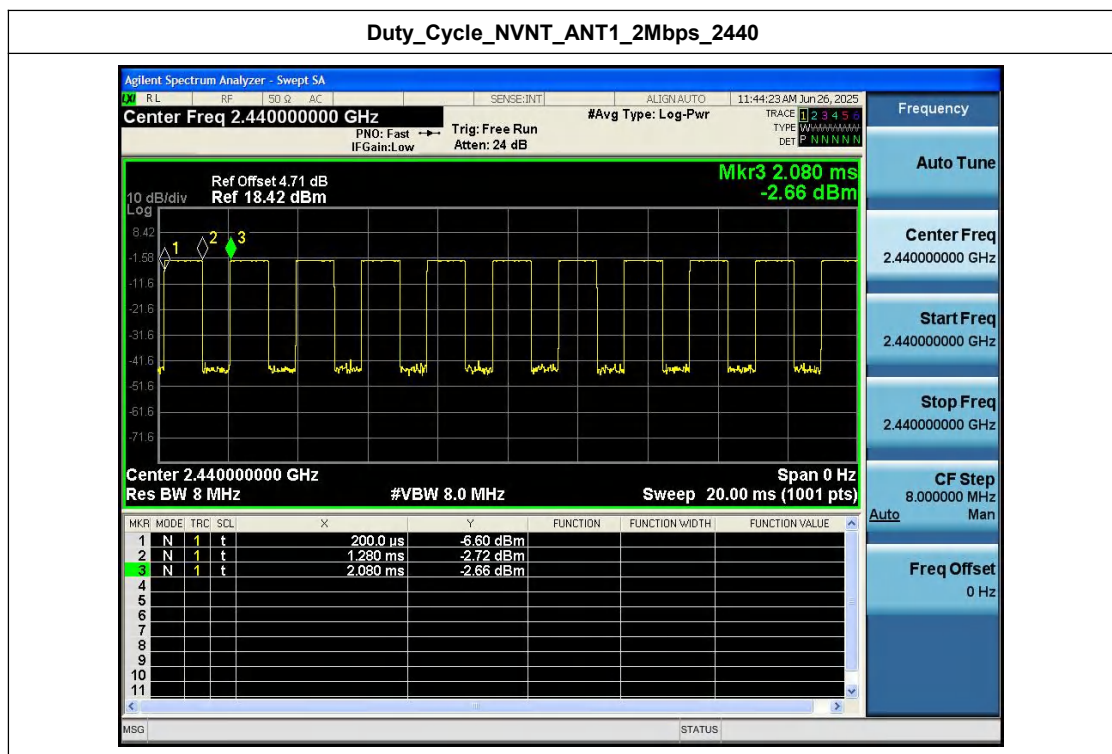
Duty Cycle_NVNT_ANT1_1Mbps_2480



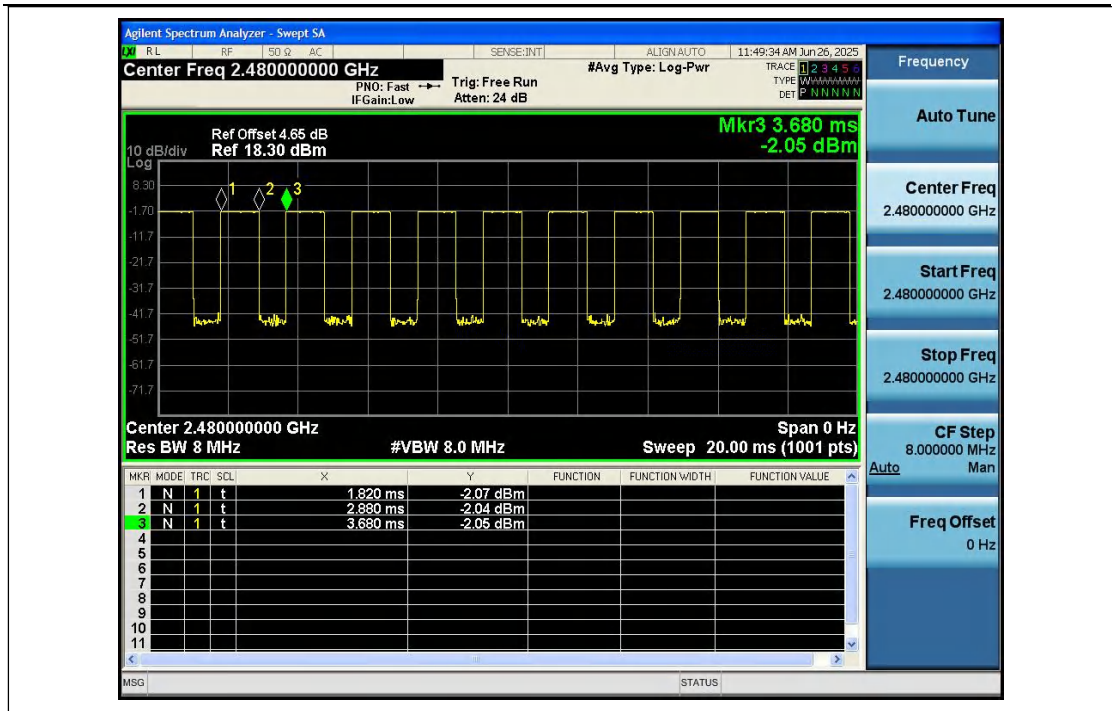
Duty Cycle_NVNT_ANT1_2Mbps_2402

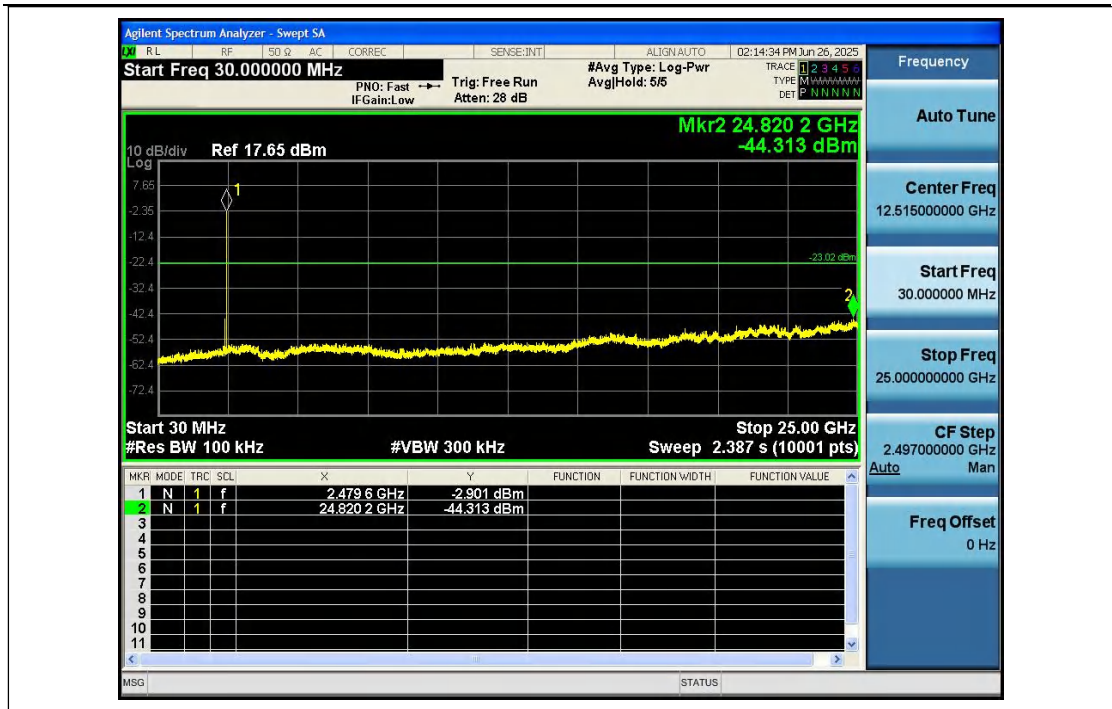
2_Spurious_Emission_NVNT_ANT1_1Mbps_2440



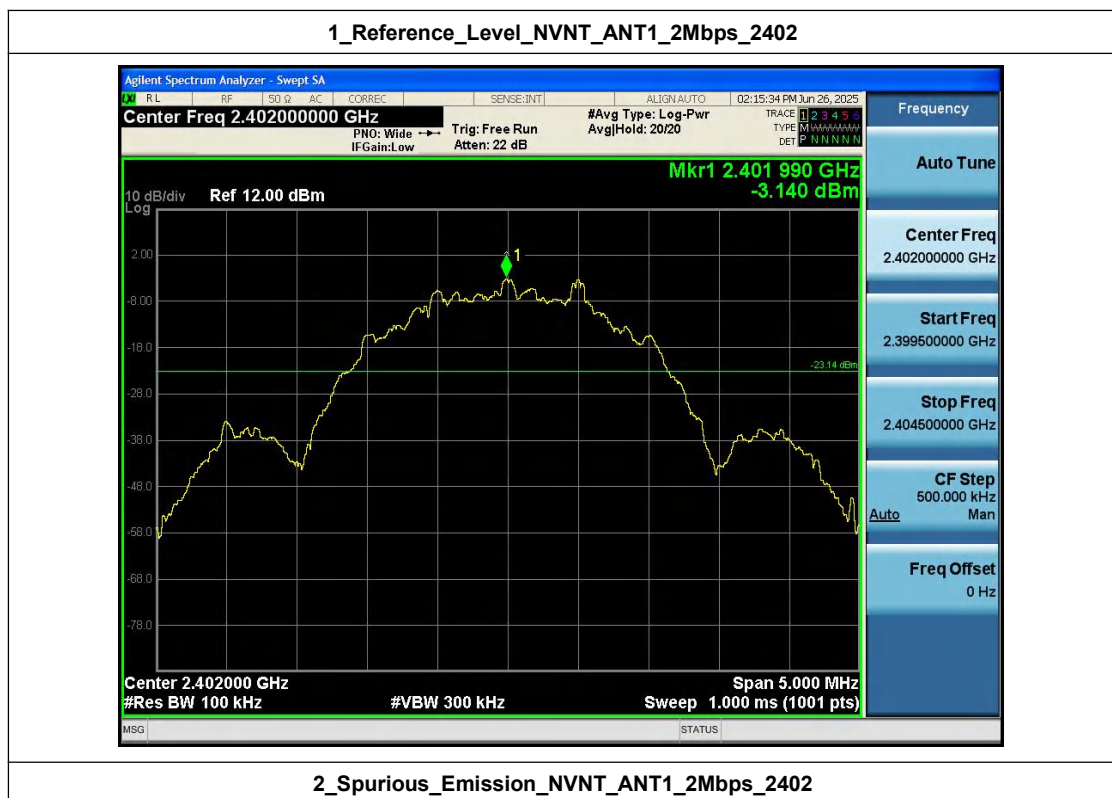
