-Charge the VIV Smart Ring fully before first use.

-Pair the ring with your smartphone via Bluetooth.

-Adjust device settings and measurement intervals through the app.

7. Usage

Manual Measurement: Initiate real-time heart rate and SpO2 measurement and more via the app.

Automatic Measurement: The ring supports 24-hour continuous monitoring with adjustable measurement intervals.

Data Access: View your health data and insights in the VIV Ring App.

8. Troubleshooting

-**Device Not Pairing:** Ensure Bluetooth is enabled and the ring is charged.

-**No Automatic Measurements:** Confirm that measurement intervals are correctly set in the app.

-**Low Battery:** Recharge the ring using the supplied charging dock.


9. Maintenance and Care
