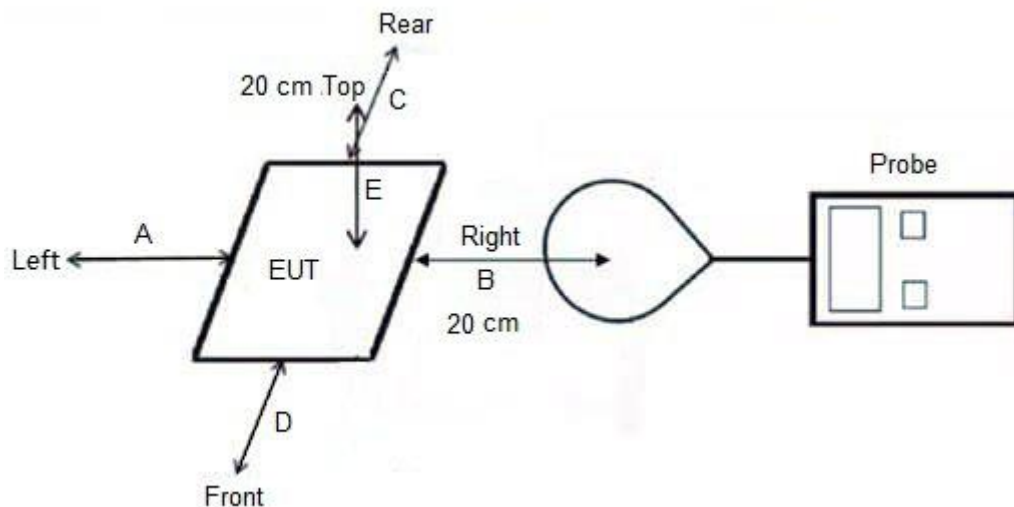

3.4 Measurement Procedure

- The RF exposure test was performed on 360 degree turn table in anechoic chamber.
- The measurement probe was placed at test distance (20 cm from all sides) which is between the edge of the charger and the geometric centre of probe.
- The turn table was rotated 360 degree to search of highest strength.
- The highest emission level was recorded and compared with limit as soon as measurement of each points (A, B, C, D, E) were completed.
- The EUT were measured according to the dictates of KDB 680106 D01 RF Exposure Wireless Charging App v04.

MPE-based total exposure ratio (Worst case):

E-field:

$$\text{Coil 1} + \text{Coil 2} + \text{Coil 3} = 0.0016 + 0.0014 + 0.0014 = 0.0044 < 1$$

H-field:

$$\text{Coil 1} + \text{Coil 2} + \text{Coil 3} = 0.0992 + 0.0881 + 0.0871 = 0.2743 < 1$$

3.7 Conclusion
