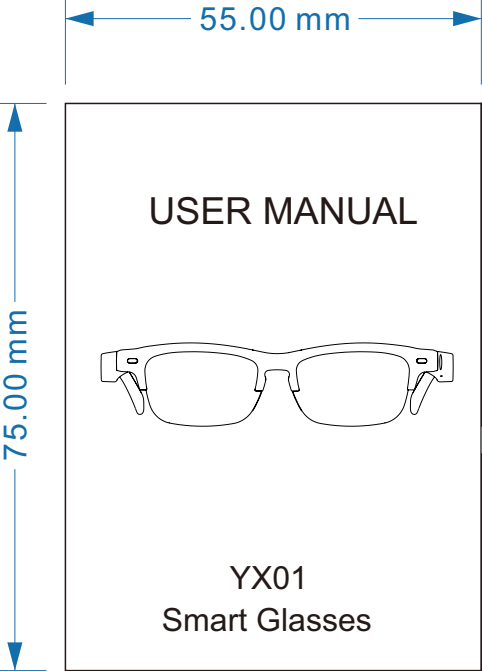

Charging

1. Charging glasses:
Charge glasses with magnetic charging cable
During charging, the red LED is always on
The red light goes off after charging is completed

2. Power reminder:
When the power is lower than 10%, the red light flashes
Please recharge your glasses in time.

Power-on pairing

1. Press and hold the multi-function button for about 2 seconds to turn on the glasses.The red and blue lights flash alternately when turning on.
2. After turning on, it automatically enters pairing mode, turn on the Bluetooth of the mobile phone, search for the Bluetooth device YX01, and click to connect.After the connection is successful, the blue light flashes once every 5 seconds.

Shut down

1. Manual shutdown: Press and hold the multi-function key 5 seconds and turn off the glasses. The red light flashes 3 times when shutting down.
2. Automatic shutdown: If the glasses are turned on without bluetooth pairing, they will automatically shut down after 5 minutes; if the bluetooth connection is disconnected for 5 minutes, the glasses will automatically shut down.

Automatic connect back

When you use it again, the glasses will automatically connect to the device after turning on.
