### How to use

### Press the button briefly

Once you press the button, the LED mode changes in the order of ON - FLICKER - DIMMING - REVERSE - ROTATION - OFF.

### Press and hold the button

If you press and hold the button for 3 seconds, it will blink in blue, and the Bluetooth pairing mode will be activated. After connecting the device through Bluetooth, you can enjoy diverse experiences using the application.


### Central control

When central control is activated in the concert hall, the lighting of the light stick is will be automatically controlled without any additional button operation.

When central control is activated, users are unable to individually control the lighting of the light stick.

### Inserting and replacing the battery

As shown in the figure below, rotate the bottom part of the handle to separate. Insert 3 AAA batteries in the direction written on the socket. (The part with the spring in the socket is the  $(\cdot)$  pole.)
