
Maintenances

- Do not use unauthorized equipment and accessories, as the use of such items falls outside the scope of the company's warranty.





Micro SD Card Installation




1. Place the microSD card with the metal contacts facing up and the tablet screen facing down. Then align the card slot and gently press the microSD card into the slot from left to right to secure it.
2. Use your fingernail to press slightly firmly along the edge of the microSD card, and the card will pop out.
3. After the microSD card is ejected, it can be pulled out along its edge.

Connection with PC

USB Connect

Use USB cable to connect device to PC, device will pop up the USB connection window, click Turn on USB storage to connect to PC.




In load mode, you can copy or delete files on the device and on the memory card.

OTG Use


- Supports FAT32 format for mobile memory devices, such as USB disks.

- Use an OTG cable to connect the MID USB OTG PORT to other devices.



Troubleshooting

Q1. The tablet doesn't power on.

- ▲ Reboot your tablet after charging for 30 minutes;
- ▲ Press the power button to check if the tablet is in the Sleep Mode;
- ▲ Press and hold the power button for 7-8s to turn off the tablet, then reboot it;
- ▲ Press the Reset button with a pin to reboot the tablet.

Q2. The tablet doesn't charge.

- ▲ Make sure the USB cable is properly plugged into the charging port;
- ▲ Try another compatible USB cable and adapter.

Q3. Error message occurs during the operation.

- ▲ Uninstall the App with the error message, then download and install again;
- ▲ Press the Reset button with a pin to reboot the tablet,

Q4. The tablet cannot be detected by the computer.

- ▲ Make sure the tablet is powered on;
- ▲ Try another USB cable;
- ▲ Try another USB port on the computer;

Troubleshooting

▲ Instead of Charge this device, choose Transfer files or Transfer photos (PTP) when connecting the tablet to the computer.

Q5. The tablet cannot connect to the Wi-Fi.

▲ Make sure the Wi-Fi in your tablet is ON;

▲ Make sure you input the correct password when connecting the Wi-Fi;

▲ Restart the router

▲ Make sure there is no filter setting or device connection limitation in the setting of the router

▲ Forget the current Wi-Fi, reset the router and connect the Wi-Fi again.

Q6. The storage space of the tablet is not enough.

▲ Delete the Apps you don't use;

▲ Clear the cache of the Apps regularly;"Install an Micro SD card to expand the storage.
