

### **5.1. Evaluation Results (Evaluation)**

#### **5.1.1. Antenna Requirement**

Test Requirement:

Refer to 47 CFR Part 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

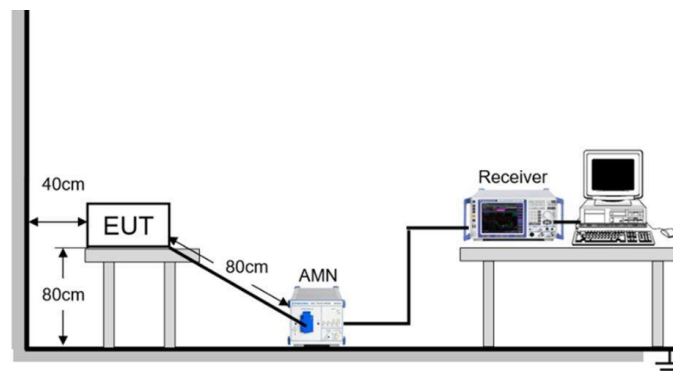

Procedure:	<ol style="list-style-type: none"> <li>1. The EUT was setup according to ANSI C63.10 requirements.</li> <li>2. The EUT was placed on a platform of nominal size, 1 m by 1.5 m, raised 80 cm above the conducting ground plane. The vertical conducting plane was located 40 cm to the rear of the EUT. All other surfaces of EUT were at least 80 cm from any other grounded conducting surface.</li> <li>3. The EUT and simulators are connected to the main power through a line impedances stabilization network (LISN). The LISN provides a 50 ohm /50uH coupling impedance for the measuring equipment.</li> <li>4. The peripheral devices are also connected to the main power through a LISN. (Refer to the block diagram of the test setup and photographs)</li> <li>5. Each current-carrying conductor of the EUT power cord, except the ground (safety) conductor, was individually connected through a LISN to the input power source.</li> <li>6. The excess length of the power cord between the EUT and the LISN receptacle were folded back and forth at the center of the lead to form a bundle not exceeding 40 cm in length.</li> <li>7. Conducted emissions were investigated over the frequency range from 0.15MHz to 30MHz using a receiver bandwidth of 9 kHz.</li> <li>8. 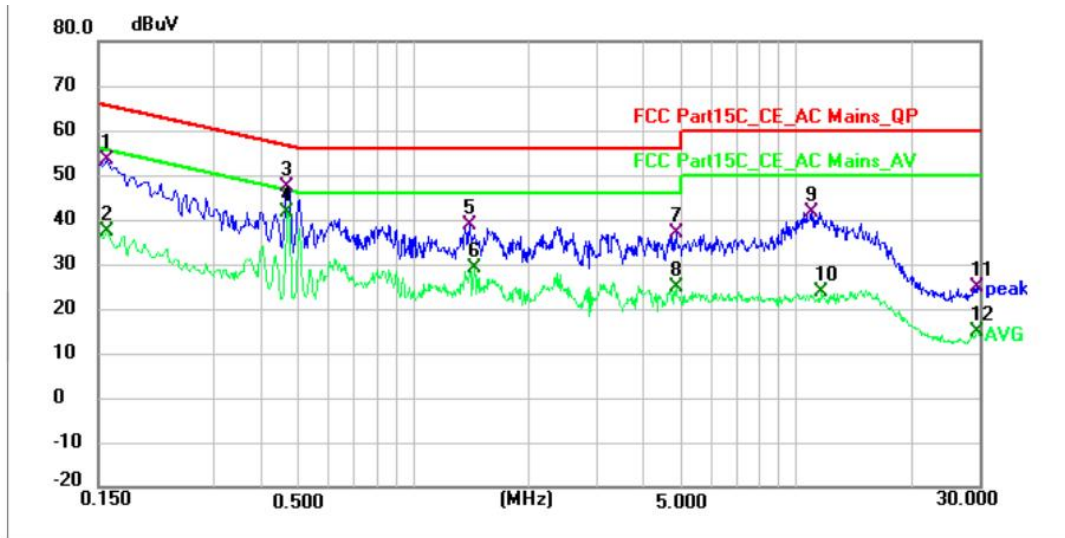

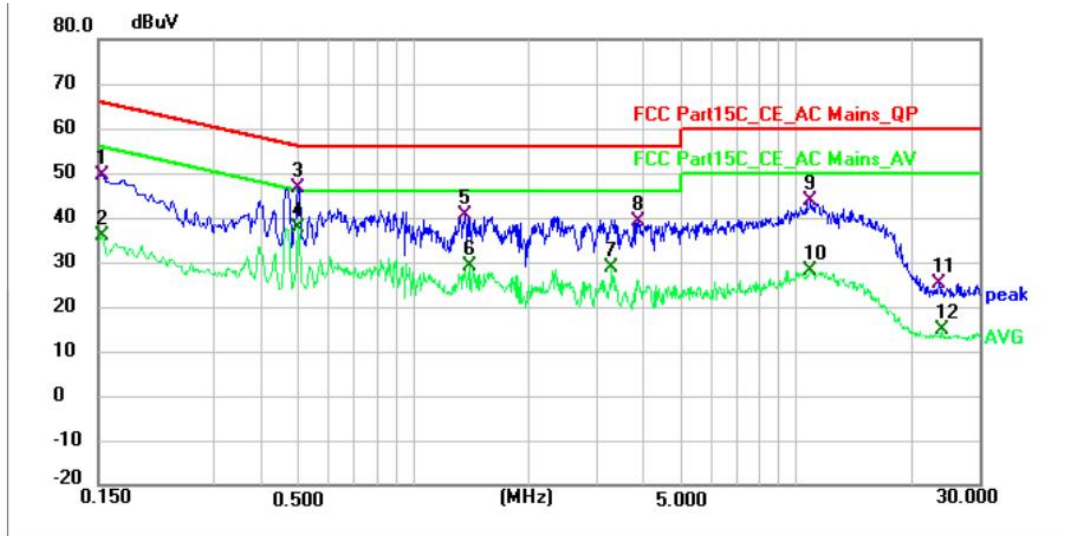

Test Limit:	Refer to 47 CFR 15.247(d), In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. 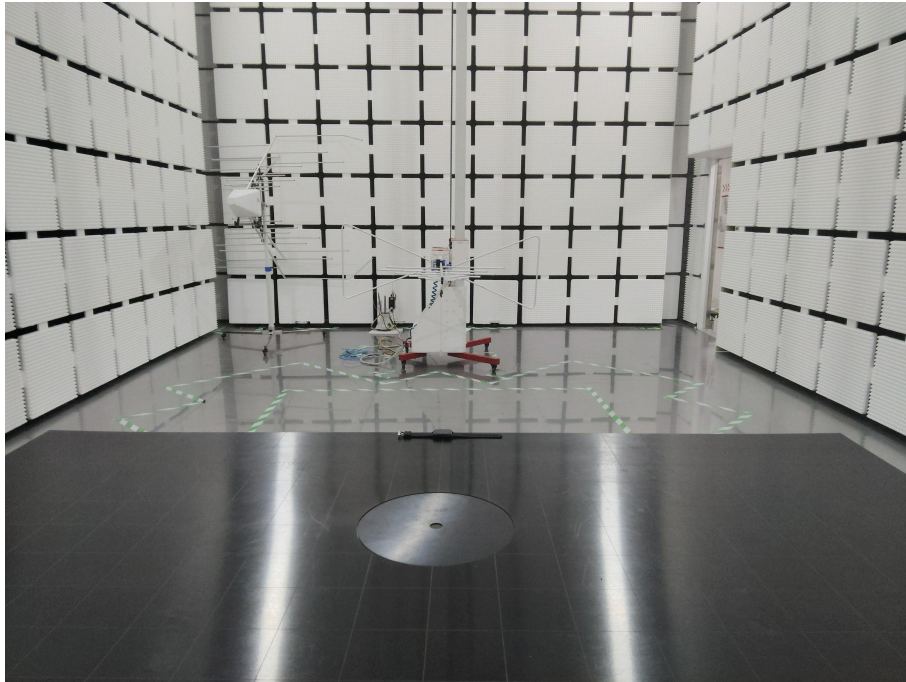
