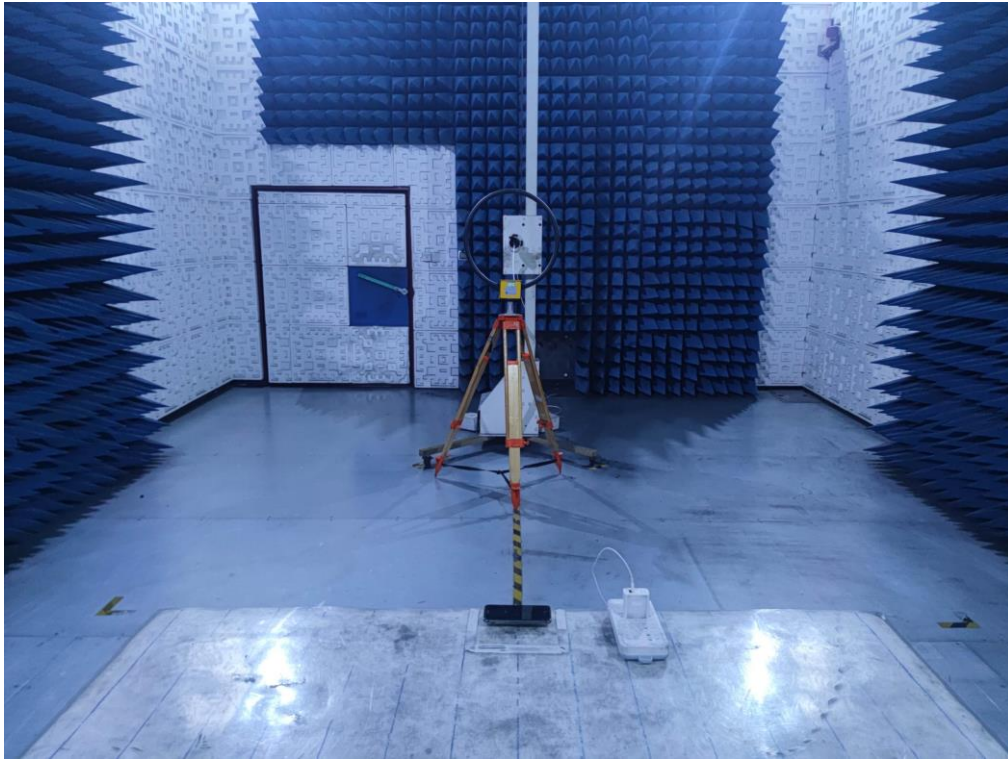
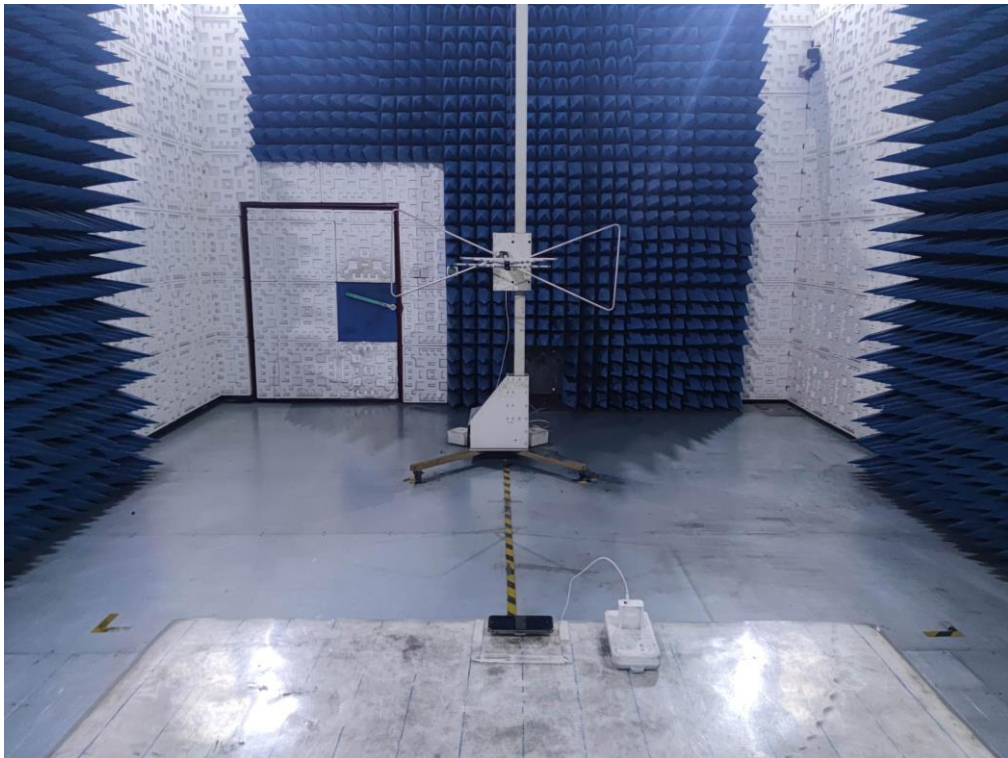

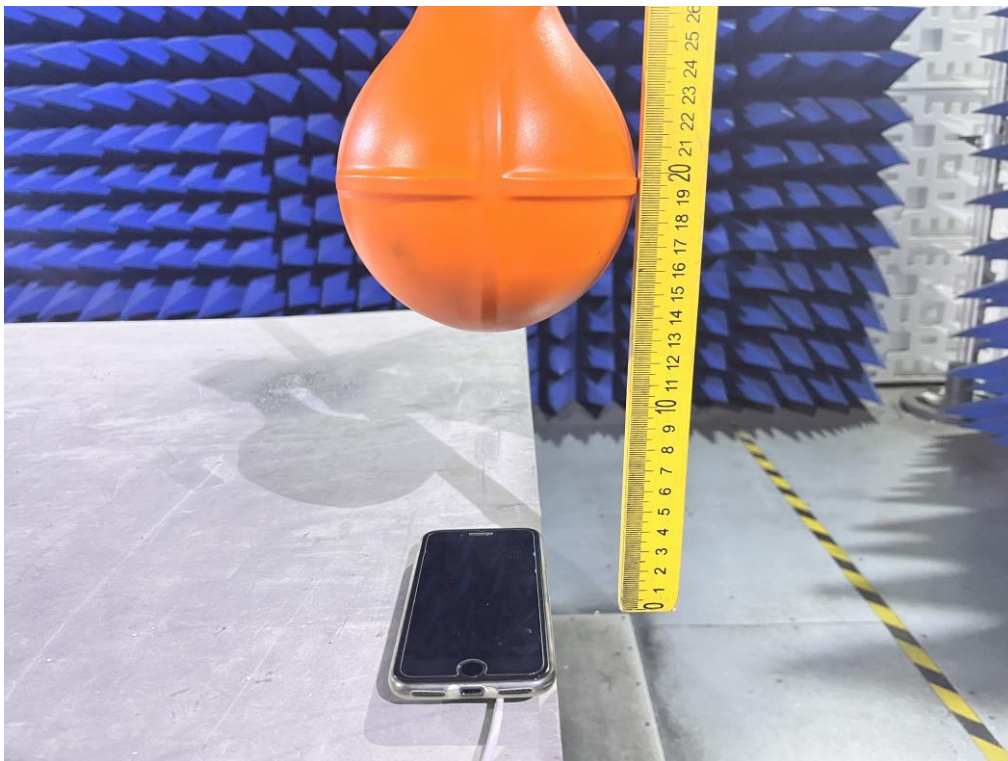

AC POWER LINE CONDUCTED TEST SETUP

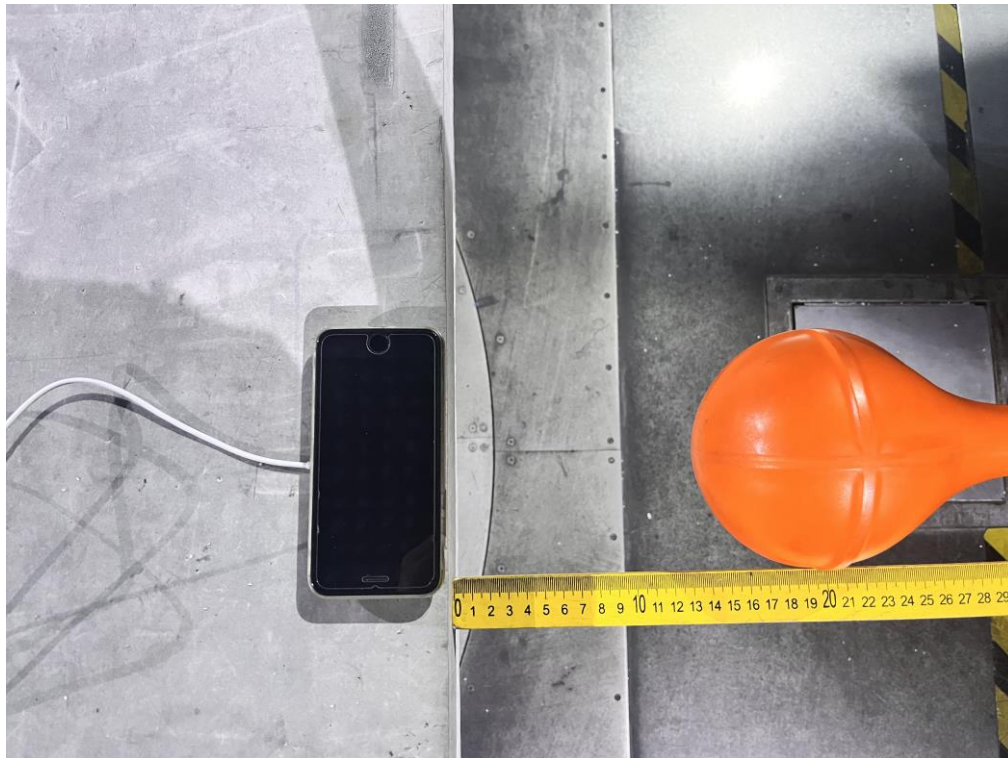
