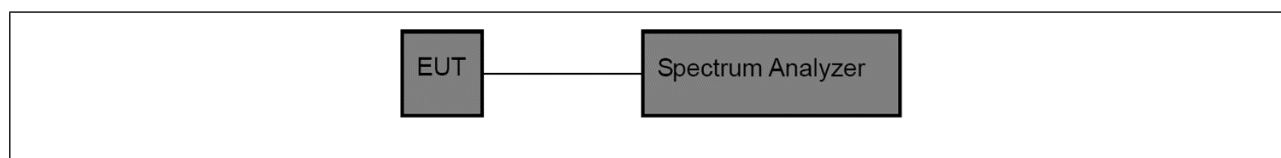
## 4. 6dB Bandwidth

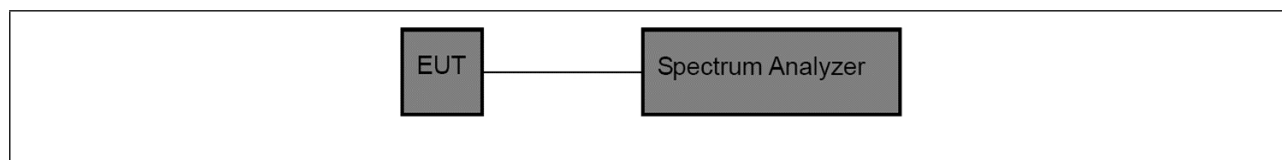
## 5. Maximum Conducted Output Power

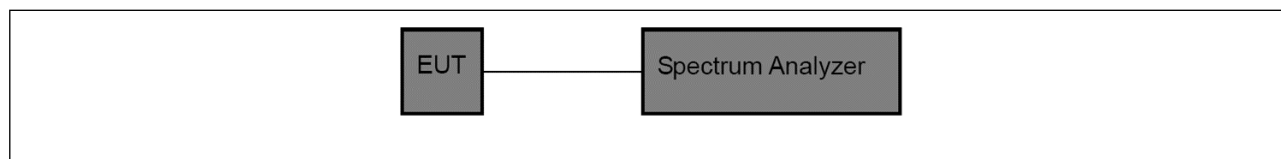
## 6. Power Spectral Density

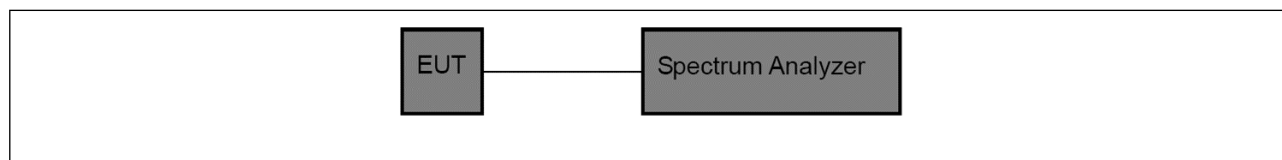
## 7. Emissions in non-restricted frequency bands
