



4. Personnel who take the installation, operation, and maintenance, must be familiar with the lighting performance. Most of the damage is resulted from unfamiliar with its performance.
5. Please do not face up to the luminous unit for a long time, so as not to cause discomfort to your eyes.
6. Please often wipe the unit with a clean cloth.
