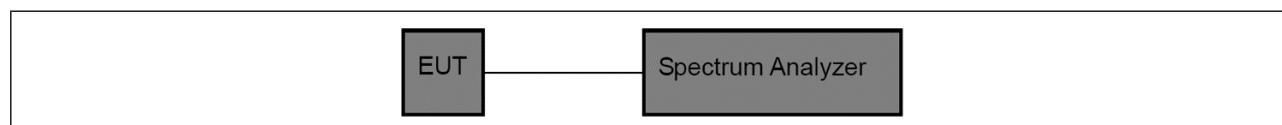
4. 6dB Bandwidth

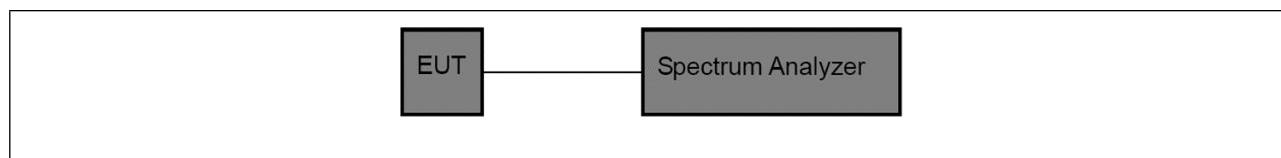
5. Maximum Conducted Output Power
