

Smart watch manual

Product introduction

APP download and connection:

1. Scan the QR code to download and install the "HryFine" APP(browser,can be scanned).



2. APP connection method:

- ① . After turning on the watch, open Settings--General--About this device and check the wireless address.
- ② . Turn on the wireless switch on your phone, enter the APP and click Add Device. After scanning the corresponding device, click Connect directly.

3. Audio connection mode:

Open Settings-General-Wireless (turn on the switch), enter the mobile phone wireless connection, search for the wireless name corresponding to the bracelet to bind (the wireless icon will be colored after successful connection).

Note: When the watch is connected to the APP, the watch data will be synchronized with the mobile phone via wireless, such as: information, weather, address book, step counting, etc. Once disconnected or unbound, the data will not be synchronized.

Watch OperatingInstructions:

Functionintroduction:

Dialing: After connecting to the mobile phone wirelessly, you can make calls on the watch;

Contact: After the watch is successfully connected to the APP, you can add contacts in the APP, after the contacts are successfully added,the watch phone book will be displayed synchronously,and the watch can make a call by clicking on the contact in the phone book;

Call log: The call record can be displayed on the watch, and the phone number can be dialed by clicking on it;

Message: Display mobile phone information push content, support SMS, commonly used social APP and other information content push;

Exercise:Select the multi-sport mode, start a random exercise,and record the calories burned, heart rate and steps during the exercise, After the end, you can view the exercise record;

Pedometer: Count the pedometer data of the day, and return to 0 at 00:00 in the morning;

Sedentary reminder: Set sedentary reminder through the mobile app;

Remote photography: open the camera in the APP, and take photos with the watch operation;

Music control:You can control the music in the mobile phone,"+", "-" to adjust the volume;

Settings: notification setting, raise your hand to open the screen, vibration, button setting, backlight display,time setting, sound and tactile feedback.APP view, language setting,answering, Do Not Disturb mode,screen off clock,power off, restart,restore factory settings.About this machine;

Find the mobile phone: the mobile phone is not silent, the operating device, the mobile phone will ring;

Weather: Connect to the APP to display the current weather temperature;

Drink water reminder: the device and APP set the water drink reminder,the device vibrates the reminder;

Stopwatch:Support stopwatch timing and segmentation;

Calculator: easy to calculate;

Calendar: You can view the calendar on the device;

Alarm: You can customize the alarm clock, and press and hold to delete the alarm;

Style:Switch between multiple UI styles

Screen-off clock: When turned on, the time hand will be displayed when the screen is off;

Breathe:Breathe in slowly as the animation unfolds and exhale as the animation closes

Disassembly:

Take off the watch, pinch one end of the strap and push it out along the wristband card slot of the main unit, so that the strap and the main unit can be successfully removed.

***Notes:**

- * in daily use, you should avoid wearing the watch for hot showers,saunas and diving,and when the water meter is wet, please wipe the surface water stains with a soft cloth before operating.
