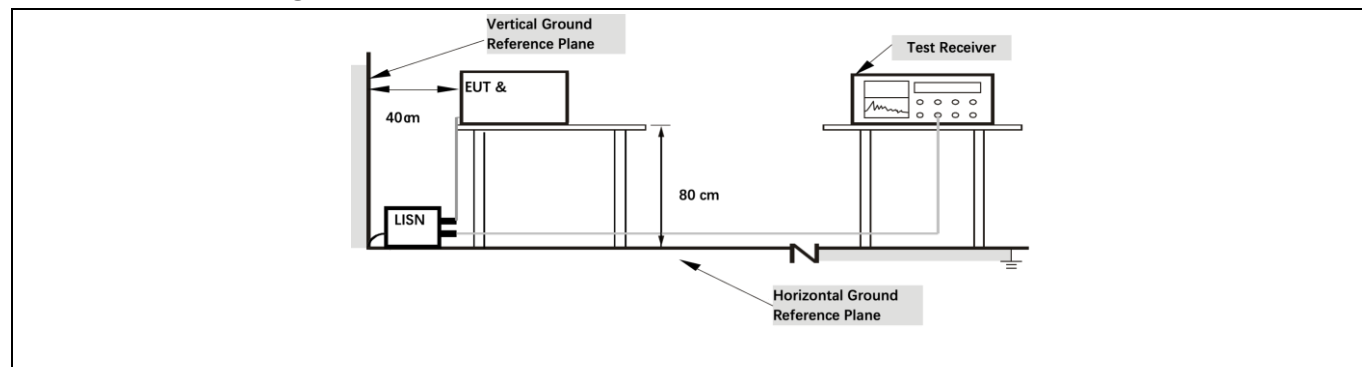

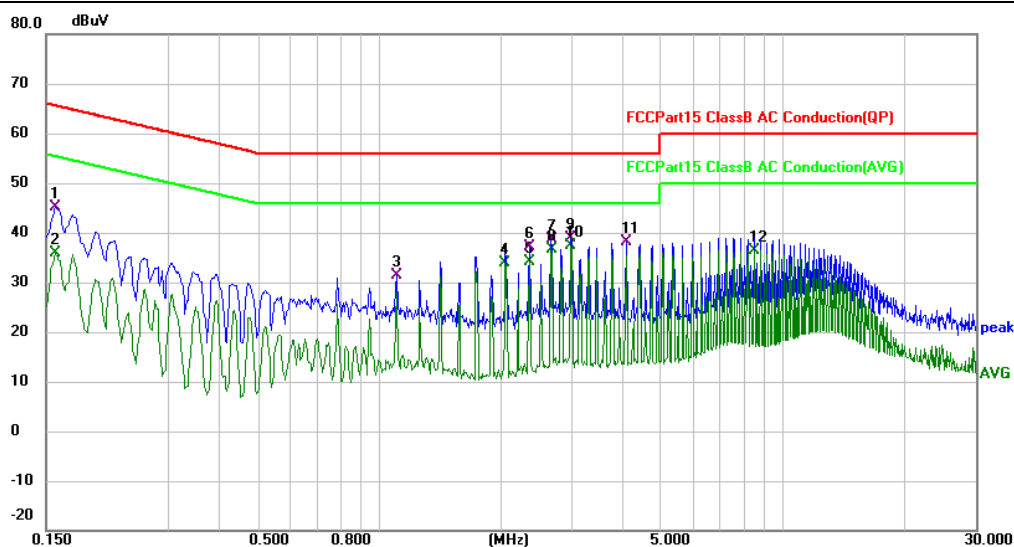

#### 6.1.2 Test Setup Diagram:



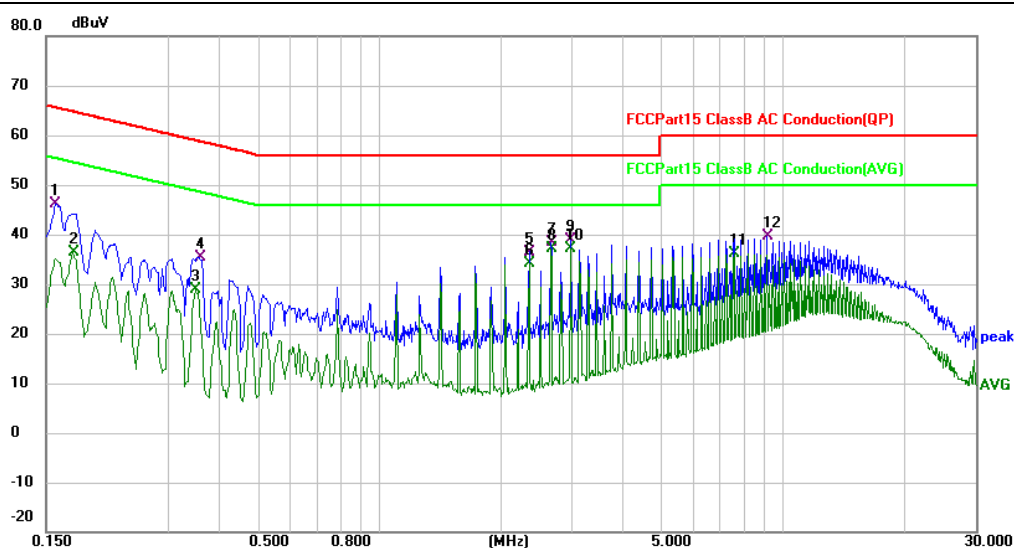

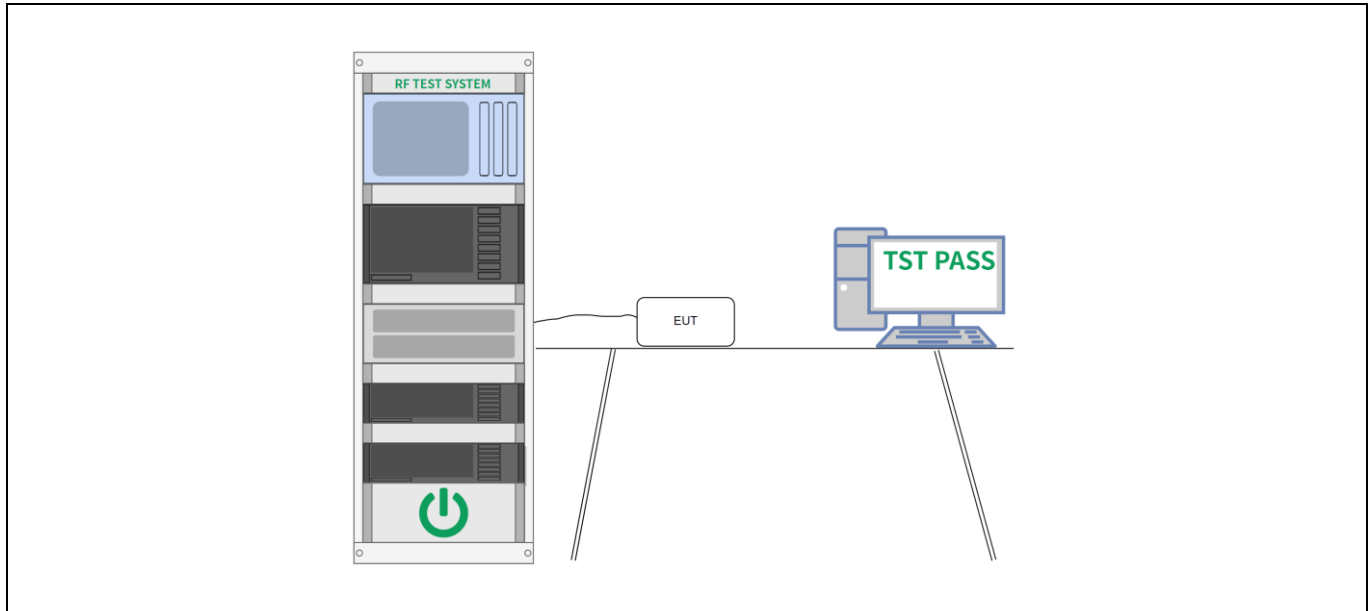
## 6.2 20dB Occupied Bandwidth

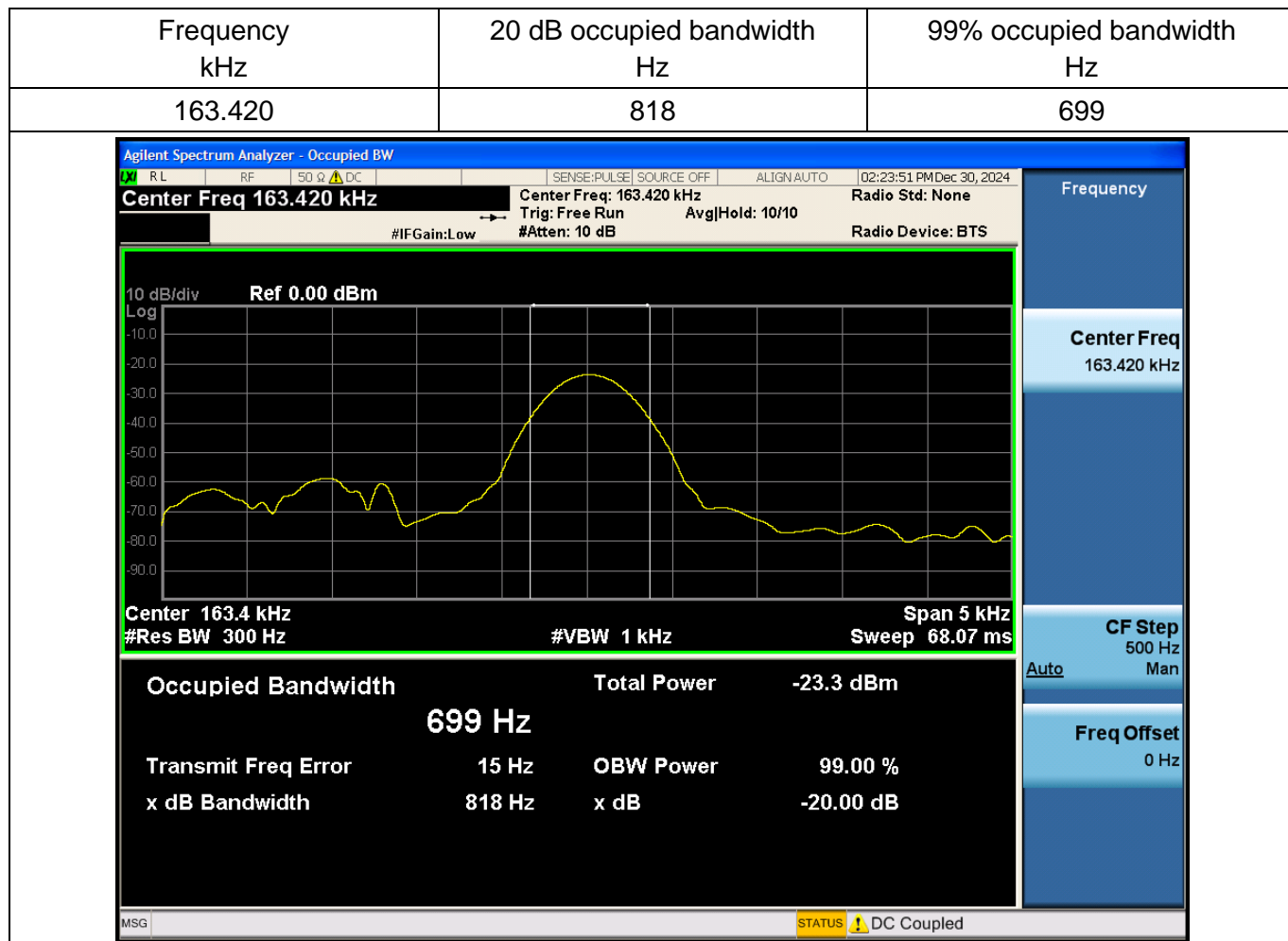

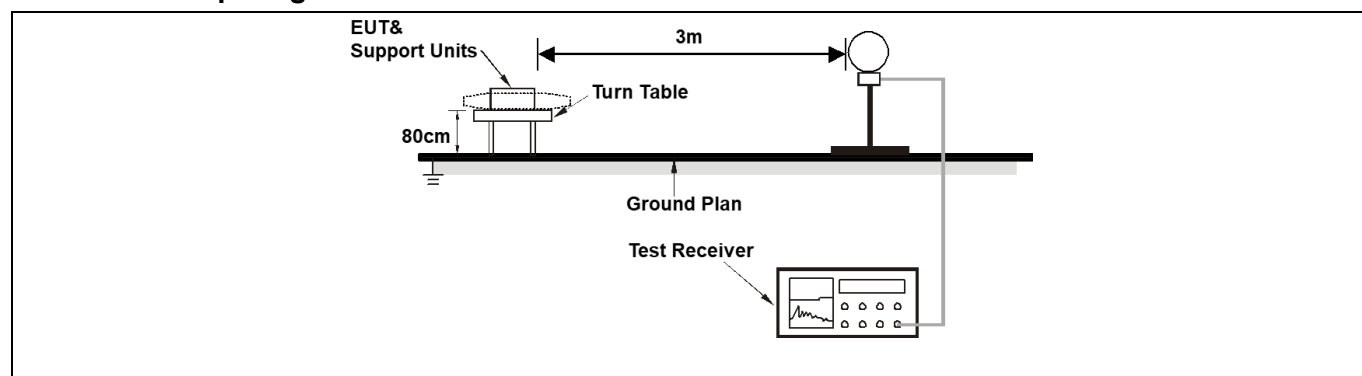

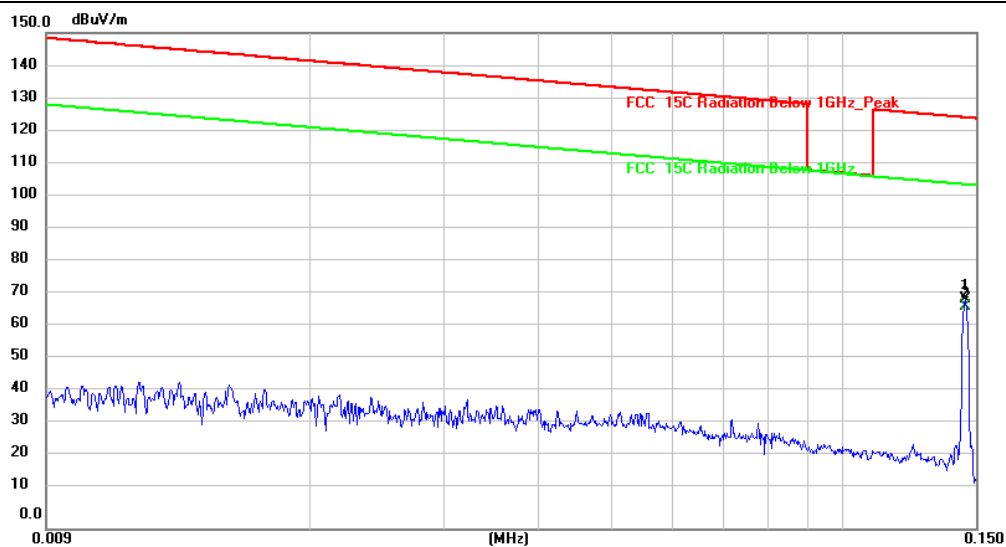

#### 6.3.2 Test Setup Diagram:



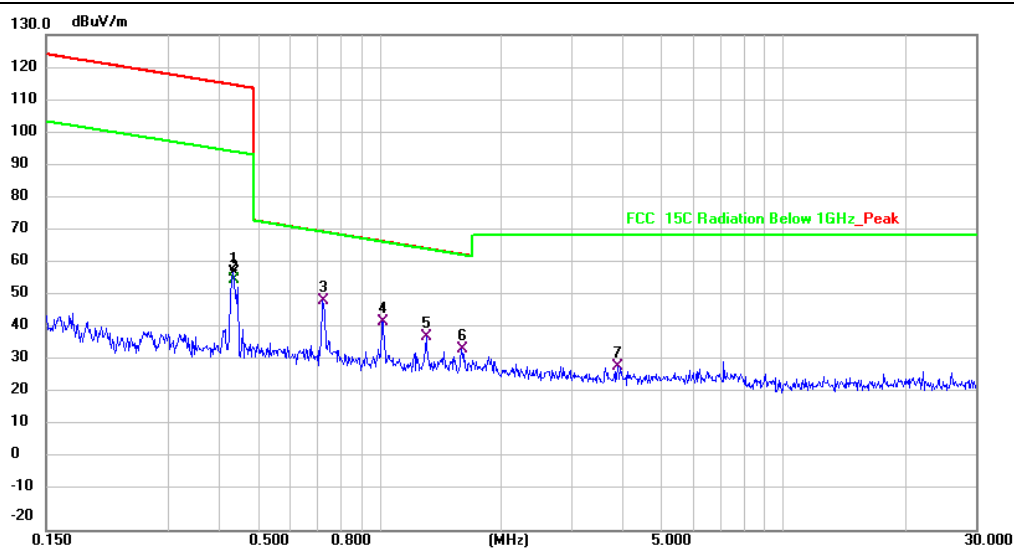

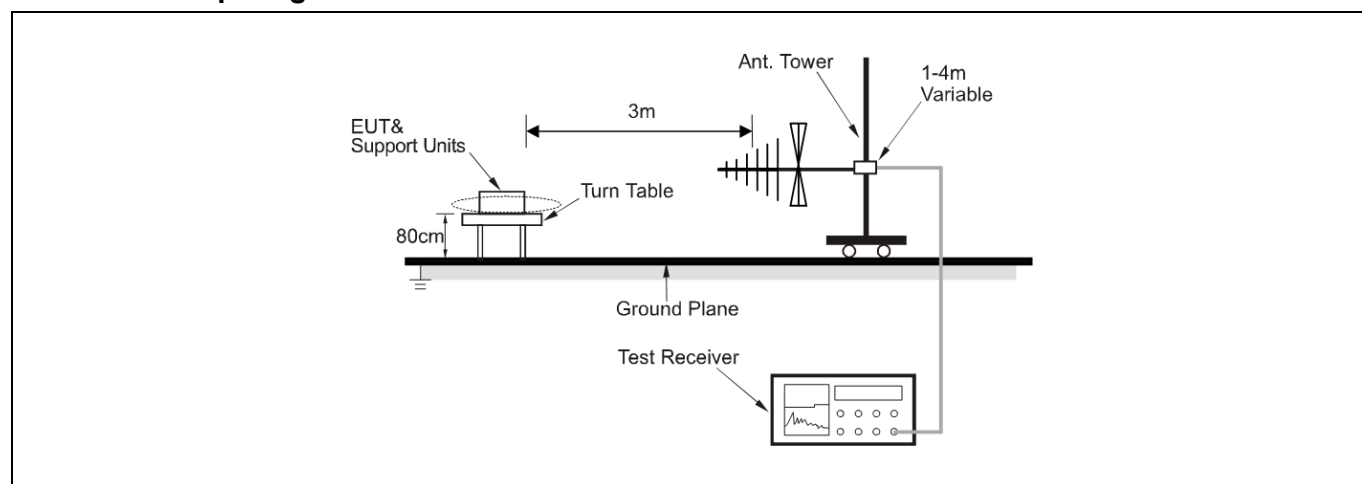

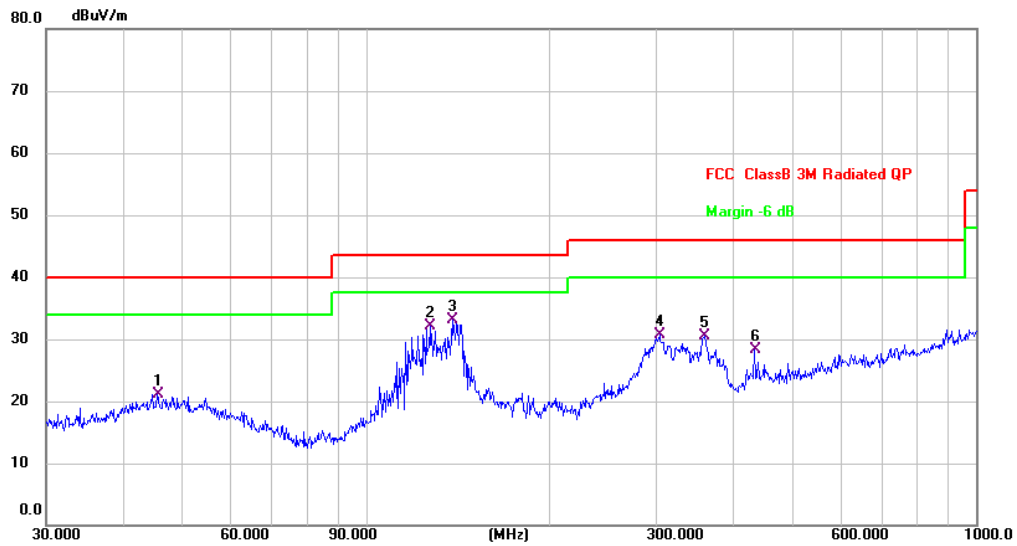

### 6.4.2 Test Setup Diagram:



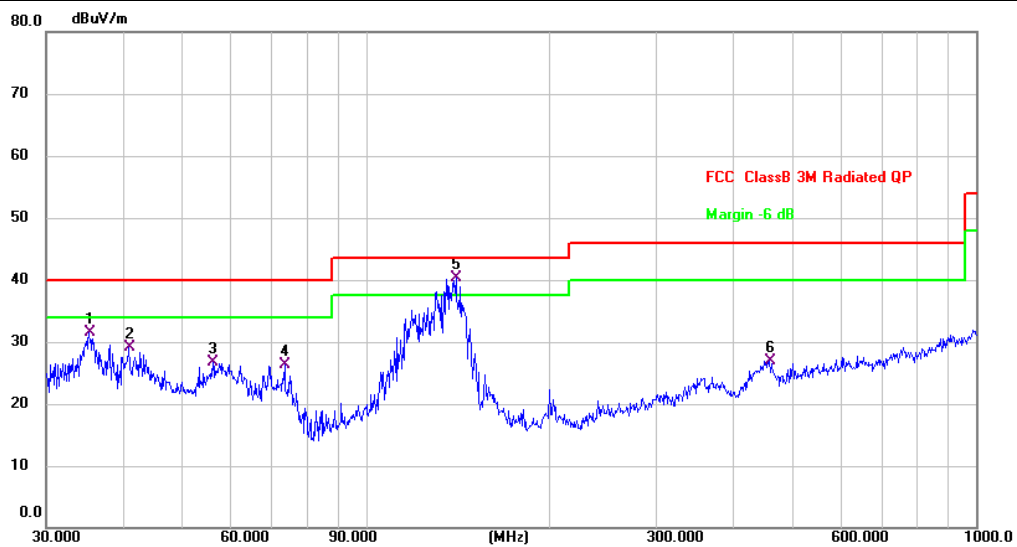
