Power/Charging

For better enjoyment, fully charge the speaker before use.

A USB-C charging cable (charge only) is included for standard USB compatible device.

Please use a 5V/1A or above power adapter (not included).

Caution: - Other incompatible charges may cause damages.

- Do not use if the connector or device is wet or damaged.

Power On/Off

To turn on the speaker, press and hold the Power On/Off button for 2 seconds, you will hear a power on tone.

To turn off the speaker, press and hold the Power On/Off button for 2 seconds, you will hear a power off tone.

Caution: If no bluetooth device is connected, the speaker will turn off in 15 minutes.

Music Control

Short press "⏮" music can be played or paused.

Long press "⏮" to go to the previous song.

Long press "⏭" to go to the next song.

Call Mode

Answer a call: Short press the "📞" button.

Reject a call: Double click the "📞" button.

End the call: Short press the "📞" button.

Bluetooth Connection

• When first used and turned on, the speaker will automatically enter a waiting mode for connection.

• If the Bluetooth device is already connected, press and hold the"⏭" and"⏮" button to disconnect the current connection so that you can connect to another device.

• The speaker will automatically enter pairing mode if it is not connected to a Bluetooth device.

When connecting, enable the Bluetooth function of the mobile phone, search for "Fvyao FS01" and connect. After the connection is successful, you will hear a prompt, the white light of stays on.

Connect Two Speakers, Stereo Mode

(Same Model Only)

1. Turn on two FS01 speakers and do not connect to a Bluetooth device (such as a mobile phone).

2. Double click the "📞" button on one of the speakers twice, and you will hear a voice prompt. The two speakers will automatically pair, After the connection is successful, the white indicator light of the main speaker will flash, and the white indicator light of the secondary speaker will remain on,

3. Enable the Bluetooth function of the mobile phone, search for "Fvyao FS01" and connect. After the connection is successful, you will hear a voice prompt, the white indicator light of the main speaker will become stays on, and the white indicator light of the secondary speaker will remain on,

4. To exit TWS pairing mode, double click the "📞" button again, and the white light will flash.

SOS

In the power on state,press and hold for 2S to enable/disable the SOS function.

Reset Paired Device List

Press and hold the "+" and "-" button simultaneously to enter pairing mode and clear all paired devices.

Power Saving Settings

In Bluetooth mode, when no device is connected, the speaker will be switched off automatically in 15 minutes.

Reset Device

If the speaker needs to be reset, press the "📞" button 5 times.

Caution

•It is not recommended to replace the battery privately.

•The battery (battery pack or battery pack combination) must not be exposed to sunshine, fire or similar overheated environments.
