



Before using the "Fvyao F01", please connect the USB-C cable to a power adapter to begin charging. Fully charge the earphones and the charging case before the first use.

#### Power On/Off


Open the cover of the charging case, the earphones will turn on automatically. If you want to turn off the earphones, please put the earphones into the charging case and close the cover, the earphones will power off and charge at the same time.

#### Pairing


Open the cover of the charging case, the earphones will turn on automatically.

#### Additional Operation

Answer call	Press L or R once
End call	Press L or R twice
Reject call	Long Press MFB on the left or right earphone for 2 seconds
Ambient sound	Long press the MFB on the right earphone for 2 seconds to turn on transparency mode/noise reduction mode/off mode
LED indicator (earphone)	Power on: White flashes
LED indicator (charging case)	Charging: The orange light keeps on. and when fully charged, the white light lights up
