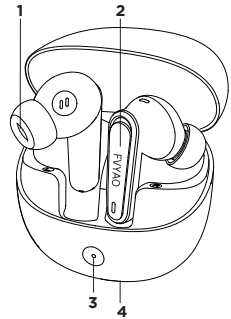

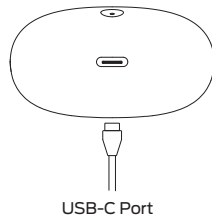

## Charging

Before using the "Fvyao F01", please connect the USB-C cable to a power adapter to begin charging. Fully charge the earphones and the charging case before the first use.



## Power On/Off

Open the cover of the charging case ,the earphones will turn on automatically. If you want to turn off the earphones, please put the earphones into the charging case and close the cover,the earphones will power off and charge at the same time.

## Pairing

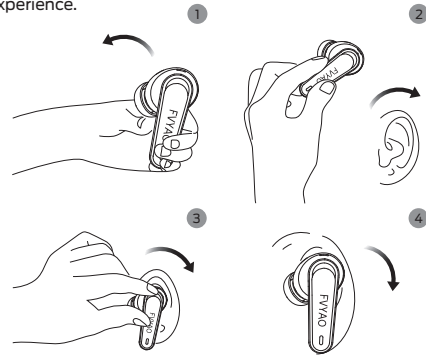
Open the cover of the charging case ,the earphones will turn on automatically.

For new device connection, turn on the Bluetooth in your device and choose "Fvyao F01" from the Bluetooth list to connect. You will hear system prompts after the earphones are connected to the device.

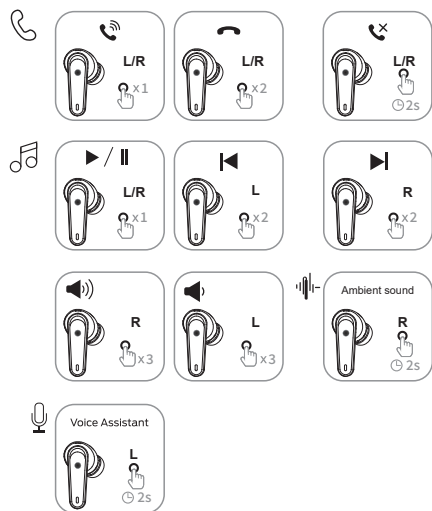
If the earphones have been connected before, they will connect to the last connected device automatically after being turned on.
