Charging

Before using the "Fvyao F02", please connect the USB-C cable to a power adapter to begin charging. Fully charge the earphones and the charging case before the first use.

Power On/Off

Open the cover of the charging case, the earphones will turn on automatically. If you want to turn off the earphones, please put the earphones into the charging case and close the cover, the earphones will power off and charge at the same time.

Pairing

Open the cover of the charging case, the earphones will turn on automatically.

Wearing

Put the "Fvyao F02" onto your ears and rotate to fit comfortably to get the best wearing and sound quality experience.

MFB Operation

Additional Operation

Answer call	Press L or R twice
End call	Press L or R twice
Reject call	Long press left or right ear
LED indicator (charging case)	
When the charging case is charging.	The units digit on the digital display flickers and then goes out completely.
The earbuds are placed in the charging case for charging.	The current battery level is displayed, and the battery indicator bar scrolls like a marquee.

Reset

In the power on state, touch the MFB of the earphones 5 times (two earphones at the same time), the earphones will automatically shut down and put the earphones into the charging case. When the cover is opened again, the earphone will turn on again and enter the pairing mode.
