



II. NOTED:USB CABLE CONNECTION IS REQUIRED FOR WIRELESS CHARGING

III. PRODUCT INSTRUCTIONS

1. Charge using a DC 5V 1A plug;
2. Red indicates charging, disappearance of red indicates fully charged;
3. Open your phone and pair it with a Bluetooth speaker.

Control music playback through mobile phone or remote control

4.  Long press decrease the volume; Short press, previous song
5.  Long press increase volume; Short press, next song
6.  Long press turn on/off; Short press play/pause
7.  Projection lamp mode Switching-10 mode loop
8.  Switch RGB mode, 12-mode loop



Use two #7 bateries for the Remote control
