#### Use, Care and Maintenance

Finger size can vary depending on the time of the day, and sometimes it may be difficult to remove the ring from your finger. In case the ring gets stuck:

Use cold water and gentle soap to wet your finger, and slowly twist the ring to remove it.

Hold your hand up above your heart until the blood pressure gets lower, and then try to remove it. In cases of emergency and/or discomfort, when you can't remove the ring yourself, seek immediate medical attention. Use a soft cloth or hand wash with mild soap and water to clean the ring.

Your Smart Ring can be worn during showers, baths, swimming, and snorkeling but we do not recommend wearing it while diving.

Try to avoid wearing the ring when strength training, working with a shovel or other heavy tools, or carrying heavy objects made of metal, ceramics or stone. In addition, try to avoid wearing the ring next to other rings or objects which are made of metal, ceramic, stone or diamonds. The Smart Ring may get scratched and can itself scratch softer metal jewelry or other objects in close contact with the ring like phone covers made of gold, silver, or aluminum. Some ceramic phone covers with a soft coating may also get scratched.

1. When first connected or after factory reset, the device needs to be connected to power to activate.
2. Scan the QR code with your phone to download the "ROMILIA" App, or find it on the App Store or Google Play.
3. Open the "ROMILIA" App, select "Devices"; click the "..." in the top right corner of the page, then select "Add Device". Click the "Connect" button in the "ROMILIA" tab to successfully add the device.

### Main Functions

1. Step Counting: Automatically measures daily activity steps, data saved for 7 days.
2. Sleep Detection: Automatically detects sleep, sleep detection time period can be changed on the phone. Data saved for 7 days.
3. Heart Rate: Hourly or manual measurement. Measurement interval can be set on the phone (1 hour, 2 hours, 3 hours, or 4 hours).
4. Blood Oxygen: Manual measurement. Follow the instructions on the page to start measurement, view measurement results on the phone.
5. Blood Pressure: Blood pressure measured every 4 hours, data saved for 7 days.
6. Menstrual Tracking: Manually track relevant information on the phone, and the physiological cycle prediction is generated automatically.
