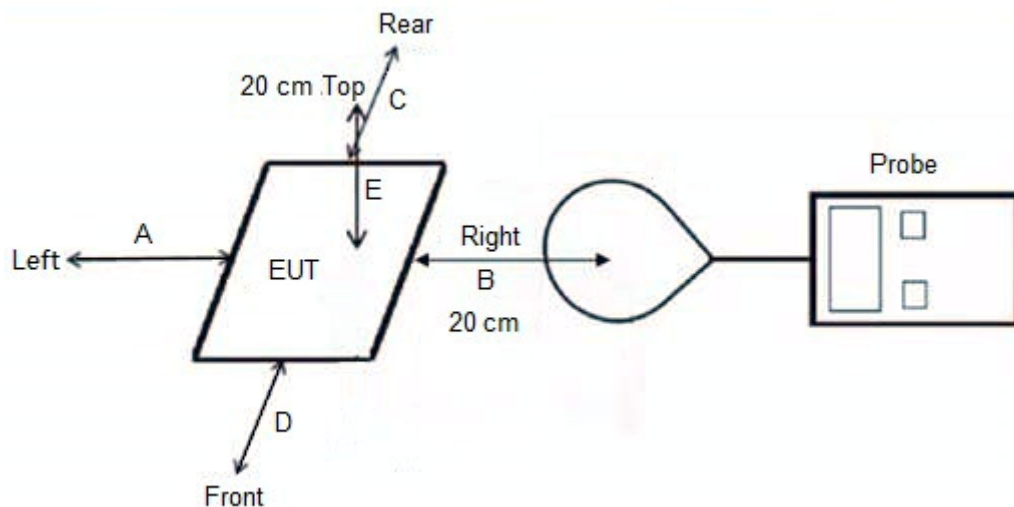

### 3.4 Measurement Procedure

- The RF exposure test was performed on 360 degree turn table in anechoic chamber.
- The measurement probe was placed at test distance (20 cm from all sides) which is between the edge of the charger and the geometric centre of probe.(for EHP-200A, The sensitive elements are located approximately 8 mm below the external surface, so measurement distance 20cm is between the edge of the charger and the external surface of EHP-200A rather than geometric centre of probe).
- The turn table was rotated 360d degree to search of highest strength.
- The highest emission level was recorded and compared with limit as soon as measurement of each points (A, B, C, D, E) were completed.
- The EUT were measured according to the dictates of KDB 680106 D01 RF Exposure Wireless Charging App v04.

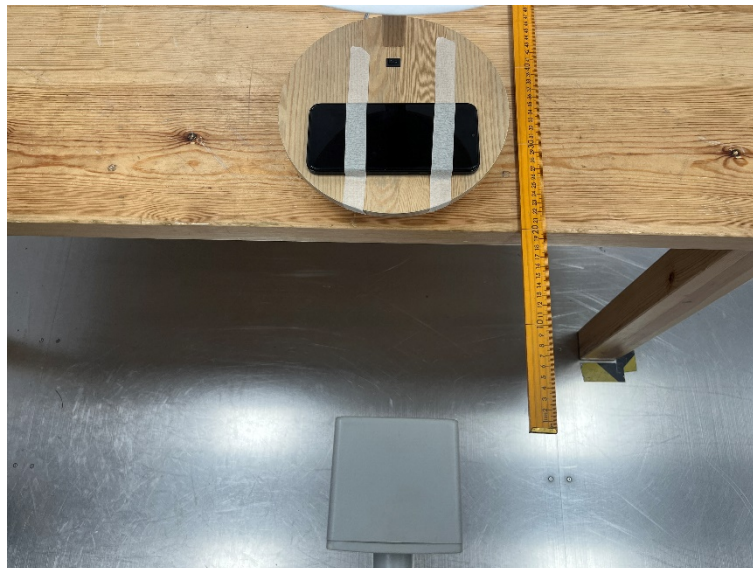

### 3.7 Conclusion

The detected emissions with a distance of 20cm surrounding the device are below the FCC E-Field Strength & H-Field Strength limits; and comply with the requirements of FCC KDB 680106 D01, the measurement results comply with the FCC Limit per 47 CFR 2.1091 for the uncontrolled RF Exposure of mobile device.

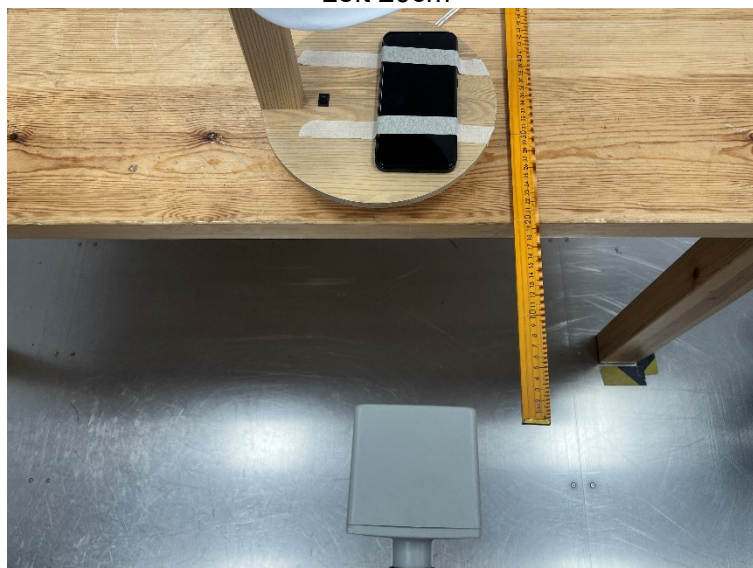

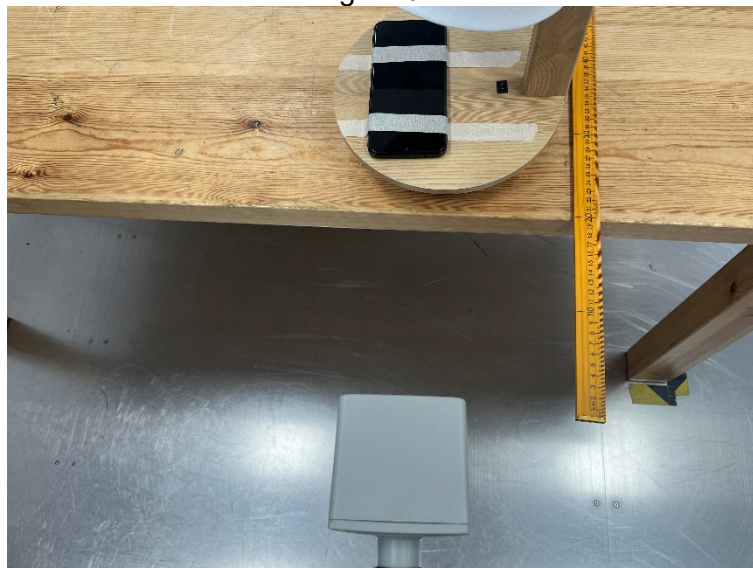
20cm Rear
