Suitable for children over 3 years old. All electronic products should be carefully used to prevent electric shock.


Maintaining:

This product contains electronic components. Don't use t in water or damp environment. Wipe the surface with cloth.


1. Set the switch on the OFF position of the car and the remote control.(if switch is available)
2. Use a cross head screwdriver to open the battery cover.
3. Install the rechargeable battery pack according to the figure below, and install the battery according to the corresponding "+" and "-" poles in the battery box.
4. Close the battery case and tighten it with cross head screws.

Operations of Remote Control and Cars:


1. Turn the switch on the car and remote control to "NO'position.(if switch is available)
- 2 Then, operate the car.
- 3 When your car starts to lose performance, power, or function, it may be the time to replace the battery or charge the battery pack.



Description to the Functions of Remote Control :









Charging the model battery :

Function demonstration of remote control Collision vehicle

Forward/Backward Operate the "Forward/Backward" button to control the vehicle to make forward and backward movement</p> 	<p>2.Turn Left / TurnRight Operate the "Turn Left/Turn Right" button to control the vehicle to turn left or turn right.</p> 	<p>3. One-click Acceleration Operate the "Shift" button to change the speed of the remote control car.</p> 
<p>4.Spray Effect Operate the "spray" button to spray the rear of the remote control car.</p> 	<p>5.Colection Ejection Hit the tail button to trigger the ejection function.</p> 	<p>6.Equipment Upgrades Add upgrades to experience the fun of soccer matches.</p>
