
\* The machine must be charged with 5V voltage, If using 9V fast charging may cause the machine to burn out \*

Move the switch up to turn on your machine.









## The machine charges

Please use the original data cable to connect the computer for charging. If you use an adapter, please use a power adapter with a charging current of 1A or less to charge the recorder; otherwise, it may damage the recorder or cause danger. When the recorder is charged, the flash red light will be on; when it is fully charged, the blue light will be on.

If the product is not used for a long time, please charge and discharge at least once every three months to prevent battery damage.
