

## Function Guide



Power On/Off: Press and hold for 3 seconds

Short Press: Play/Pause

Double Click: Mute original vocal

Triple Click: TWS pairing (connects two microphones together)

MIC: Adjust microphone volume (+/-)

ECHO: Adjust echo effect level (+/-)

MUSIC: Adjust music volume (+/-)

Charging Port: 5V / 1A

### **Caution**

Covering the microphone may cause feedback noise.

Do not exceed 10 meters of distance when using Bluetooth.

Keep the product away from children, pets, and moisture.

Dropping the product may result in malfunction or damage.

Do not expose to heat sources (e.g., heaters) to avoid explosion, degradation, or battery life reduction.

Charge only in environments between -10°C and 50°C.
