
2.2 Description of Test Conditions

(1) E.U.T. test conditions:

For intentional radiators, measurements of the variation of the input power or the radiated signal level of the fundamental frequency component of the emission, as appropriate, shall be performed with the supply voltage varied between 85% and 115% of the nominal rated supply voltage. For battery operated equipment, the equipment tests shall be performed using a new battery.

- (2) Frequency range of radiated measurements:
 The test range will be up to the tenth harmonic of the highest fundamental frequency.
- (3) Pre-test the EUT in all transmitting mode at the lowest (2402 MHz), middle (2440 MHz) and highest (2480 MHz) channel with different data packet and conducted to determine the worst-case mode, only the worst-case results are recorded in this report.






2.3 Description of Test Setup

Operation of EUT during AC conducted testing and below 1GHz radiation testing:



Operation of EUT during RF conducted testing:



The sample was placed (0.8m below 1GHz, 1.5m above 1GHz) above the ground plane of 3m chamber. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating the turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages. The worst case is X position

For conducted measurements (Output Power, 6dB Emission Bandwidth, Power Spectral Density, Spurious Emissions), the antenna of EUT is connected to the test equipment via temporary antenna connector, the antenna connector is soldered on the antenna port of EUT, and the temporary antenna connector is listed in the Test Instruments.

4 Test Result

4.1 Antenna Requirement

4.1.1 Standard Requirement

Standard Applicable

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section 15.247, if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.


Refer to statement below for compliance.

The manufacturer may design the unit so that the user can replace a broken antenna, but the use of a standard antenna jack or electrical connector is prohibited. Further, this requirement does not apply to intentional radiators that must be professionally installed.

Antenna Connected Construction

The antenna used in this product is a FPC Antenna, not easy to remove. It conforms to the standard requirements. The directional gains of antenna used for transmitting is 4.05dBi.


4.2.2 Test Procedure

- 1. The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system; a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10:2013.
- 2. Support equipment, if needed, was placed as per ANSI C63.10:2013.
- 3. All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10:2013.
- 4. The adapter received AC120V/60Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
- 5. All support equipments received AC power from a second LISN, if any.
- 6. The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7. Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.
- 8. During the above scans, the emissions were maximized by cable manipulation.





4.3 Radiated Emissions Measurement

4.3.1 Applied Procedures / Limit

For intentional device, according to § 15.209(a), the general requirement of field strength of radiated emission out of authorized band shall not exceed the following table at a 3 meters measurement distance. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply

with the radiated emission limits specified in §15.209(a).

Except when the requirements applicable to a given device state otherwise, emissions from license-exempt transmitters shall comply with the field strength limits shown in table below. Additionally, the level of any transmitter emission shall not exceed the level of the transmitter's fundamental emission.







Test Procedure

- 1. The EUT was placed on turn table which is 0.8m above ground plane for below 1GHz test, and on a low permittivity and low loss tangent turn table which is 1.5m above ground plane for above 1GHz test.
- 2. Maximum procedure was performed by raising the receiving antenna from 1m to 4m and rotating the turn table from 0° to 360° to acquire the highest emissions from EUT.
- 3. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- 4. Repeat above procedures until all frequency measurements have been completed.



4.5 Power Spectral Density

4.5.1 Limit

For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

4.5.2 Test Procedure

Use this procedure when the maximum peak conducted output power in the fundamental emission is used to demonstrate compliance.

Set the RBW =10 kHz.

Set the VBW =30 KHz.

Set the span to 1.5 times the DTS channel bandwidth.

Detector = peak.

Sweep time = auto couple.

Trace mode = max hold.

Allow trace to fully stabilize.

Use the peak marker function to determine the maximum power level.

If measured value exceeds limit, reduce RBW(no less than 3 kHz)and repeat.

The resulting peak PSD level must be 8 dBm.

4.6 6db Bandwidth

4.6.1 Limit

For digital modulation systems, the minimum 6 dB bandwidth shall be at least 500 kHz.

4.6.2 Test Procedure

The transmitter output was connected to the spectrum analyzer through an attenuator. The bandwidth of the fundamental frequency was measured by spectrum analyzer with RBW=100 KHz and VBW=300 KHz.


The 6dB bandwidth is defined as the total spectrum the power of which is higher than peak power minus 6dB.

- 1. Set RBW = 100 kHz.
- 2. Set the video bandwidth (VBW) ≥ 3 RBW.
- 3. Detector = Peak.

- 6. Allow the trace to stabilize.





4.7 Occupied Bandwidth

4.7.1 Test Procedure

The occupied bandwidth is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers are each equal to 0.5% of the total mean power of the given emission. The following procedure shall be used for measuring 99% power bandwidth:

RBW=1% to 5% of the OBW

VBW=approximately 3 X RBW

Detector=Peak

Trace Mode: Max Hold

Use the 99% power bandwidth function of the instrument to measure the Occupied Bandwidth and recorded.

4.8 Band Edge

4.8.1 Limit

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated device is operating, the RF power that is produced shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided that the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under FCC rules in section 5.8.1, the attenuation required shall be 30 dB instead of 20 dB.

4.8.2 Test Procedure

- a. The EUT was directly connected to the spectrum analyzer and antenna output port as show in the block diagram below.
- b. Span = wide enough to capture the peak level of the emission operating on the channel closest to the band edge, as well as any modulation products which fall outside of the authorized band of operation, RBW ≥ 1% of the span, VBW ≥ RBW, Sweep = auto, Detector function = peak, Trace = max hold.

4.9 Conducted Spurious Emissions

4.9.1 Applied Procedures / Limit

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated device is operating, the RF power that is produced shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided that the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under Section (b)(3) of RSS 5.4(4), the attenuation required shall be 30 dB instead of 20 dB. For below 30MHz,For 9KHz-150kHz,150K-10MHz,We use the RBW 1KHz,10KHz, So the limit need to calculated by "10lg(BW1/BW2)". for example For9KHz-150kHz,RBW 1KHz, The Limit= the highest emission level-20-10log(100/1)= the highest emission level-40.

a. The EUT was directly connected to the spectrum analyzer and antenna output port as show in the block diagram below.

b.Span = wide enough to capture the peak level of the emission operating on the channel closest to the band edge, as well as any modulation products which fall outside of the authorized band of operation, RBW \geq 1% of the span, VBW \geq RBW, Sweep = auto, Detector function = peak, Trace = max hold.
