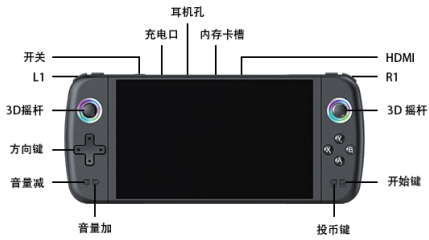

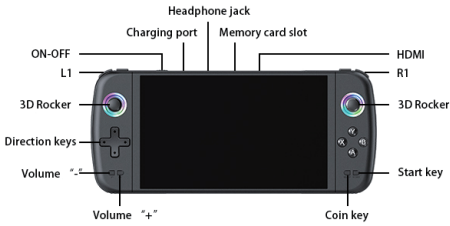

- 5.Charging method: please use 5V-2A charger to connect the TP-C port of the machine. Charging time: 5-8 hours
