

INSTRUCTIONS:

1.MODE

Short press for switching among Bluetooth, TF CARD, USB, LINE IN, FM.

2.

Play the previous music under Bluetooth, TF card and USB mode Play previous radio station under FM mode. Long press for volume down.

3.

Short press for music play/pause.

Long press for radio station automatic searching under FM mode.

4.

Play to next music under Bluetooth TF card and USB mode Play next radio station under FM mode. Long press for volume up.

5.DC 3.7V

Charge Jack for built in battery. When DC 3.7V cable plugs in, The LED lights up.

6.AUX

AUX IN can connect to PCmp3Phone.or CD walkman.

7.OFF/ON

Speaker power off/ Speaker power on.

8.USB Port

Support USB and can play MP3 and WAV format music in U disk.

9.Mic

Plug the microphone input the port to enjoy the music.

10.TF card Port

Support TF CARD and can play MP3 and WAV format music in CARD.

11. Bluetooth Connection

- Power on the product or press MODE button to enter into Bluetooth mode.
- Open mobile devices(Cell phones computers. etc)in Bluetooth mode, search for Bluetooth devices when it appears the item pairing name (BT SPEAKER).
- After the device has been paired successfully for the first time it will connect automatically around 10 seconds to the devices which connected before when next time use.(Note: Each product could connect to one Bluetooth device only.)
