


- 1 INPUT : 吉他输入插孔

Function description

- 1 INPUT : Guitar input jack
- 2 VOL : Volume adjustment knob
- 3 DIST : Clean and distortion (overload) effect switch
- 4 TONE : Tone adjustment knob
- 5 TYPE_C : Type_c Charging interface
- 6 SW : Bluetooth Swtich
Press once to pause ;
Press twice to play the next song ;
Press the Bluetooth button and last 2 second,the Bluetooth is on, and press another 2 second,the Bluetooth will be off.
- 7 ON : Bluetooth light (Quick Flash means Bluetooth is Off ;
Slow Flash means Bluetooth is Working ;
Ongoing Flash means Bluetooth is Paused)
- 8 ON/CH : Power indicator/charging indicator
- 9 POWER : Power switch
