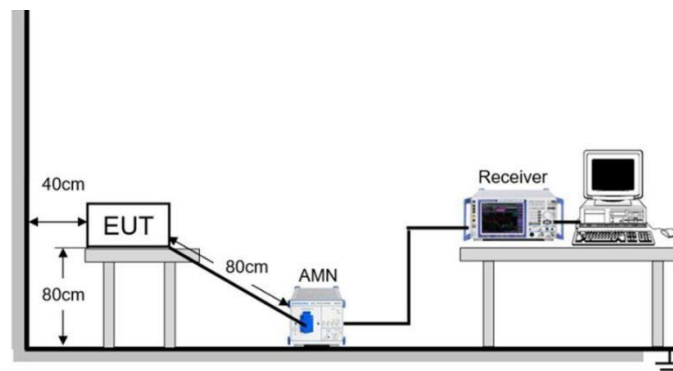

All other surfaces of EUT were at least 80 cm from any other grounded conducting surface. 3. 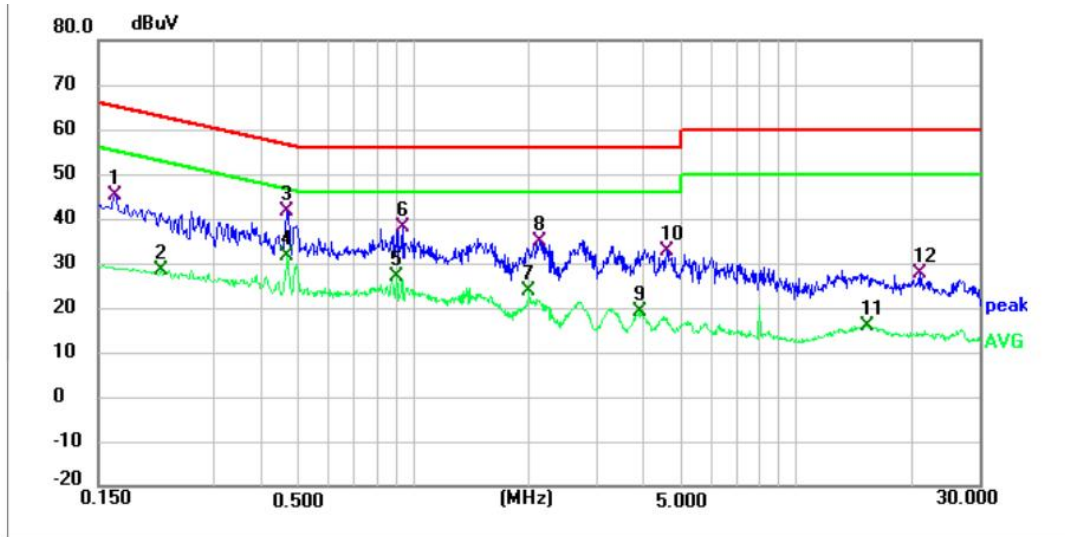

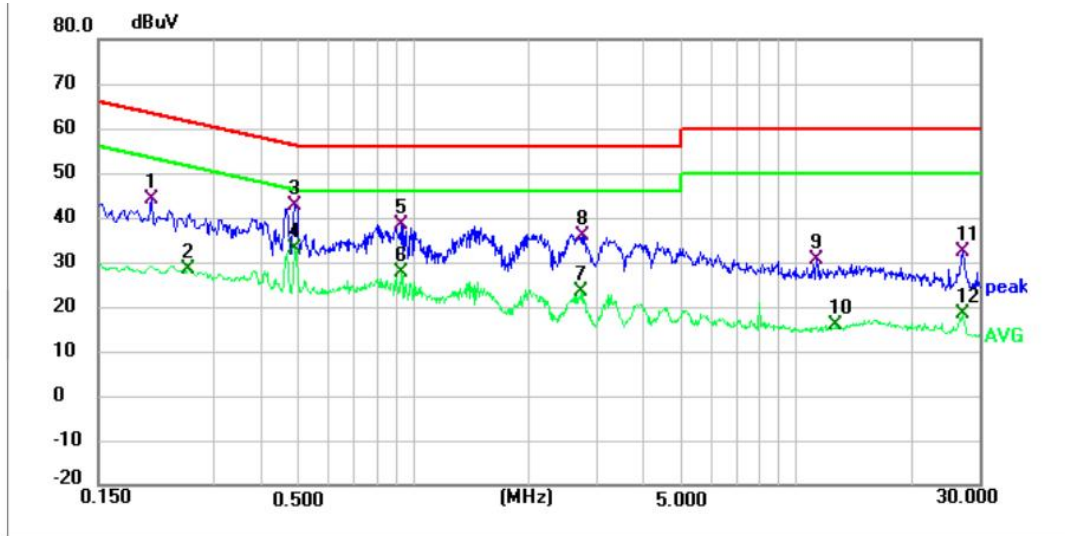

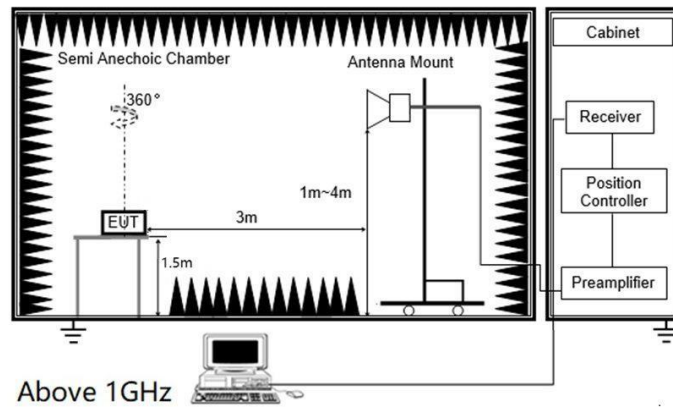

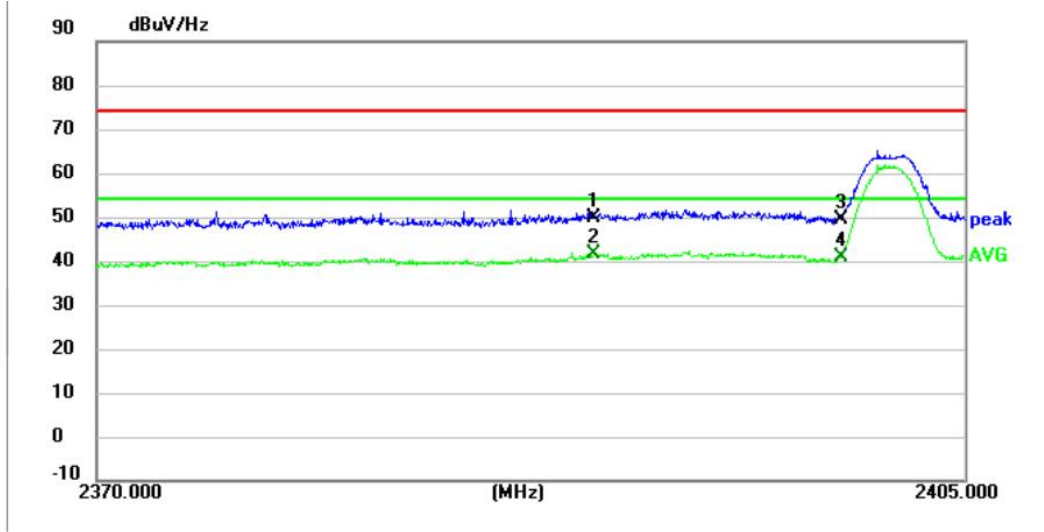
