





Pet Automatic Ball Launcher

User Manuals



1 About the product and its accessories



***Product includes: 1 automatic ball machine, 2 tennis balls, 1 remote control, and 1 charger. For returns, please pack all items in the original box.**

2 About Charging

- This ball launcher is equipped with a rechargeable battery. Please use the provided charger for recharging..
- Charging time: about 3 hours
- Battery capacity:2600mAh

Charger power requirements(12.6w Max)	
Operating Voltage-12.6V	Maximum Current-1A

- Please use the original charger. If it is damaged, use a replacement charger with a power rating that does not exceed the specified maximum.
- This product has a charging protection function, and it will automatically cut off the power when the battery is fully charged.
- The charging head's indicator light: green for full charge, red for not fully charged.
- Battery level display: Check via display screen

Four bars	75%-100% battery level
Three bars	50%-75% battery level
Two bars	25%-50% battery level
One bar	1%-25% battery level

3 How to use

- 1.Before first use, please charge the machine.
- 2.Power off completely when not in use.
- 3.After power-on, default distance is level 1 (10ft). Adjust using product's distance button or remote. Levels cycle: 1 (10 ft), 2 (20 ft), 3 (30 ft), then repeat.
- 4.When in use, place the ball in the entry. It will eject after 3 seconds. If multiple balls are placed at once, they will eject approximately every 3 seconds.
- 5.In case of damage to the provided tennis ball, it can be replaced with any standard tennis ball.

4 Matters need attention

- 1.The ball launcher can't be used while charging.
- 2.Please turn off the device before charging.
- 3.Don't take apart the machine.
- 4.Remote control only works when powered on.
- 5.Don't stand in front of the ball launcher to avoid injury.
- 6.Human/Animal Detection: Stops ball dispensing on sensing, can ONLY be turned off via remote, defaults to on at power-on.
- 7.High-sensitivity sensor may cause false triggers due to sudden light changes, passing leaves, flying insects, or similar interference.
- 8.After an obstacle clears, there's a 5 - second delay for human detection. Avoid standing in front of the sensor too long time, or it may not detect the next action.
- 9.The human body sensing icon flashes when the function is activated and remains steady when deactivated.
- 10.This product is not waterproof. Avoid using it in rainy conditions or rinsing it directly with water. For cleaning, use a dry cloth or damp wipe only.
- 11.Clean the tennis ball and machine after each use.
- 12.Replace damaged balls promptly for optimal use.
- 13.Balls contaminated with saliva, dirt, and other impurities may affect launch distance.
- 14.Excessively cold or hot ambient temperatures can affect battery life.
- 15.Low battery voltage may cause the launcher range to decline, which is normal. Prompt charging will resolve the issue.
- 16.Try not to fully drain the battery, as it will affect its lifespan.
- 17.The remote control for this product is not interchangeable. If it is lost, please purchase an official VKL remote control.
