Calculation Method

Friis transmission formula: $P_d = (P_{out} * G) / (4 * \pi * R^2)$

Where:

P_d = Power density in mW/cm²

P_{out} = output power to antenna in mW

G = gain of antenna in linear scale

π = 3.1416

R = distance between observation point and center of the radiator in cm

P_d limit of MPE is 1mW/cm². If we know the maximum gain of the antenna and total power input to the antenna, through the calculation, we will know the distance where the MPE limit is reached.
