





Wearing



Please ensure that one end of the earphone is snugly fitted into your ear canal, while the other side is securely looped behind the ear, maintaining a stable position to prevent the earphone from falling off.

Pairing



Stereo Mode

1. Open the charging case and take out the earphones from the charging case, two earbuds will automatically turn on and connect to each other, waiting to connect to your phone. You will hear the sound “pairing”.
2. Turn on your phone's Bluetooth and select "Ao6". when you hear the sound “connected”, pairing is done.

Forced Pairing


Press button for 3 secs, the earbuds will enter forced pairing mode, LED Light will start to breathe/pulse.

Reset Connection/Clear All Records

Press button for 10 sec, LED Light will turn red and green three times, all records have been cleared.

FAQs

Q: If JewelPods keep falling off my ears, how do I wear Jewel-Pods?

A: For the best experience, please follow our wearing instruction videos. JewelPods are designed with special ergonomic features to ensure a secure and comfortable fit, even during physical activity. Any issue, feel free to reach out to us for help.

Q: If I am using the earphones and Bluetooth pairing is unsuccessful, what should I do?

A: Please ensure the earphones are properly placed inside the charging case, then press and hold the rear button for 10 seconds to reset the Bluetooth connection, and repeat the pairing process. If the issue exists still, feel free to reach out to us for help.
