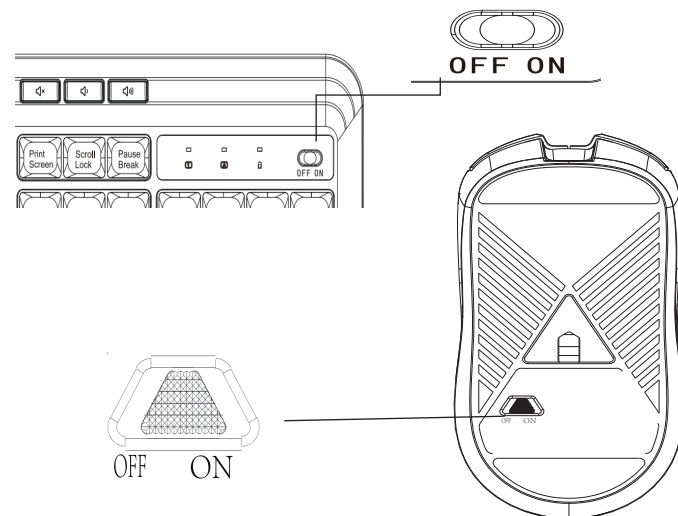


How to set up

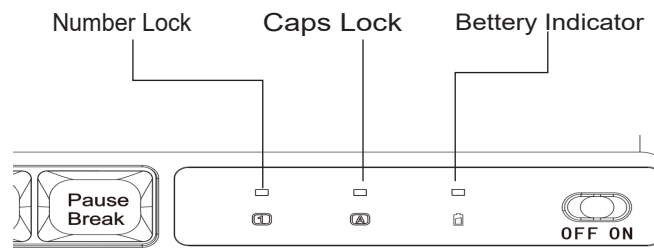
- ❶ Step 1: Plug the USB dongle into your computer
(USB receiver is on the back of the Keyboard)



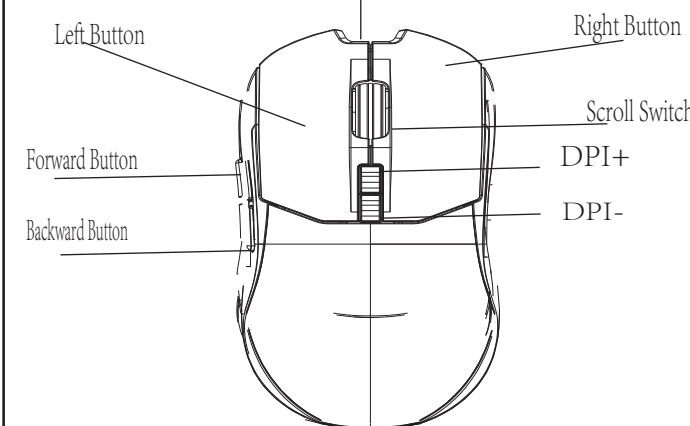

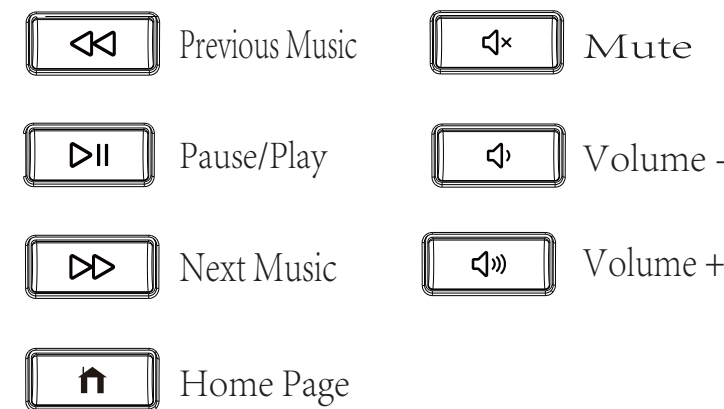
- ❸ Step 3: The keyboard and mouse will automatically connect to the computer.
