1. Safety Instructions

General Safety Precautions

- Do not modify or attempt to repair the device yourself.
- Only use accessories recommended by Brume
- **Do not drink or place liquid oil in the mouth. Keep out of reach of children.**


Battery Safety

- This product contains a **rechargeable battery**.
- Do not **short-circuit, disassemble, or puncture** the battery.
- Charge only using the **provided charger/cable**.
- Dispose of batteries **properly and according to local regulations**.
- If the battery is leaking, avoid contact with skin and seek medical advice.

Bluetooth & Wireless Safety

- Follow all **local regulations regarding Bluetooth and wireless communication**.
- Keep the device at a **safe distance from medical implants (e.g., pacemakers)**.

5. Getting Started

1. Charging the Device

- Connect the USB-C charging cable to the charging port (F).

● RED indicator means the battery-level is below 20%.

● WARM WHITE indicator means the battery-level is above 20% - Only appears when not in charging mode

● GREEN indicator means the battery-level is above 90% - Only appears when in charging mode.

2. Inserting the Scent Cartridge

- Remove the Disposable cartridge (C), we recommend storing it safely as it may be helpful for maintenance and product cleaning later on.
- Insert a Brume cartridge securely from the bottom and make sure it is securely attached to the body.

3. Finding the perfect spot in the room

- Prefer placing the diffuser in a central area of the room to distribute the area evenly and cover the space ideally.
- Avoid corners as it will impact the scent distribution.

4. Turning the Device On/Off

- Short press the **power button** to turn on.
- The LED indicator will light up.
- Press and hold again to turn off.

6. Operating Instructions

Connecting via Bluetooth

- 1.** Download the latest version of the Scent Tech app at [**www.brume.me/setup**](http://www.brume.me/setup) or scan the QR code on the front page.
- 2.** Enable Bluetooth on your smartphone.
- 3.** Open the app, then select Bluetooth.
- 4.** Double tap the LED control button (E) until it flashes blue to enter **pairing mode**.
- 5.** In the app, a **BRUME device** should appear in the list, tap it to pair.
- 6.** Add **working modes** to schedule diffusion and adjust spray and pause times for desired aroma intensity.

Manual Mode

- Press the power button to start the device. If no program has been set up, the device will run in default mode, which is configured to operate at the highest intensity for 4 hours or until manually turned off.

Allow the diffuser to run for about 30 minutes to scent the room.

Factory reset

To reset to factory settings and activate the highest scent intensity in manual mode, press and hold the button for more than 5 seconds.

7. Maintenance and Cleaning

We recommended cleaning the device every 3 months or after long periods of disuse.

To do so, fill an empty cartridge with 95% alcohol and run it at maximum intensity for 30 minutes.

8. Troubleshooting

<u>Issue</u>	<u>Solution</u>
Device won't turn on	Ensure the battery is charged. Short press the power button.
Weak or no scent	Check diffuser placement. Adjust intensity settings. Make sure the pipe (B) isn't clogged.
Bluetooth won't connect	Restart the device pairing by double-tapping the power button and ensuring the light flashes. Then, re-pair it in the app.

9. Warranty and Customer Support

- This product is covered under a **12-month warranty** after purchase date.
- The warranty is suitable for new devices but not resold or second hand products.
- The warranty does not cover misuse, damage from drops or accidents, broken parts, unauthorized repairs, or any physical deterioration caused by the user.
