


Instruction Manual

Please read this instruction manual carefully before using the product.
Please keep this manual for your reference after reading.



When the power switch is on, you will hear a “beep” sound, then immediately long press the “ Fan ON/OFF”. If the pairing is success, you will hear a “Beep” by then, if not, please repeat the above steps again.

The features of keypad wall controller

- ◆ It is adsorptional structure. You can place it on the wall as a wall controller or take it down as remote controller, whatever you like.
- ◆ It can control the ceiling fan light together with remote control as double insurance, to avoid the embarrassing case of losing remote control
- ◆ The pairing method is simple and easy to replace. It's a fully functional controller, same as the handheld remote control.

Compatible battery type is CR2032, 3 V
