Business Search

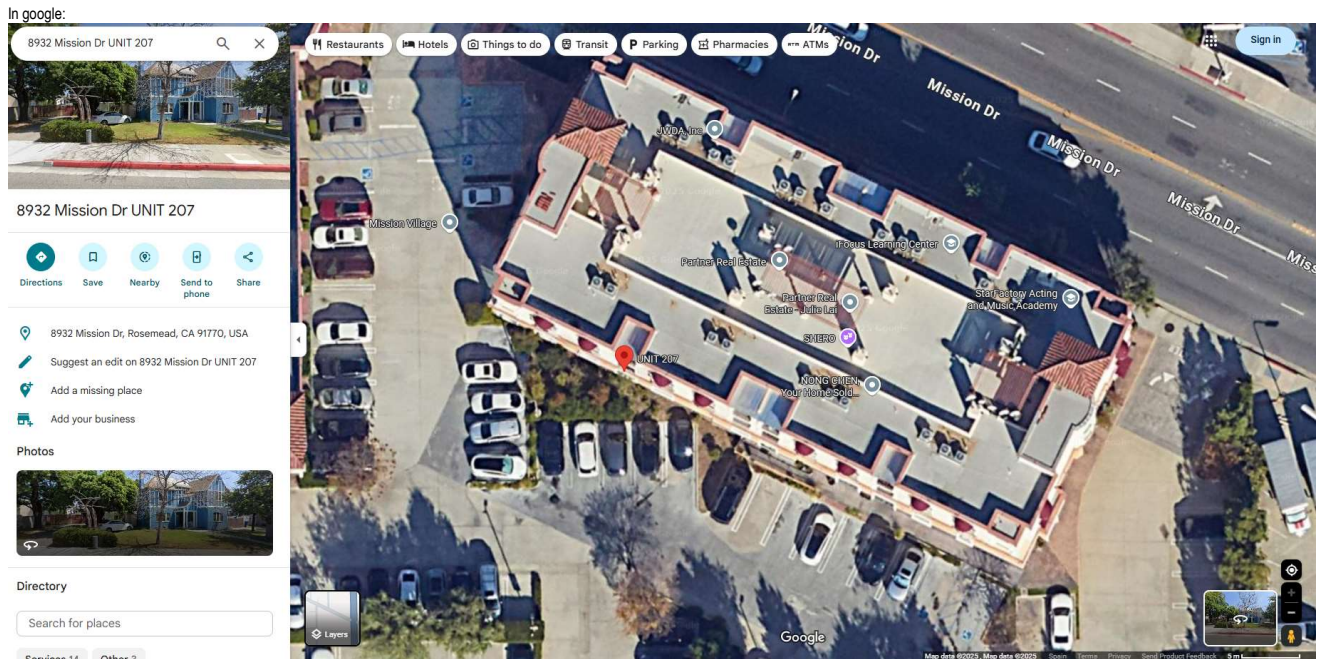
