## 2D POLAR RADIATION PATTERN

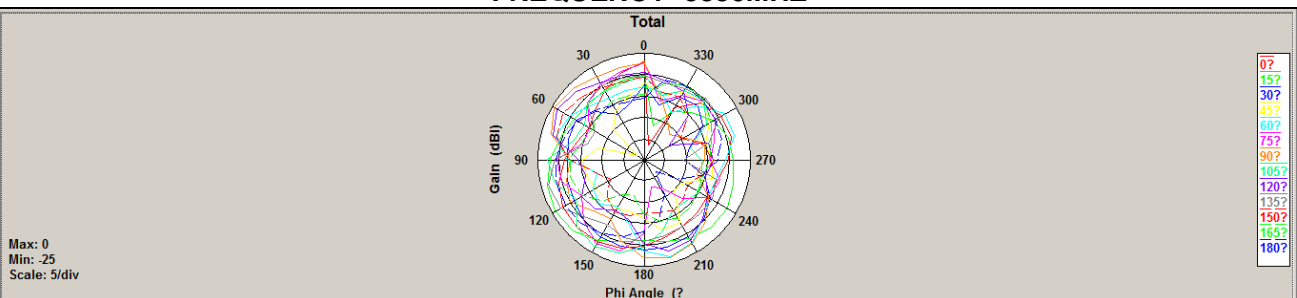

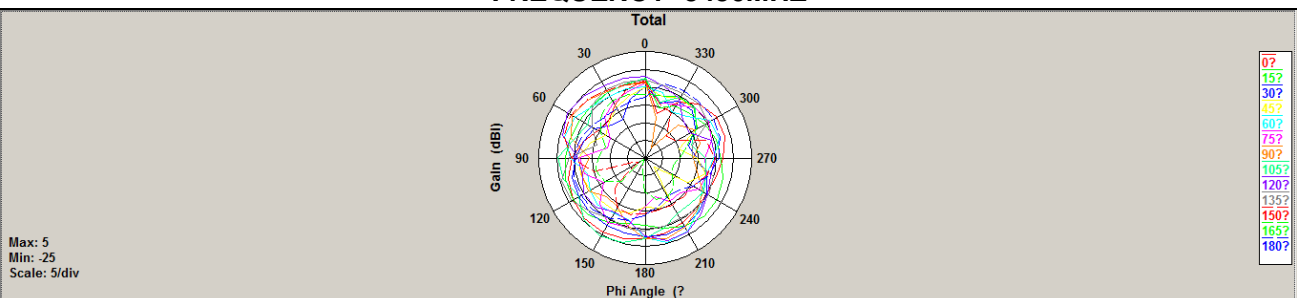
## FREQUENCY=5250MHZ

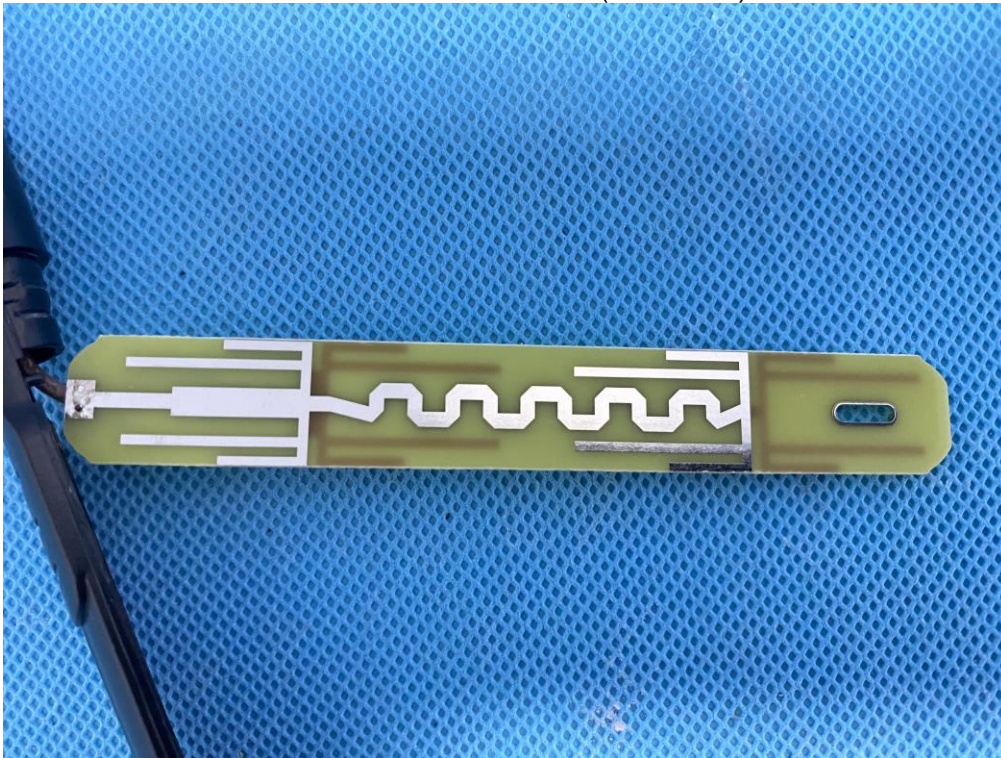
