





Hold Volume + for 5s





# Function Table

Function	Status	LED
Dual Connection	Pair phone A, switch its Bluetooth off, pair phone B, switch A back on — both now linked.	red/blue
Low Battery	Headphones announce "Battery low" when under 3.3V.	Flashes once per second
Charging	About 1.5 hours to fully charge.	LED red stays on
Fully Charged	—	LED blue stays on
Factory Reset	Hold V+ and V- for 5s.	LED blue flashes twice
Charging shutdown	Just plug in Type-C charger; the headphones will turn off automatically.	LED red stays on for 1s

# SAFETY & CARE

- !** Begin every listening session at a low volume and avoid extended listening at high levels.
- !** Water-resistance rating: IP54. Do not immerse the headphones.
- !** Use a standard 5V charger. Never charge the headphones while they are damp.
- !** Wipe with a dry cloth only. Avoid alcohol-based or solvent cleaners.
- !** Children must not attempt to dismantle the headphones.
- !** An adult should supervise app use and assist with the initial account set-up.
- !** **WARNING: CHOKING HAZARD – SMALL PARTS.** Not for children under 3 years.



# Hearing Protection


## Hearing Protection:

- Meets WHO Safe Listening Guidelines — up to **85 dB** for no more than 8 hours per day.
- Healthy-Ear Tip — Give your ears a 10-minute break every hour and keep the volume as low as comfortably possible.

**Parental Control:** Parents can manage volume levels and set listening time limits. See the **Benefits Guide** for step-by-step instructions.

- Toddler Soft Mode — 75 dB max
- Daily Routine Mode — 85 dB max (default)
- Temporary Boost Mode — 94 dB max for planes and subways. After 15 minutes the level automatically drops back to 85 dB for safer listening.
