GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The SALAZAR QUINTERO JOHN RICHARD's product, model number: VS20 (FCC ID: A2VVS20) (the "EUT") in this report was a *Mobile Phone*, which was measured approximately: 103 mm (W) x 43.5 mm (D) x 14.5 mm (H), rated input voltage: DC 3.7V Lithium battery or DC 5.0V from adapter for charging. The highest EUT operating frequency is 80 MHz.

Test Facility

The Test site used by Bay Area Compliance Laboratories Corp.(Shenzhen) to collect test data is located on the 6/F, the 3rd Phase of WanLi Industrial Building, ShiHua Road, FuTian Free Trade Zone Shenzhen, Guangdong, China.

Test site at Bay Area Compliance Laboratories Corp. (Shenzhen) has been fully described in reports submitted to the Federal Communication Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on December 06, 2010. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-2009.

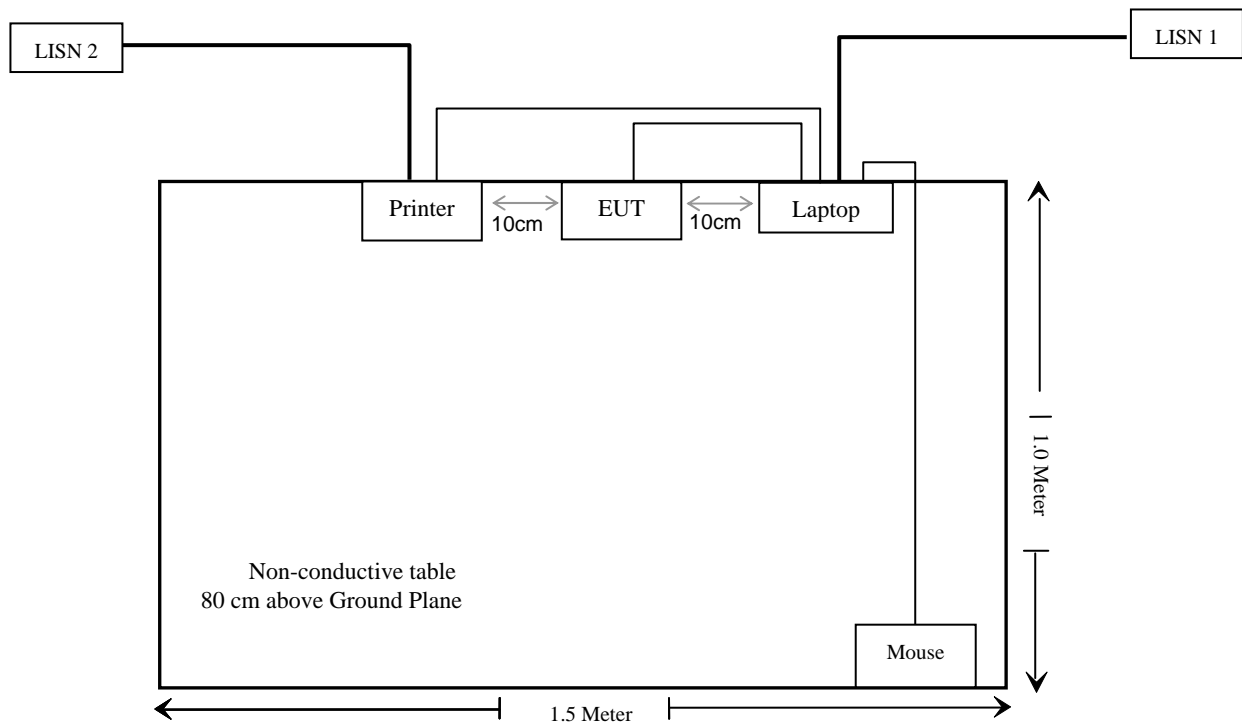

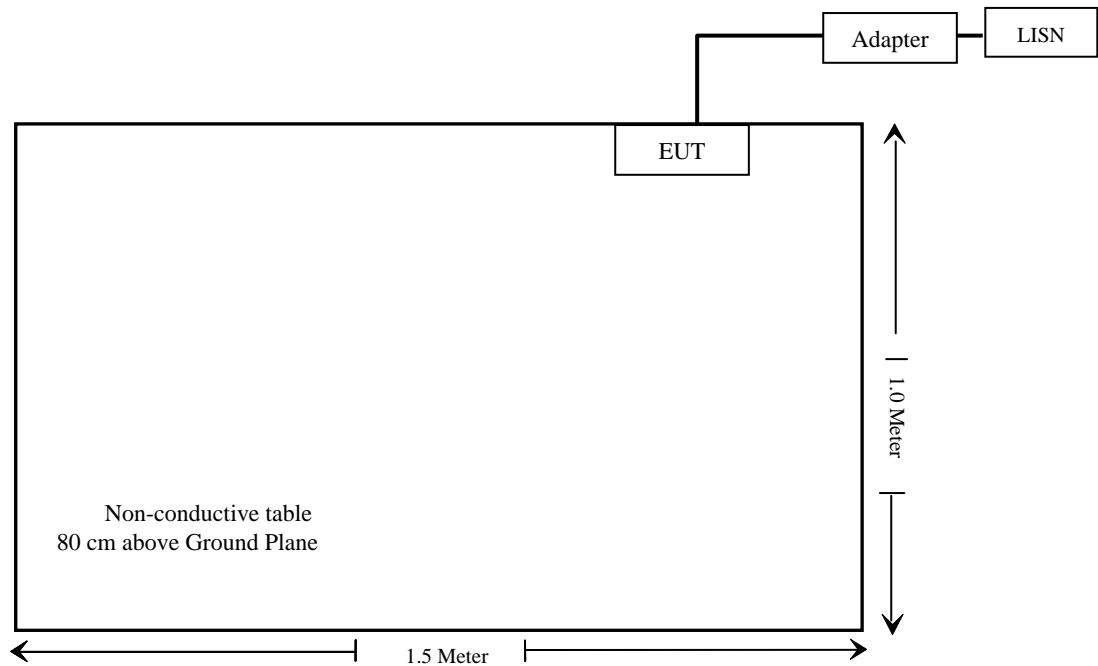

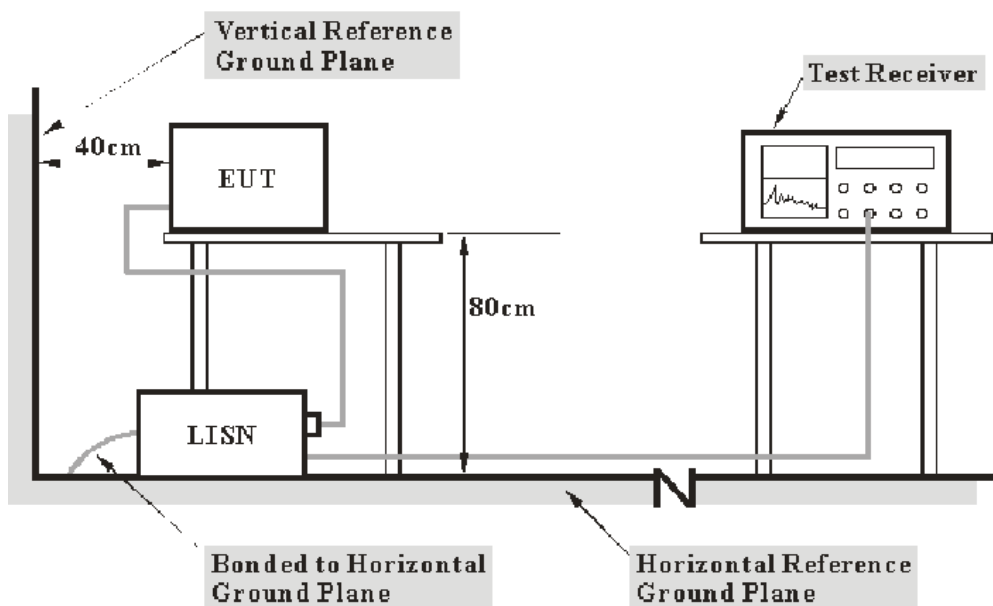
FCC §15.107 – AC LINE CONDUCTED EMISSIONS

Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, and LISN.

Based on CISPR 16-4-2, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of any conducted emissions measurement at Bay Area Compliance Laboratories Corp. (Shenzhen) is ± 2.4 dB.(k=2, 95% level of confidence)

EUT Setup



- Note: 1. Support units were connected to second LISN.
2. Both of LISNs (AMN) 80 cm from EUT and at the least 80 cm from other units and other metal planes support units.

The setup of EUT is according with per ANSI C63.4-2009 measurement procedure. The specification used was with the FCC Part 15.107 Class B limits.

The spacing between the peripherals was 10 cm.

For downloading mode, the adapter of laptop was connected to a 120 VAC/60 Hz power source.

For charging&Multimedia playing mode, the adapter of EUT was connected to a 120 VAC/60 Hz power source.

EMI Test Receiver Setup

The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

During the conducted emission test, the EMI test receiver was set with the following configurations:

Test Procedure

During the conducted emission test, for downloading mode, the Laptop was connected to the outlet of the first LISN, and the printer was connected to the outlet of the second LISN; For charging&multimedia playing mode, the adapter was connected to the outlet of the LISN.

Maximizing procedure was performed on the six (6) highest emissions of the EUT.

All data was recorded in the Quasi-peak and average detection mode.

Test Results Summary

According to the recorded data in following table, the EUT complied with the FCC Part 15.107, with the worst margin reading of:

6.95 dB at 2.410 MHz in the **Neutral** conducted mode for charging & Multimedia playing mode

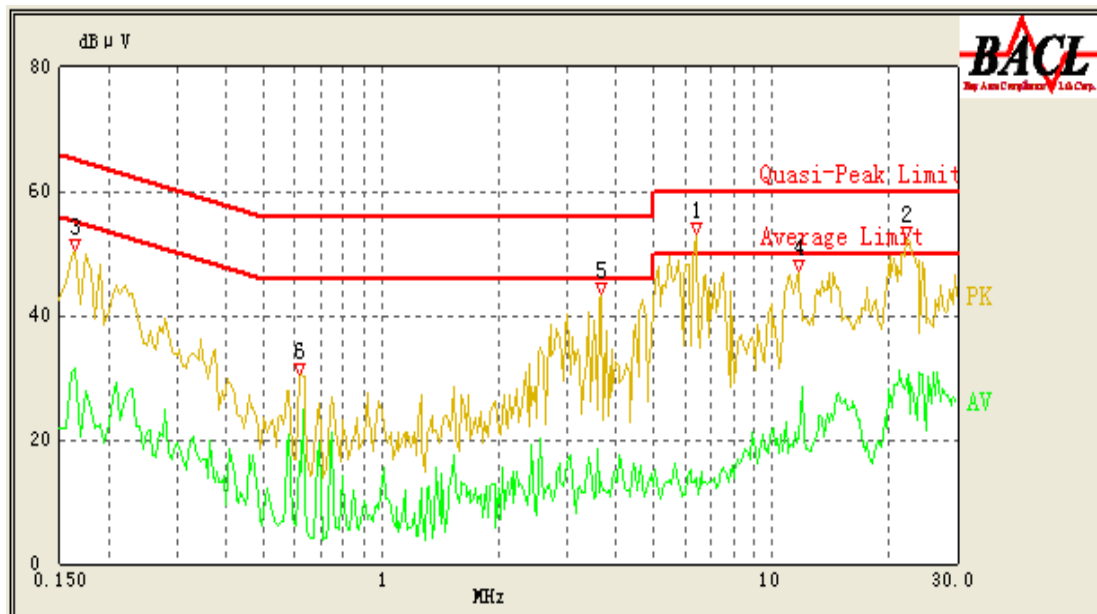

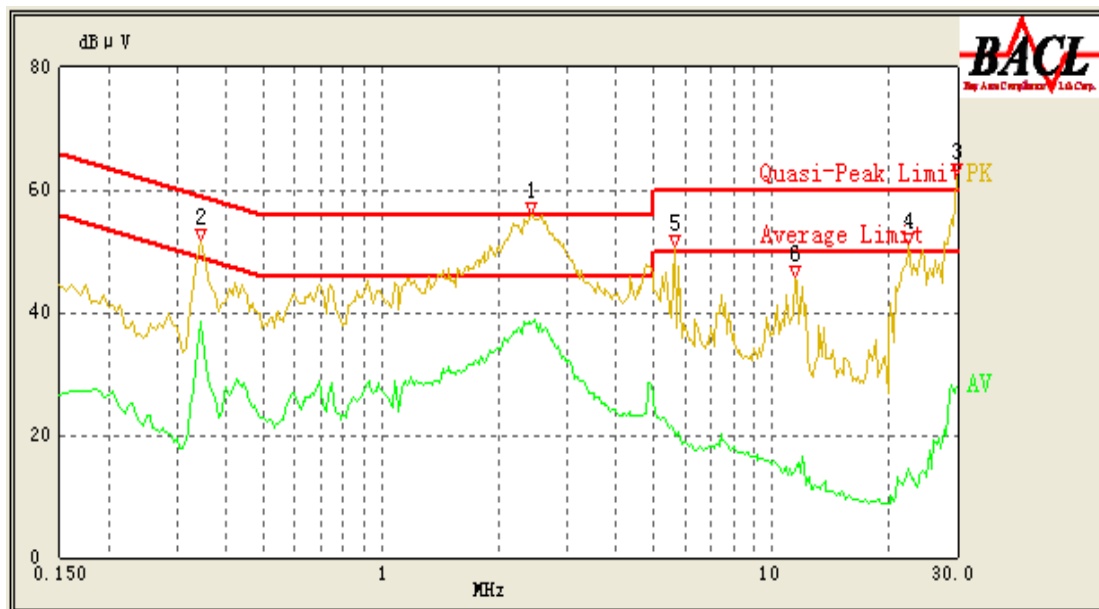

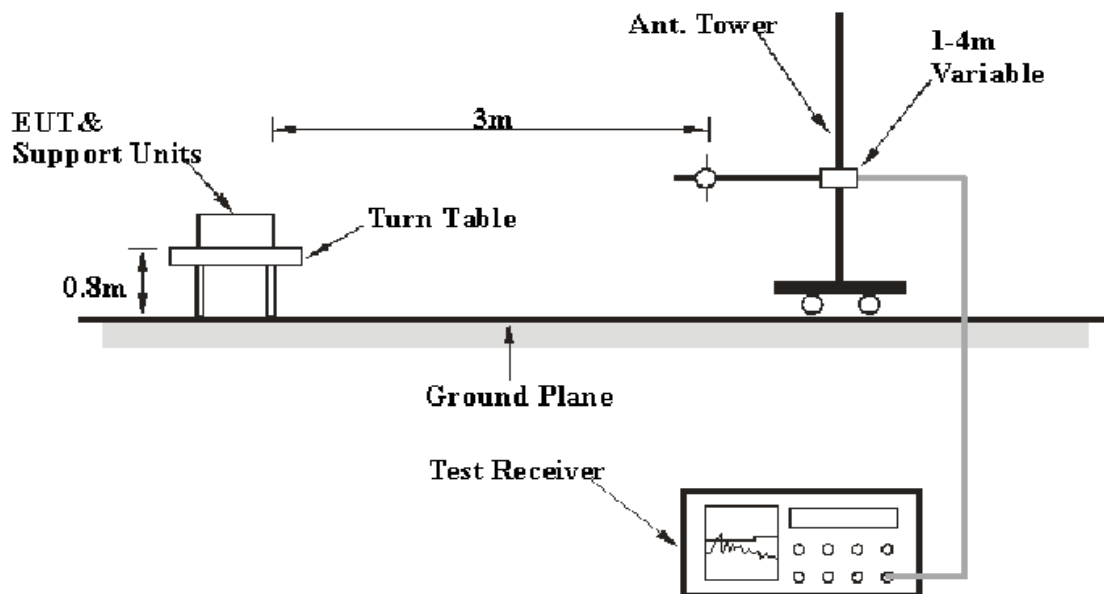

Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on CISPR 16-4-2, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of a radiation emissions measurement at Bay Area Compliance Laboratories Corp. (Shenzhen) is ± 4.0 dB. ($k=2$, 95% level of confidence)

EUT Setup



The radiated emission tests were performed in the 3 meters test site, using the setup accordance with the ANSI C63.4-2009. The specification used was the FCC Part 15.109, Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

For downloading mode, the adapter of laptop was connected to a 120 VAC/60 Hz power source.

For Multimedia playing mode, the EUT was powered by battery connecting with earphone.

EMI Test Receiver Setup

The system was investigated from 30 MHz to 1000 MHz.

During the radiated emission test, the EMI test receiver was set with the following configurations:

Test Procedure

During the radiated emissions test, for downloading mode, the Laptop and the printer were connected to AC floor outlet; For multimedia playing mode, the EUT was powered by battery connecting with earphone.

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detection mode from 30 MHz to 1 GHz.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Loss and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

$$\text{Corrected Amplitude} = \text{Meter Reading} + \text{Antenna Loss} + \text{Cable Loss} - \text{Amplifier Gain}$$

The “**Margin**” column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7 dB means the emission is 7 dB below the limit. The equation for margin calculation is as follows:

$$\text{Margin} = \text{Limit} - \text{Corrected Amplitude}$$

Test Results Summary

According to the data in the following table, the EUT complied with the FCC §15.109 Class B, with the worst margin reading of:

5.5 dB at 30.001750 MHz in the Vertical polarization

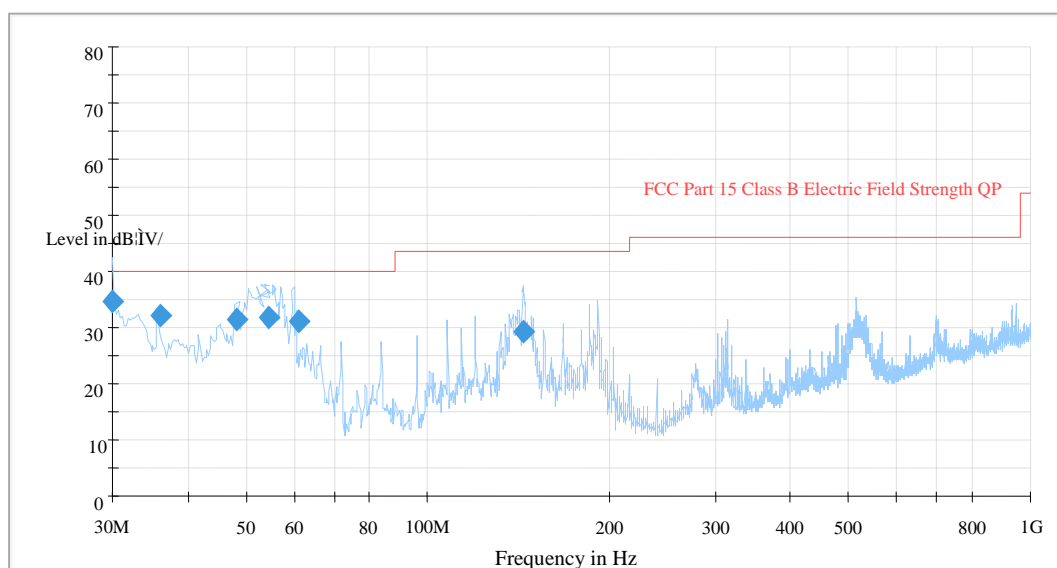

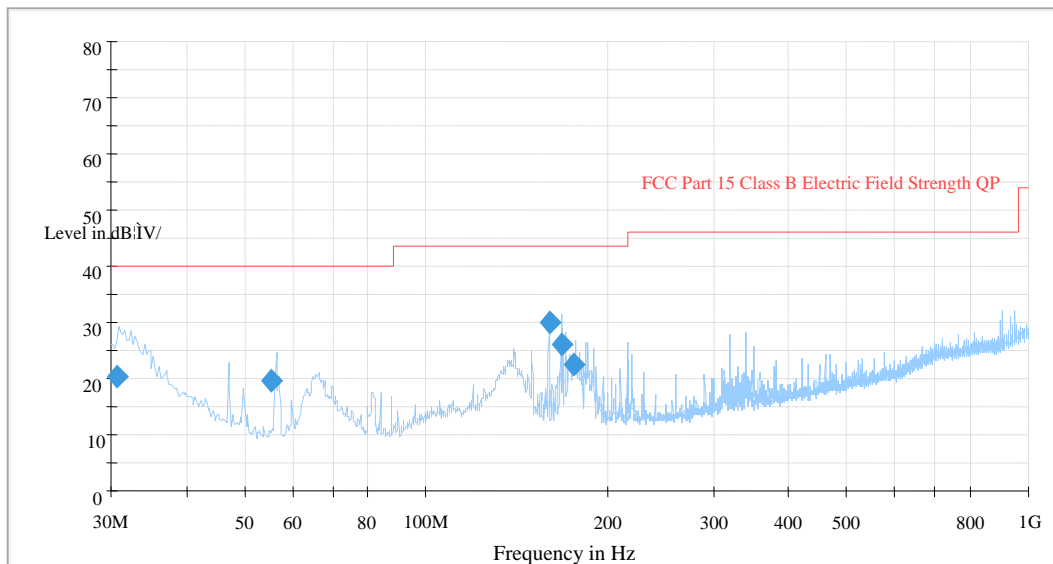
