## **TEST RESULT**

*No non-compliance noted.*

### **Calculation**

$$\text{Given } E = \frac{\sqrt{30 \times P \times G}}{d} \quad \& \quad S = \frac{E^2}{3770}$$

Where  $E$  = Field Strength in Volts / meter

$P$  = Power in Watts

$G$  = Numeric antenna gain

$d$  = Distance in meters

$S$  = Power Density in milliwatts / square centimeter

Combining equations and re-arranging the terms to express the distance as a function of the remaining variables yields:

$$S = \frac{30 \times P \times G}{3770 d^2}$$

Changing to units of mW and cm, using:

$$P \text{ (mW)} = P \text{ (W)} / 1000 \text{ and}$$

$$d \text{ (cm)} = 100 * d \text{ (m)}$$

Yields

$$S = \frac{30 \times (P/1000) \times G}{3770 \times (d/100)^2} = 0.0796 \times \frac{P \times G}{d^2}$$

***Equation 1***

Where  $d$  = distance in cm

$P$  = Power in mW

$G$  = Numeric antenna gain

$S$  = Power Density in mW / cm<sup>2</sup>

### **Maximum Permissible Exposure**

EUT Output Power=9.2mW

Numeric antenna gain=1.58

Substituting the MPE safe distance using d=20 cm into ***Equation 1*** :

Yields

$$S = 0.000199 \times P \times G$$

Where  $P$  = Power in mW

$G$  = Numeric antenna gain

$S$  = Power Density in mW / cm<sup>2</sup>

The power density  $S = 0.000199 \times 9.2 \times 1.58 \text{ mW / cm}^2 = 0.0028927 \text{ mW / cm}^2$

(For mobile or fixed location transmitters, the maximum power density is 1.0 mW / cm<sup>2</sup> even if the calculation indicates that the power density would be larger.)
