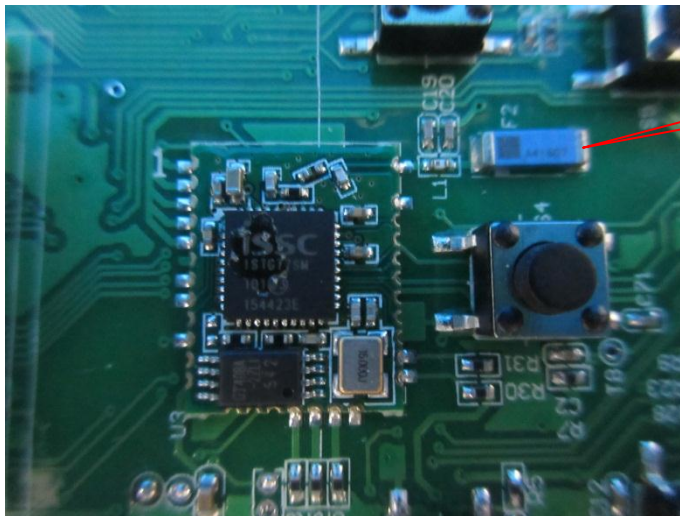

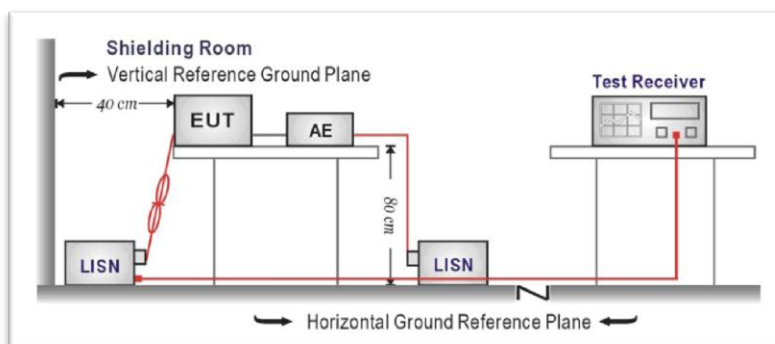

TEST PROCEDURE

1. The EUT was setup according to ANSI C63.10:2013 for compliance to FCC 47CFR 15.247 requirements.
2. The EUT was placed on a platform of nominal size, 1 m by 1.5 m, raised 80 cm above the conducting ground plane. The vertical conducting plane was located 40 cm to the rear of the EUT. All other surfaces of EUT were at least 80 cm from any other grounded conducting surface.
3. The EUT and simulators are connected to the main power through a line impedance stabilization network (LISN). The LISN provides a 50 ohm /50uH coupling impedance for the measuring equipment.
4. The peripheral devices are also connected to the main power through a LISN. (Please refer to the block diagram of the test setup and photographs)
5. Each current-carrying conductor of the EUT power cord, except the ground (safety) conductor, was individually connected through a LISN to the input power source.
6. The excess length of the power cord between the EUT and the LISN receptacle were folded back and forth at the center of the lead to form a bundle not exceeding 40 cm in length.
7. Conducted emissions were investigated over the frequency range from 0.15MHz to 30MHz using a receiver bandwidth of 9 kHz.
8. During the above scans, the emissions were maximized by cable manipulation.

- 1) The EUT was setup and tested according to ANSI C63.10:2013 for compliance to FCC 47CFR 15.247 requirements.
- 2) The EUT is placed on a turn table which is 1.5 meter above ground. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
- 3) The EUT was positioned such that the distance from antenna to the EUT was 3 meters.
- 4) The antenna is scanned from 1 meter to 4 meters to find out the maximum emission level. This is repeated for both horizontal and vertical polarization of the antenna. In order to find the maximum emission, all of the interface cables were manipulated according to ANSI C63.10:2013 on radiated measurement.
- 5) The receiver set as follow:
 RBW=1MHz, VBW=3MHz Peak detector for Peak value
 RBW=1MHz, VBW=3MHz RMS detector for Average value.

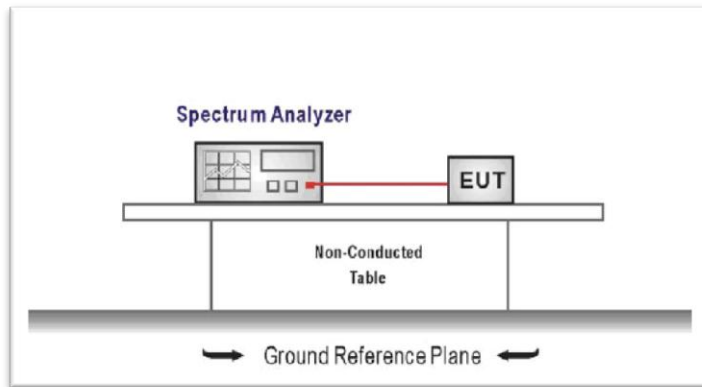
5.7. Band edge and Spurious Emission (conducted)

LIMIT

FCC CFR Title 47 Part 15 Subpart C Section 15.247 (d):

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.

TEST PROCEDURE

1. The EUT was tested according to ANSI C63.10:2013 for compliance to FCC 47CFR 15.247 requirements.
2. The EUT is placed on a turn table which is 0.8 meter above ground. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
3. The EUT was positioned such that the distance from antenna to the EUT was 3 meters.
4. The antenna is scanned from 1 meter to 4 meters to find out the maximum emission level. This is repeated for both horizontal and vertical polarization of the antenna.
5. Use the following spectrum analyzer settings
 - (1) Span shall be wide enough to fully capture the emission being measured;
 - (2) Below 1GHz, RBW=120KHz, VBW=300KHz, Sweep=auto, Detector function=peak, Trace=max hold; If the emission level of the EUT measured by the peak detector is 3 dB lower than the applicable limit, the peak emission level will be reported. Otherwise, the emission measurement will be repeated using the quasi-peak detector and reported.
 - (3) Above 1GHz, RBW=1MHz, VBW=3MHz Peak detector for Peak value
RBW=1MHz, VBW=3MHz RMS detector for Average value.

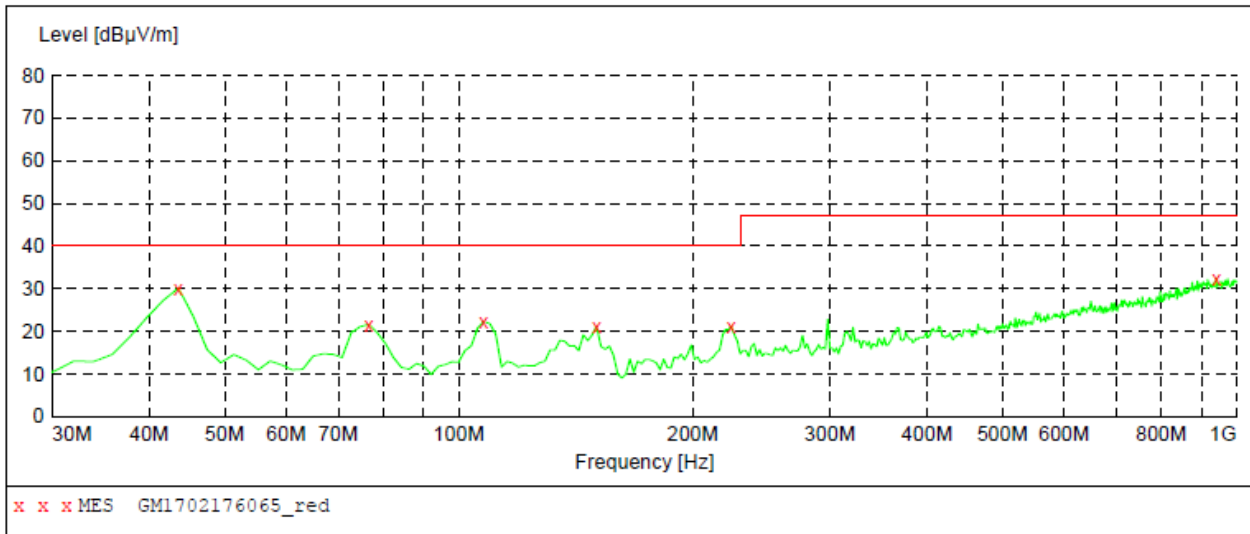

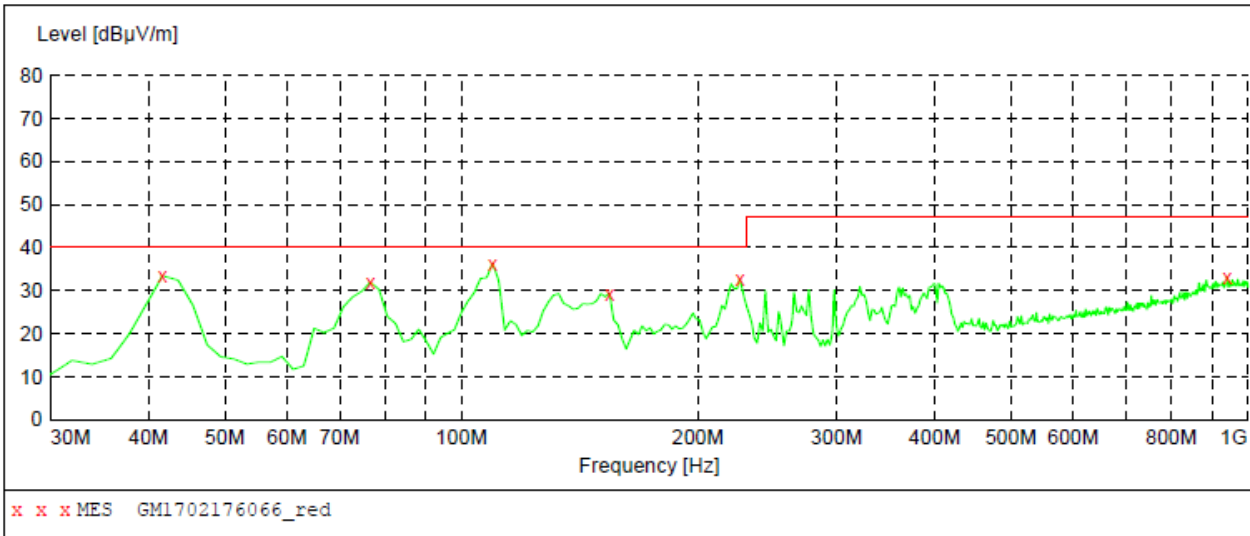

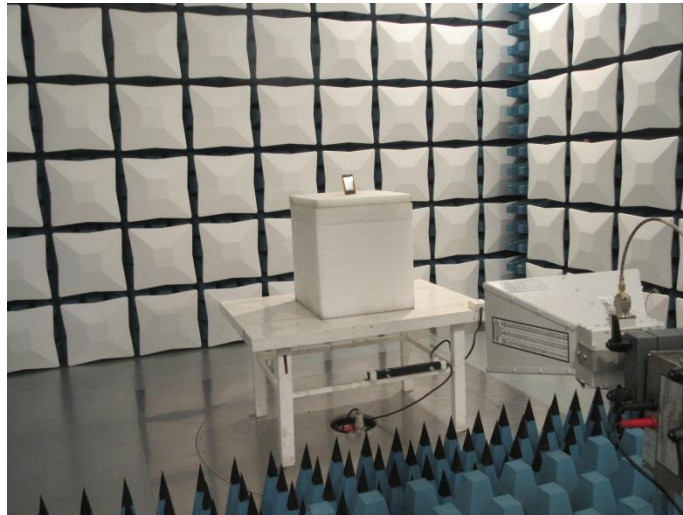
