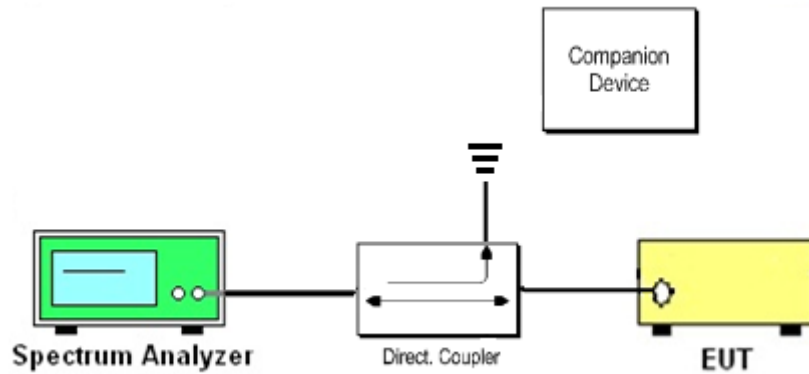

3 End User Device additional requirement

3.1 Test Requirement

FCC Part 96.47

(a) End User Devices may operate only if they can positively receive and decode an authorization signal transmitted by a CBSD, including the frequencies and power limits for their operation.

(1) An End User Device must discontinue operations, change frequencies, or change its operational power level within 10 seconds of receiving instructions from its associated CBSD.

3.2 Test Procedure

Following procedure can be done by applying WINNF-TS-0122-V1.0.2 CBRS CBSD Test Specification, use the certified Airspan NR CBSD (FCC ID: PIDAS2900) as companion device to show compliance with Part 96.47 requirement for End User Device (EUD):

1. Setup with frequency 3570-3590MHz and power level 34dBm/MHz
2. Enable CBSD service from Airspan ACP management
3. Check EUD Tx Frequency and power
4. Disable CBSD service from Airspan ACP management
 - a. Check EUD stops transmission within 10seconds.
5. Setup with frequency 3670-3690MHz and power level 24dBm/MHz
6. Enable CBSD service from Airspan ACP management
7. Check EUD Tx Frequency and power
8. Disable CBSD service from Airspan ACP management
 - a. Check EUD stops transmission within 10seconds.

3.3 Test Result

[Step 1] Setup with frequency 3570-3590MHz and power level 34dBm/MHz

[Step 3] Check EUD Tx Frequency and power

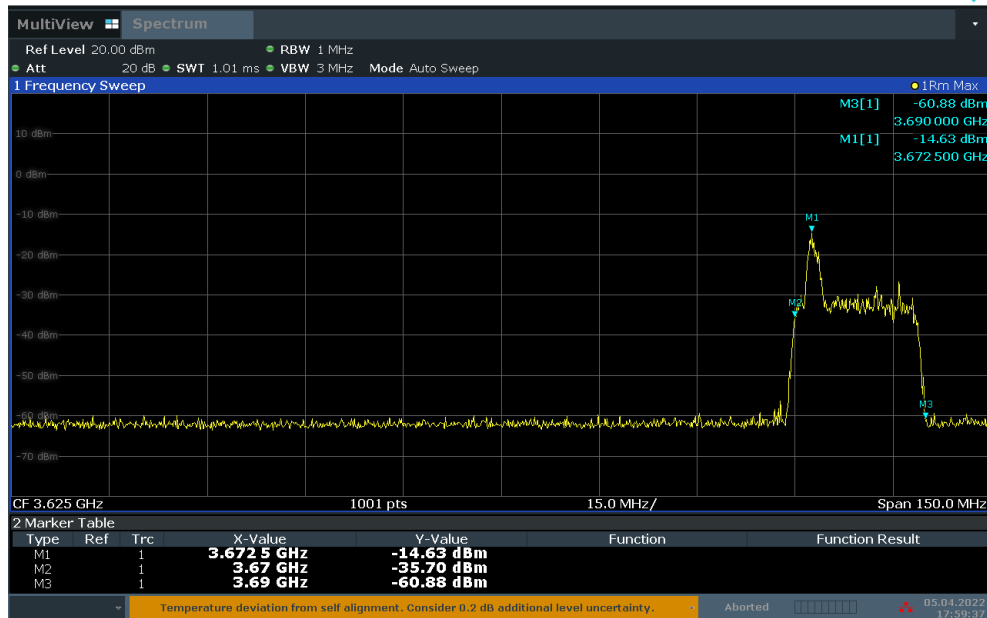
