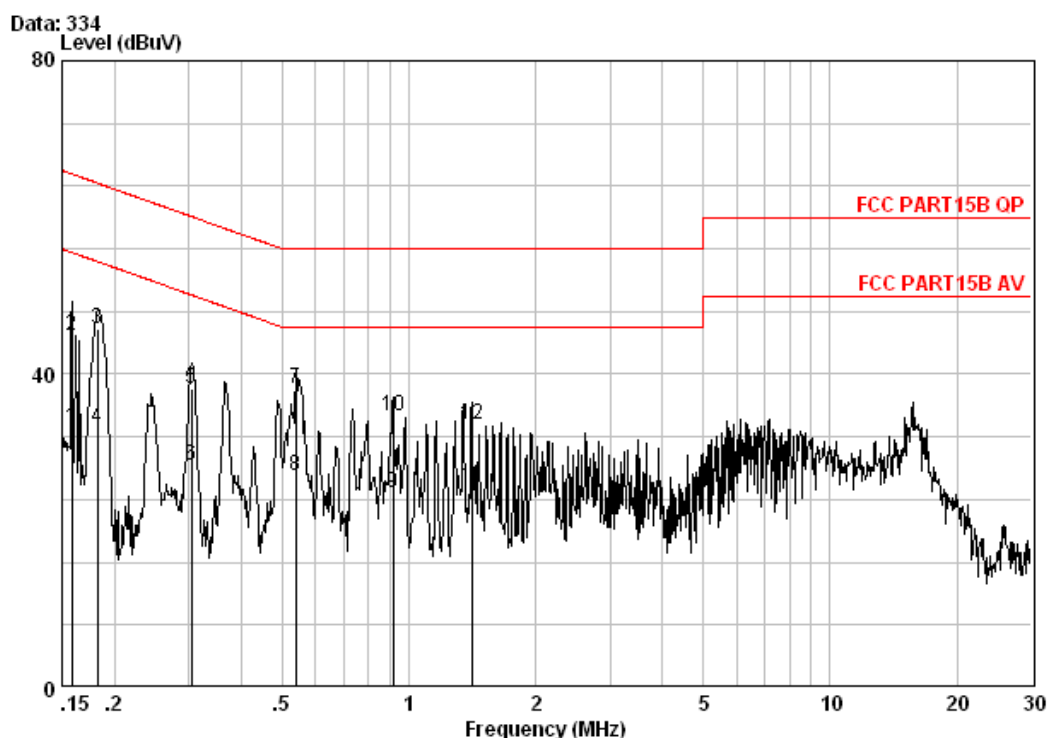

Live line:

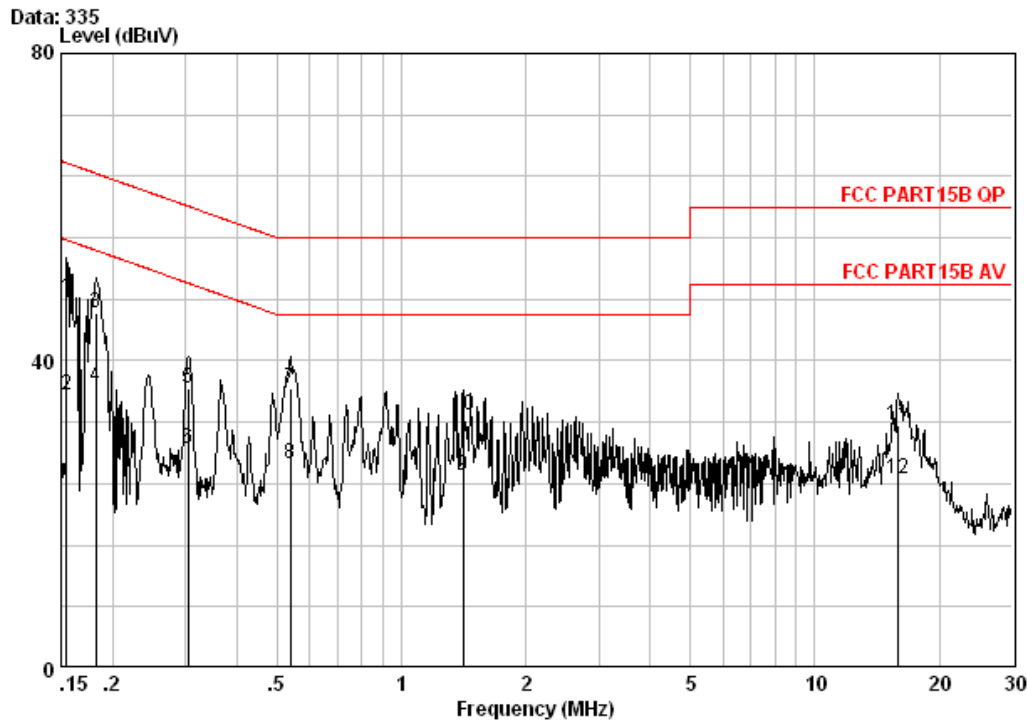
