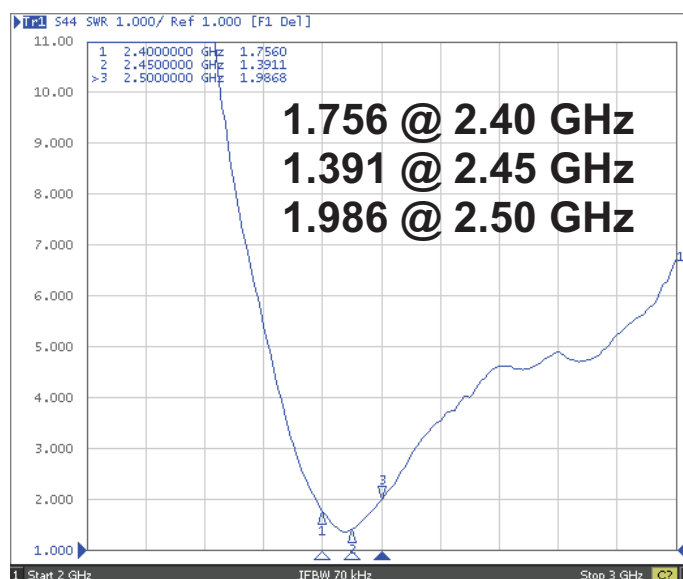
Antenna on Test Board (Thickness 0.8mm)



Antenna S11 on Test Board

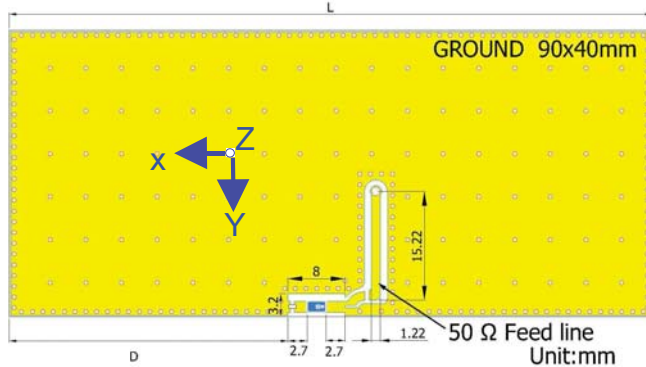


Antenna VSWR on Test Board

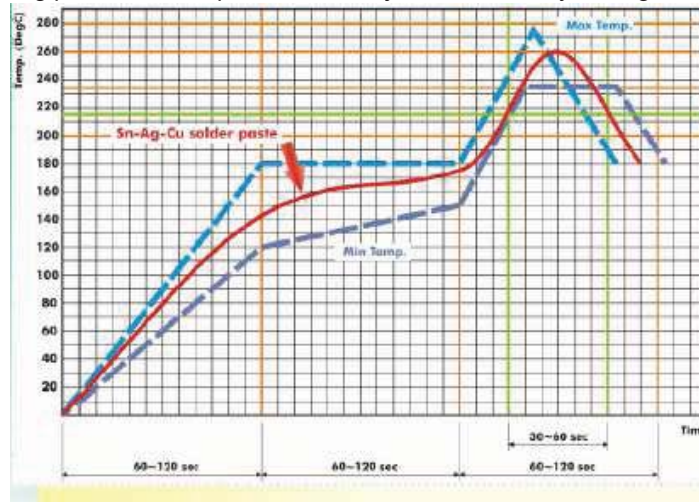


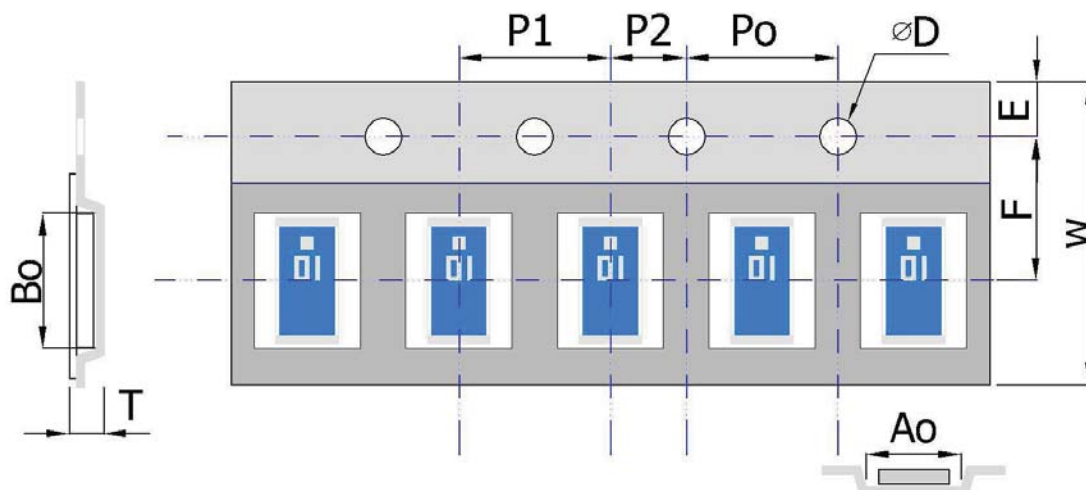
Fig 2. Infrared soldering profile

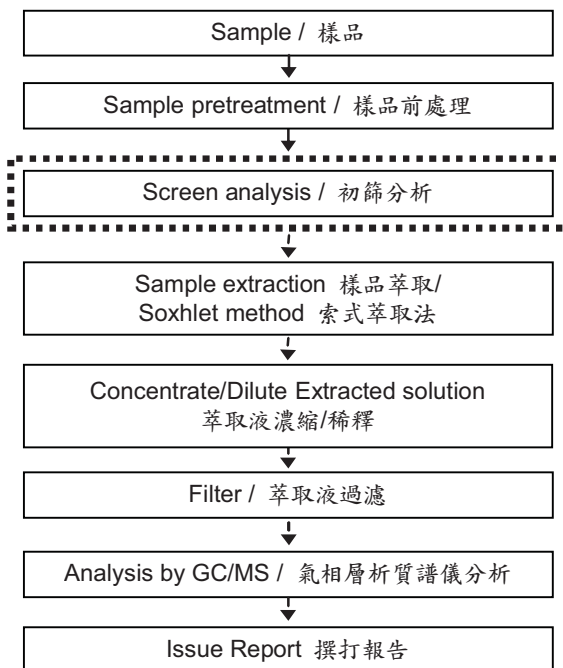

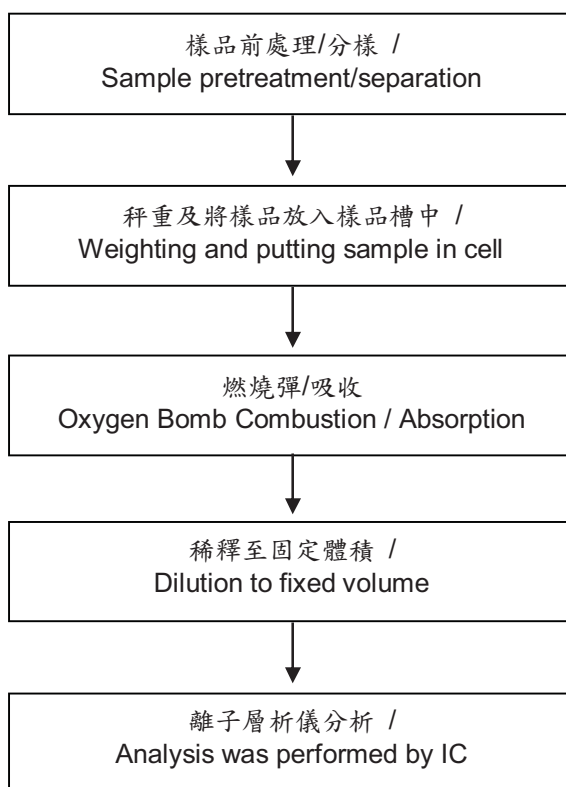

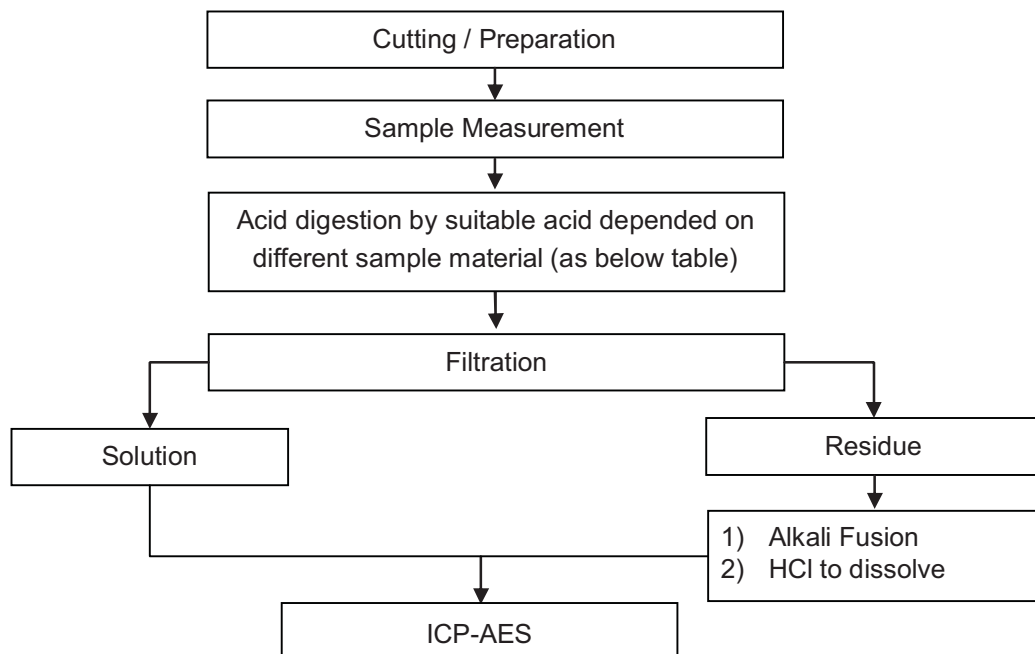

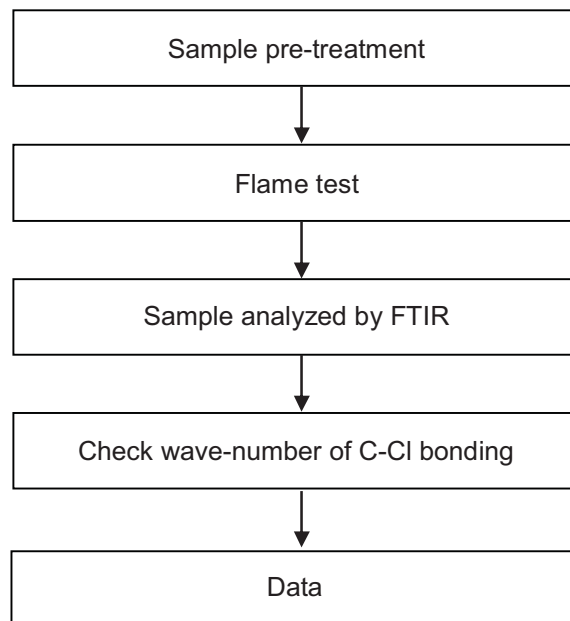

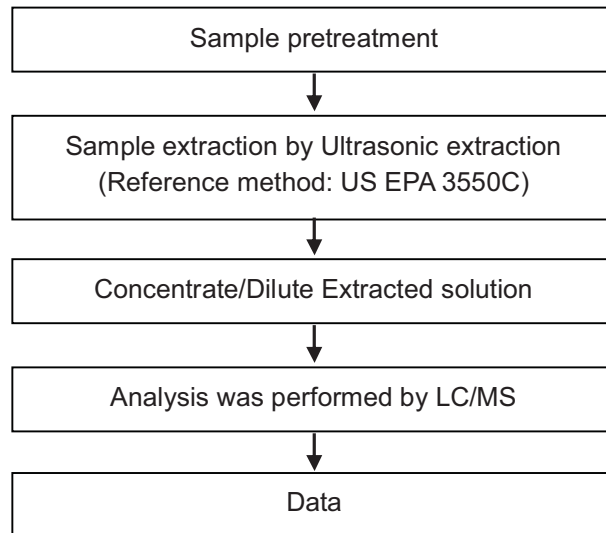

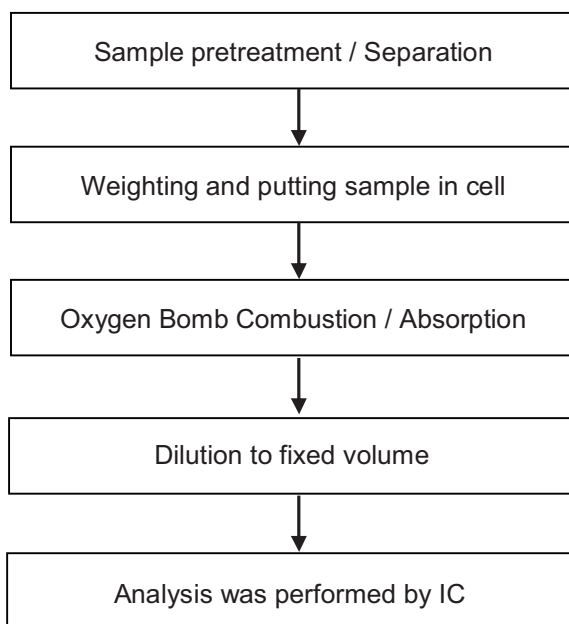

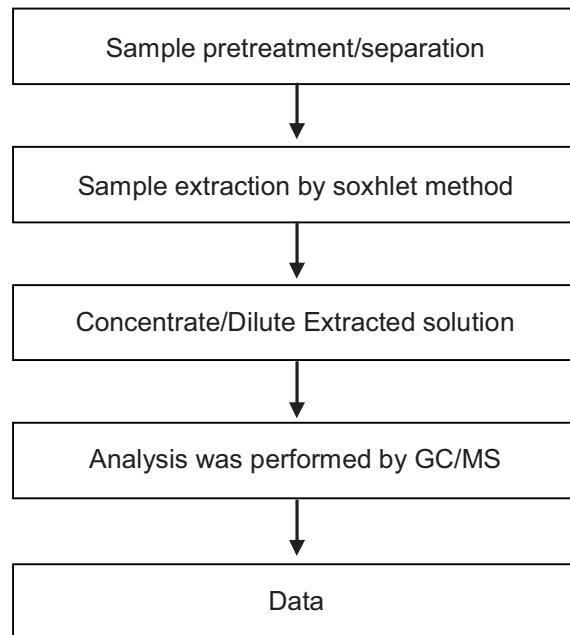

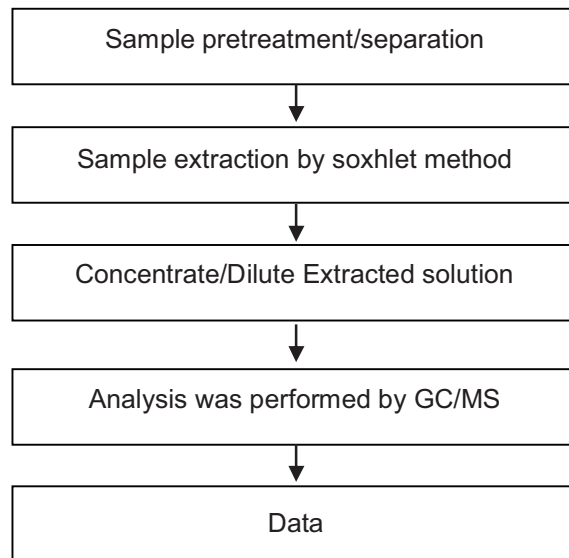

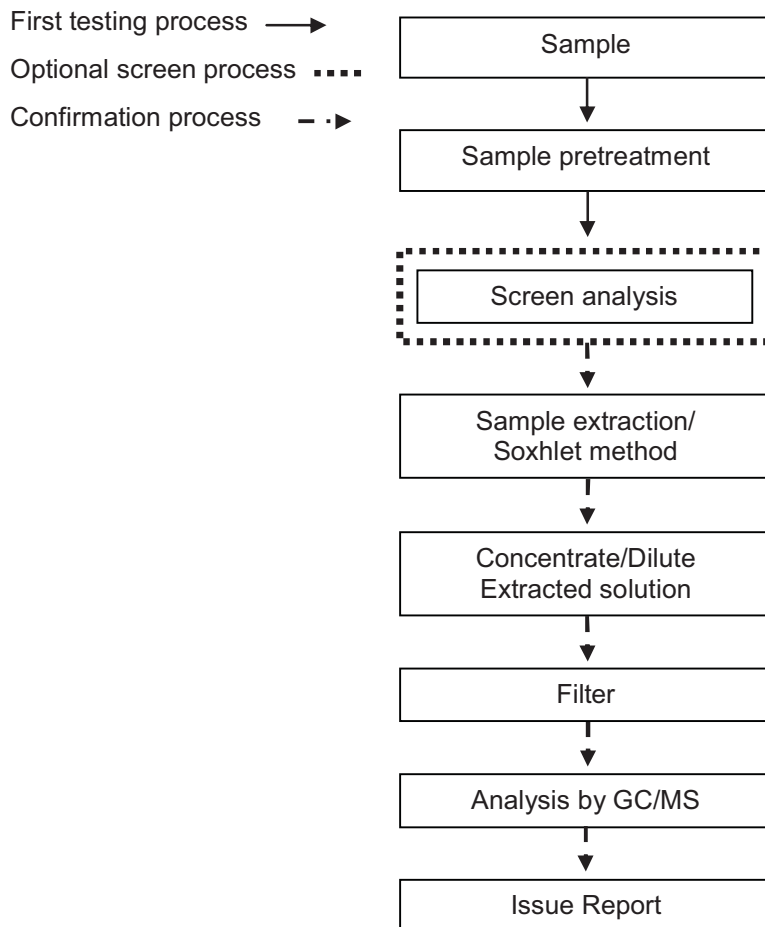

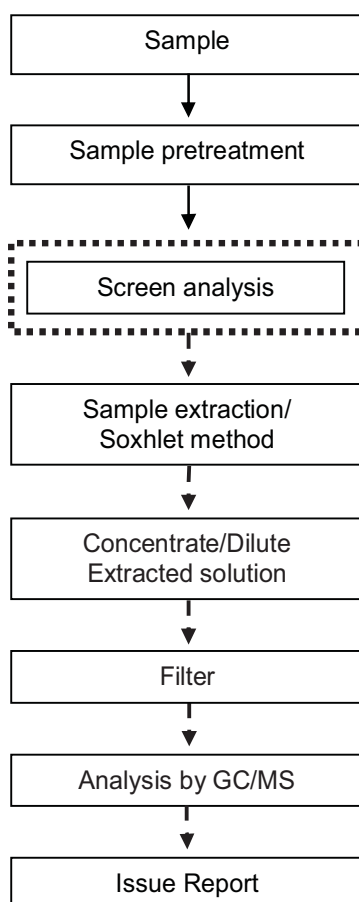

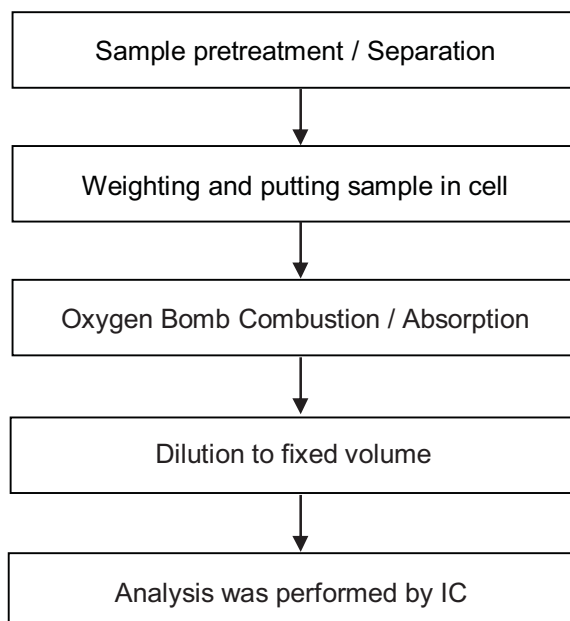

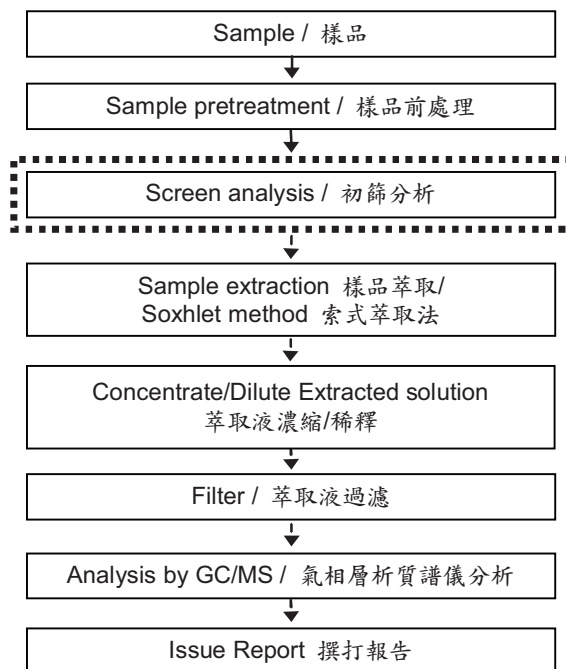

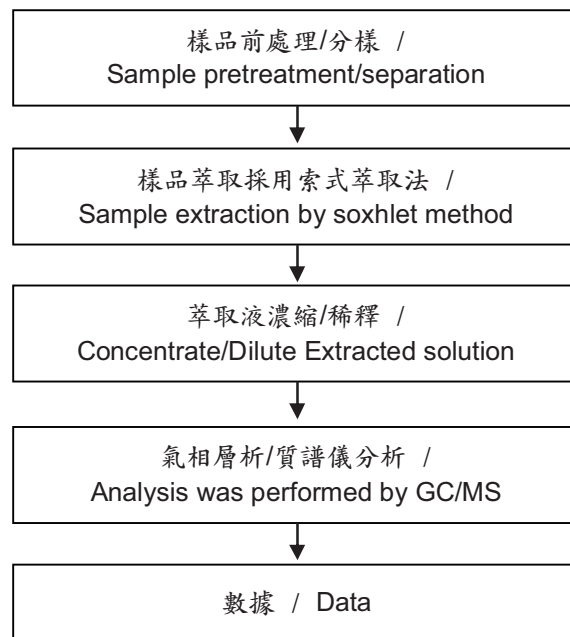

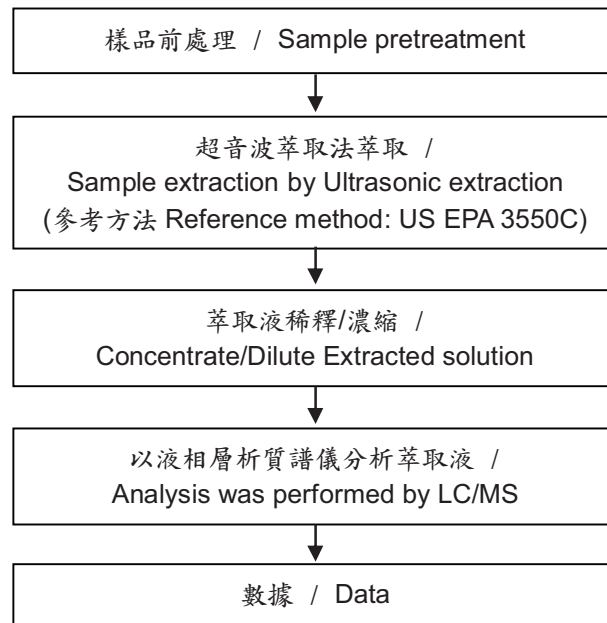

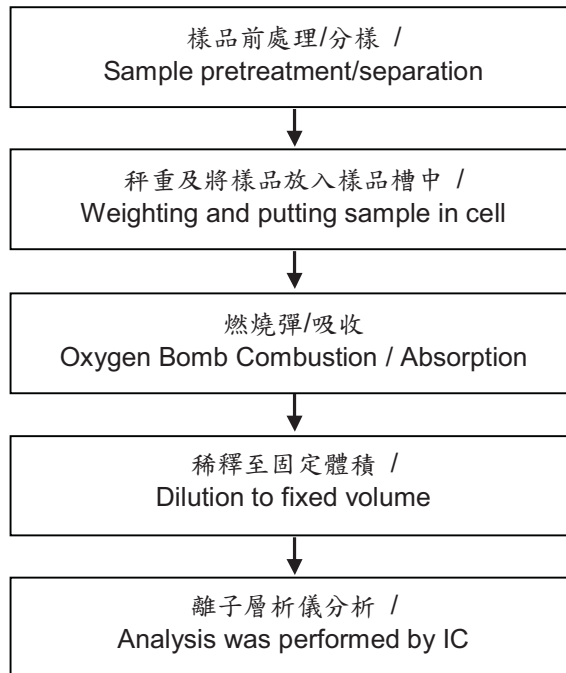

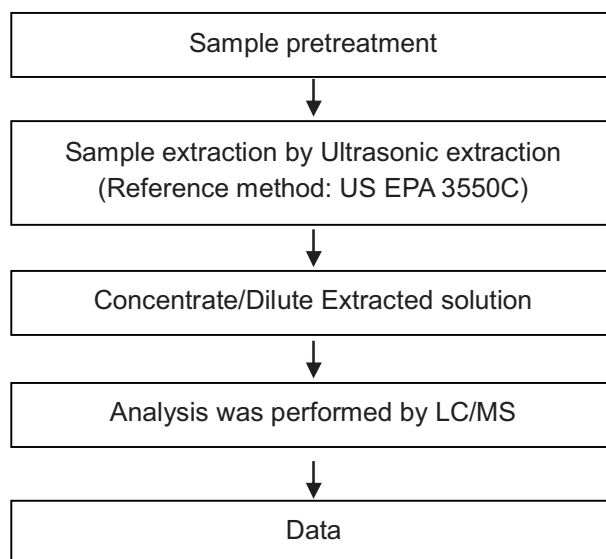

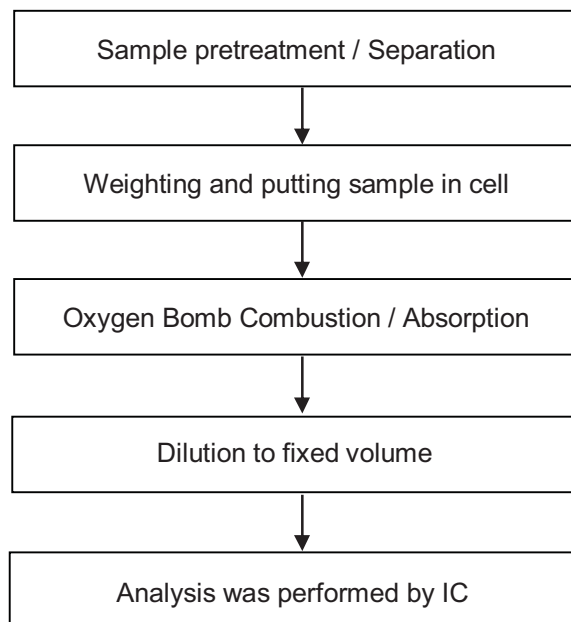

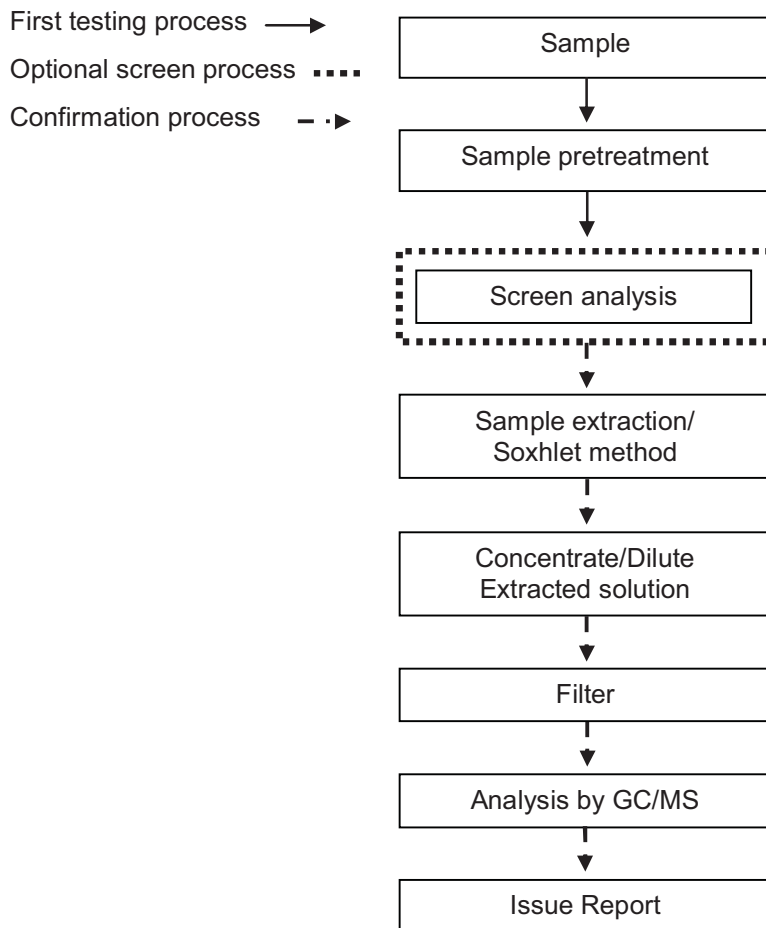

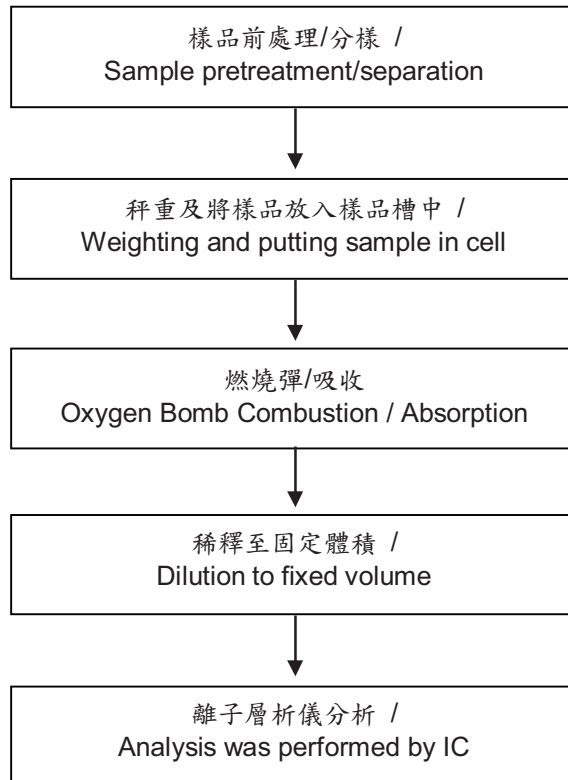

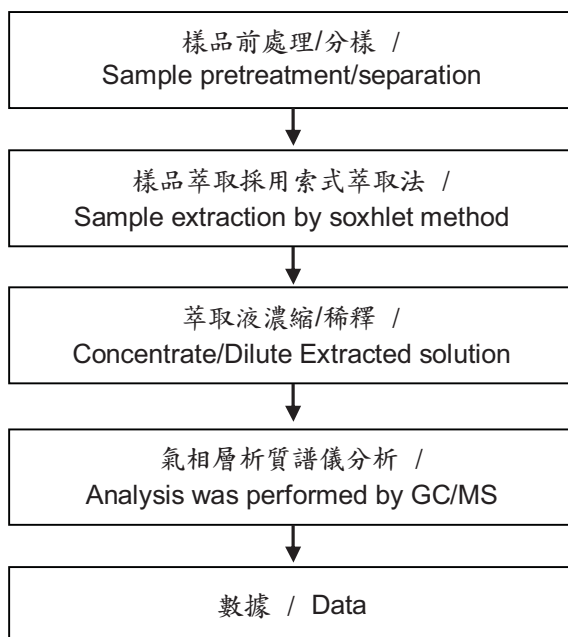

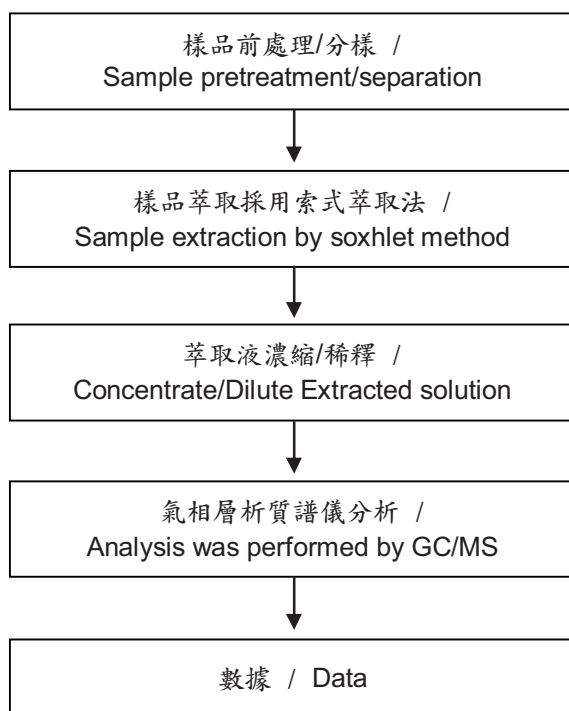

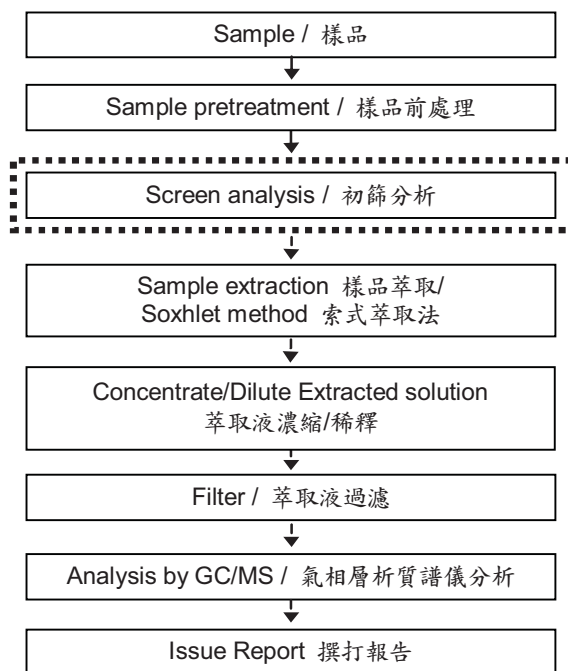
