1. Introduction

Transcend's DrivePro Body 52 is an easy-to-operate wearable video camera that is tailor-made for police officers, security guards and other professionals to capture real time videos and photos of events. The Wi-Fi network allows live streaming to your smartphone and modifying the function setting using the DrivePro Body App.

Attached with the convenient 360° rotatable clip or Velcro to your uniform/jacket, the DrivePro Body 52 features a 130° Wide Angle Lens for the best field of view and records videos in crystal clear Full HD 1080P (30 FPS) with a F1.8 aperture to ensure both the important details of your actions and those in the camera's field are clearly recorded. The handy snapshot function allows you to take photos while recording. Transcend's DrivePro Body 52 has a built-in Li-Polymer battery that can record up to 3.5 hours and only takes approximately 1.5 hours to be fully recharged.

The DrivePro Body 52 has an internal 32GB storage, allowing users to record up to 3.5 hours of footage. In addition, the camera is rugged and IPX4 water resistant, providing extra protection and durability. The DrivePro Body Toolbox provides secure encryption function to protect the recorded data. For enterprises or departments that purchase multiple DrivePro Body cameras, Transcend's optional 6-port Docking Station offers the best solution as each port can simultaneously charge and upload the recorded data to your database.

3-2 Charging the DrivePro Body 52

Before use, please ensure that the battery is fully charged. Charge the DrivePro Body 52 via the bundled USB 2.0 to 3.5mm DC power cable. A flashing orange LED light of the warning indicator is visible while charging; the orange LED light will turn off when fully charged.

To charge the DrivePro Body 52, you can either:

1. Connect the 3.5mm DC power cable to a wall outlet with the included adapter.
2. Connect the 3.5mm jack of the camera and the USB to a computer.

WARNING:

- 1. The DrivePro Body 52 only supports FAT32 file format.
- 2. Do not use the 3.5mm DC power cable on other devices.

4. Recording Videos

To start recording, long press the  button; you will hear 1 beep, and the red LED light of the recording indicator will flash during recording. To activate Wi-Fi, long press the  button while recording, and the LED light will flash from red to blue. To stop recording, long press the  button again; you will hear 1 beep. The red LED light will then turn off. One video file is saved for every 3 minutes of recording.



Note: The DrivePro Body 52 stops recording when connected to the computer or docking station.

5. Taking Photos

To take photos while recording, quickly press the  button, you will hear 1 beep.



6. Using the DrivePro Body 52 App

Developed for iOS and Android devices, the free DrivePro Body App allows you to wirelessly adjust the settings of the camera and to live-stream video on your smartphone.

6-1 Downloading and Installing the App

1. Search and download **DrivePro Body** on your App Store or Google Play.
2. Download and install the DrivePro App.

Once the installation is complete, the App will be displayed on the home screen of your device.

6-2 Connecting to the DrivePro Body App

1. Turn on the Wi-Fi by long pressing the  button while recording, the front LED will turn flashing blue. Tap the DrivePro Body App icon on your smart device.
2. Tap “Connect”. Please wait for a few seconds for the network to appear.
3. Select the “DriveProBody52” Wi-Fi link (default password is 12345678).
4. Tap the DriveProBody52 icon on the home screen of your mobile device to use the App.

Note:

1. To change the default SSID and password, go to Settings in the DrivePro App.
2. The camera stops recording when you go to Data or Settings, and will resume recording when you tap Liveview.

6-3 Playing Videos and Browsing Photos

1. Tap Data.
2. To play the videos recorded, tap VIDEO and select the desired file.
3. To browse the photos taken, tap PHOTO and select the desired file.

6-4 Settings

In the Settings menu, you can adjust the settings of video, device, Wi-Fi and System.

Menu options



Resolution: Set the resolution/quality for video recording.

Available options: **FHD / 720P**



Video Stamp: Display the time of the event being recorded and the video label.

Available options: **Disable / Enable**



Video Label: Tap to edit the video label to be displayed (default label is Transcend DPB52)



Microphone: Turn on/off the microphone during video recording.

Available options: **Disable / Enable**



Date Format: Set the date format.

Available options: **YY/MM/DD or MM/DD/YY or DD/MM/YY**



24-Hour Time: Select the 24-hour or 12-hour time format.

Available options: **Enable (24-hour) / Disable (12-Hour)**



Light Frequency: Select the appropriate frequency to avoid flashing A/C light.

Available options: **50Hz / 60Hz**



SSID: Enter the SSID to wirelessly connect to DrivePro Body 52 (default SSID is DriveProBody52).



Password: Enter the password to connect wirelessly to DrivePro Body 52 (default password is

12345678).



Version: Tap to upgrade the firmware to the latest version.

WARNING: NEVER remove the power cord or the microSD memory card while the firmware is being upgraded.



1. The DrivePro 520 will shut down and the red LED light will flash while the firmware is being upgraded. After the upgrade is complete, the DrivePro will restart automatically.
2. If the DrivePro cannot be turned on due to firmware upgrade failure, please contact Transcend customer service for technical support.

7. Using the DrivePro Body Toolbox™ Software

The DrivePro Body Toolbox, developed for Windows, features a user-friendly interface that allows you to easily back up the recorded files to your database.

2. Install DrivePro Toolbox software on your desktop or laptop.

8. Precautions

■ Do not use or store the DrivePro Body 52 in the following places to prevent malfunction or deformation:

- In extremely hot, cold or humid places such as in a car parked in the sun
- Under direct sunlight or near a heater
- Near strong magnetic fields
- In sandy or dusty places

■ Care and storage of the DrivePro Body 52 lens

- Wipe the surface of the lens clean with a soft cloth in the following cases:
 - When there are fingerprints on the lens surface
 - When the lens is exposed to salty air such as at the seaside
- Store in a well-ventilated location subject to little dirt or dust
- To prevent mold, periodically clean the lens as described above

■ Cleaning

Clean the DrivePro Body 52 surface with a soft cloth slightly moistened with water, then wipe the surface with a dry cloth. Do not use any of the following as they may damage the finish or the casing:

- Chemical products such as thinner, benzine, alcohol, disposable cloths, insect repellent, sunscreen or insecticide, etc.
- Do not touch the camera with any of the above on your hand.
- Do not leave the camera in contact with rubber or vinyl for a long time.

■ Moisture condensation

- If the DrivePro Body 52 is brought directly from a cold to a warm place (or vice versa), moisture may condense inside or outside the camera. This moisture condensation may cause malfunction of the DrivePro Body 52.
- If moisture condensation occurs, turn off the DrivePro Body 52 and wait about 1 hour for the moisture to evaporate.

9. IPX4 Water Resistant

The camera body of the DrivePro Body 52 is IPX4 water resistant (not waterproof), offering protection against splashing water from any direction. However, it is not protected against pressurized water such as from a shower or tap.



WARNING: DrivePro Body 52 is not water resistant when connected to the power cable.

Failure caused from incorrect use is not covered by the limited warranty.

- Do not use the DrivePro Body 52 in water as it is not waterproof.
- Do not use the DrivePro Body 52 in high temperature and high humidity environments (i.e. saunas, steam and shower rooms).
- Do not use the DrivePro Body 52 for a long time in heavy rains to avoid the moisture from penetrating. Make sure the power cable and adapter are completely dry before charging.

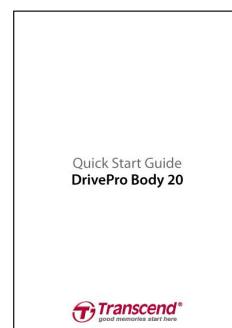

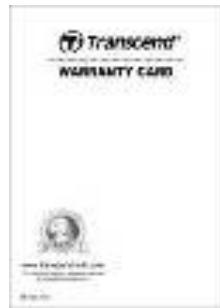

1. Is your DrivePro Body 52 properly connected to the USB port? If not, unplug and connect it

again. Make sure that both ends of the USB cables are properly connected as shown in the User's Manual.

2. Is your DrivePro Body 52 connected to the Mac keyboard? If yes, try to plug it in an available USB port on your Mac Desktop directly.
3. Is the computer's USB ports enabled? If not, refer to the user's manual of your computer (or motherboard) to enable them.

■ **None of the DrivePro Body 52 buttons are responding.**

Please press the Reset button on the bottom of the DrivePro Body 52 with a pointed object such as a paper clip.

■ **Is the DrivePro Body 52 shockproof and waterproof?**
