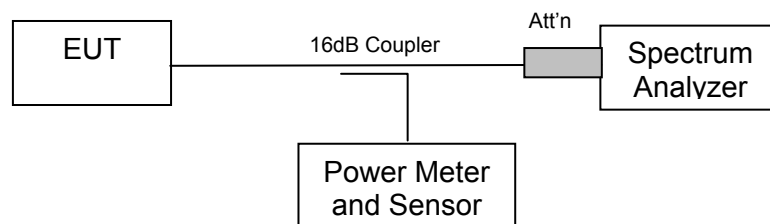

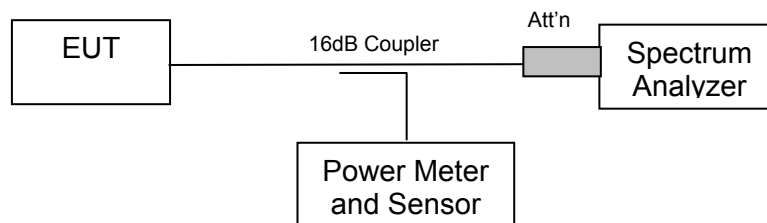

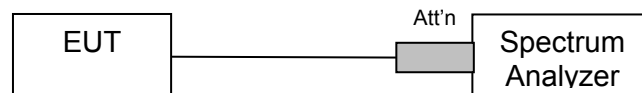

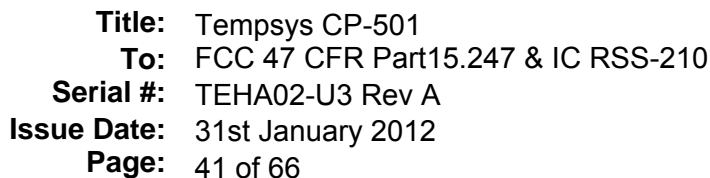
Band-edge measurement test configuration

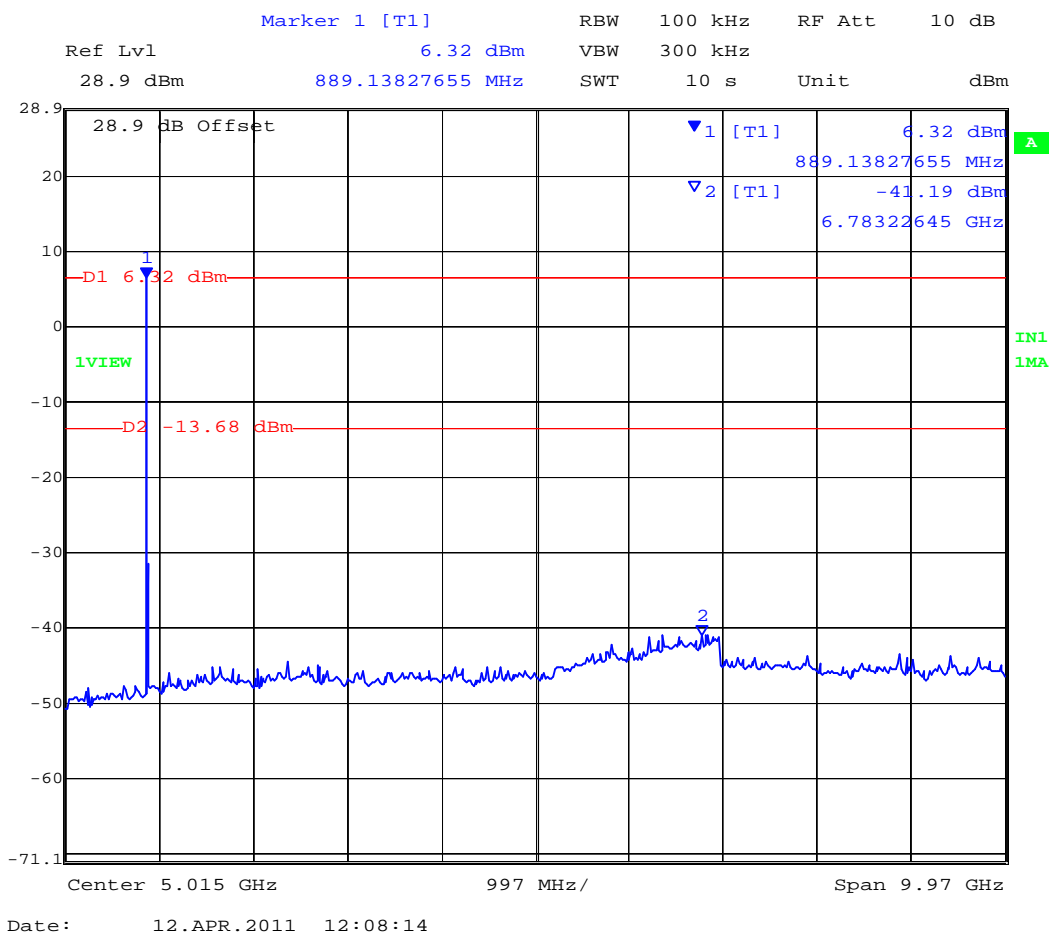

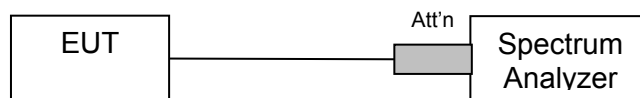

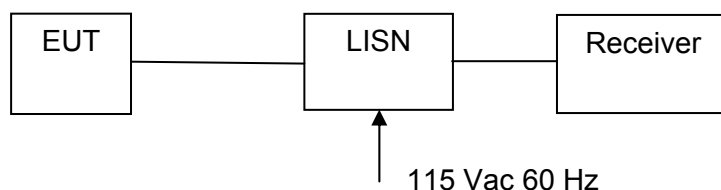

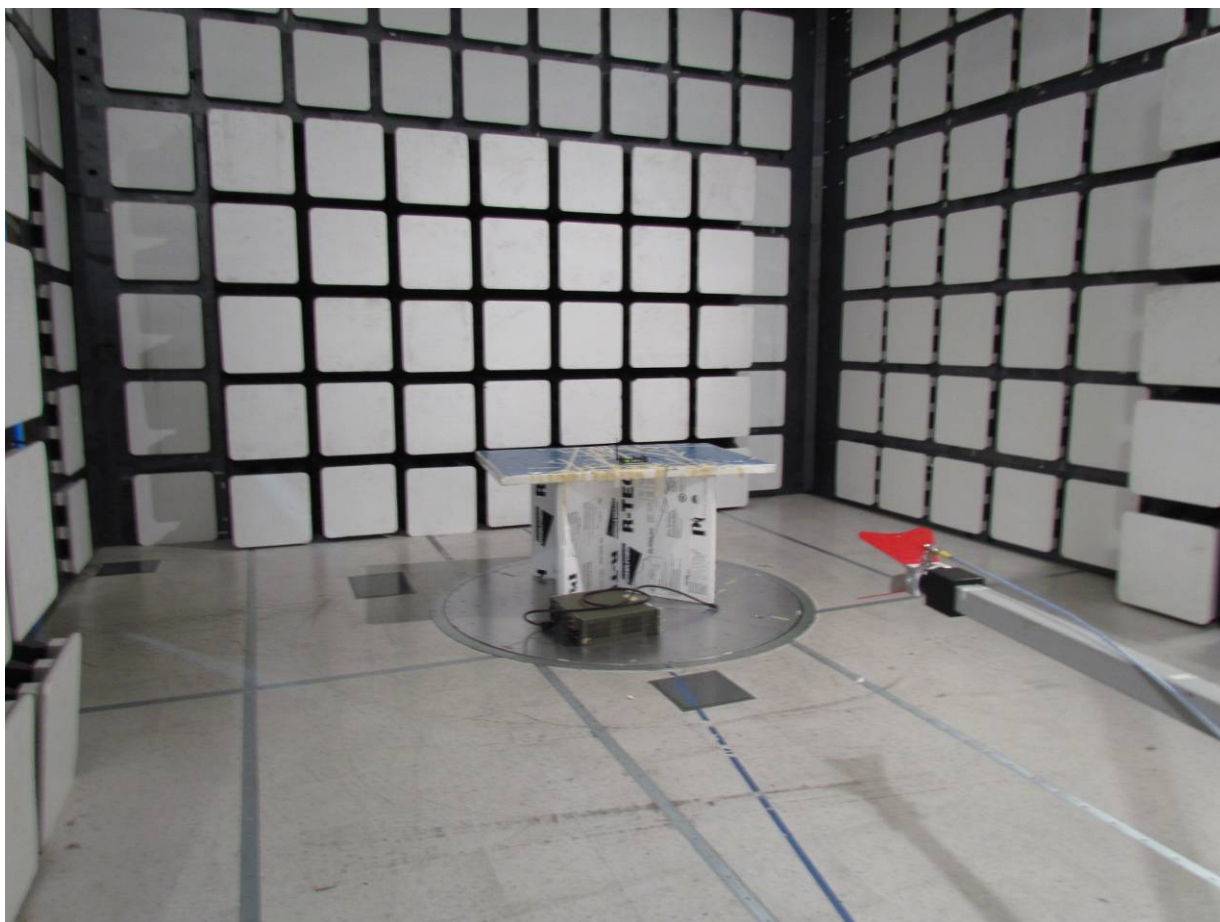
