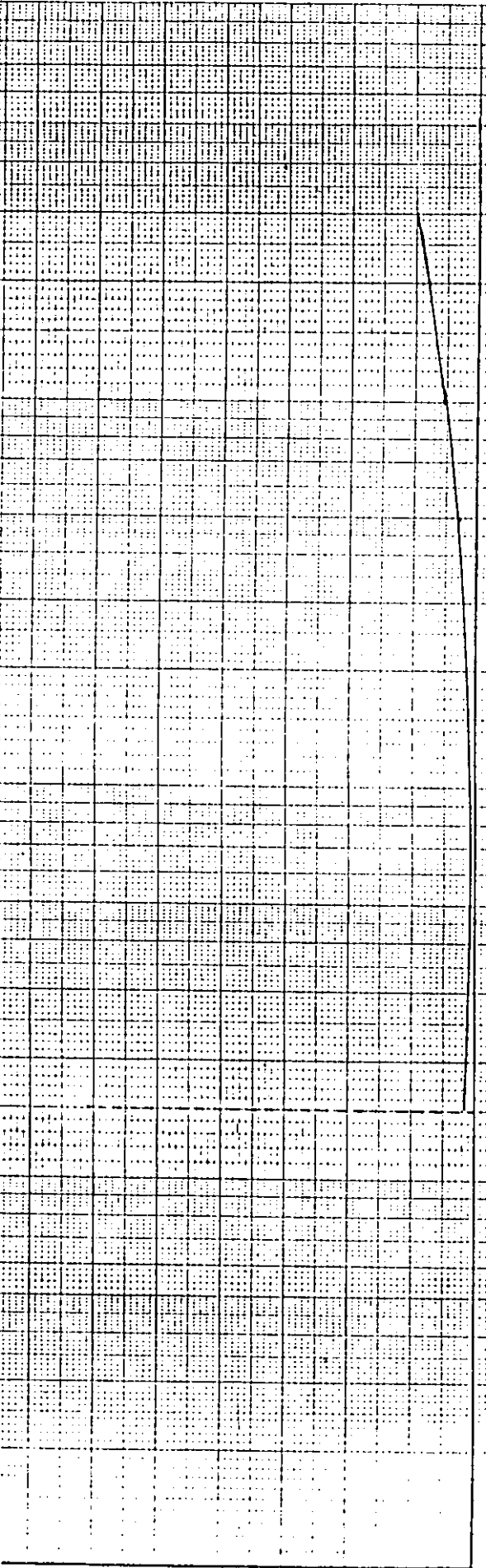

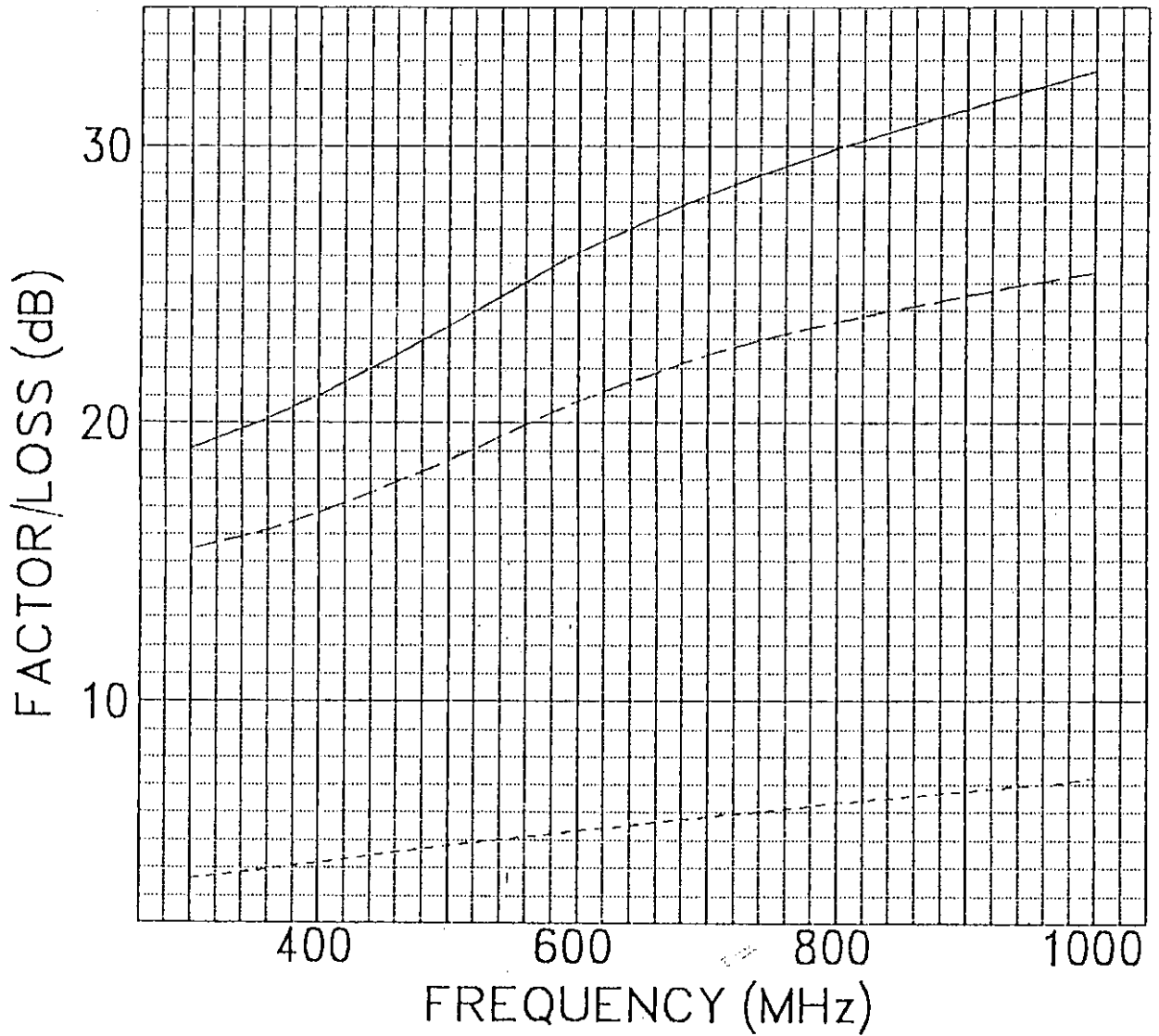

E : Field Strength

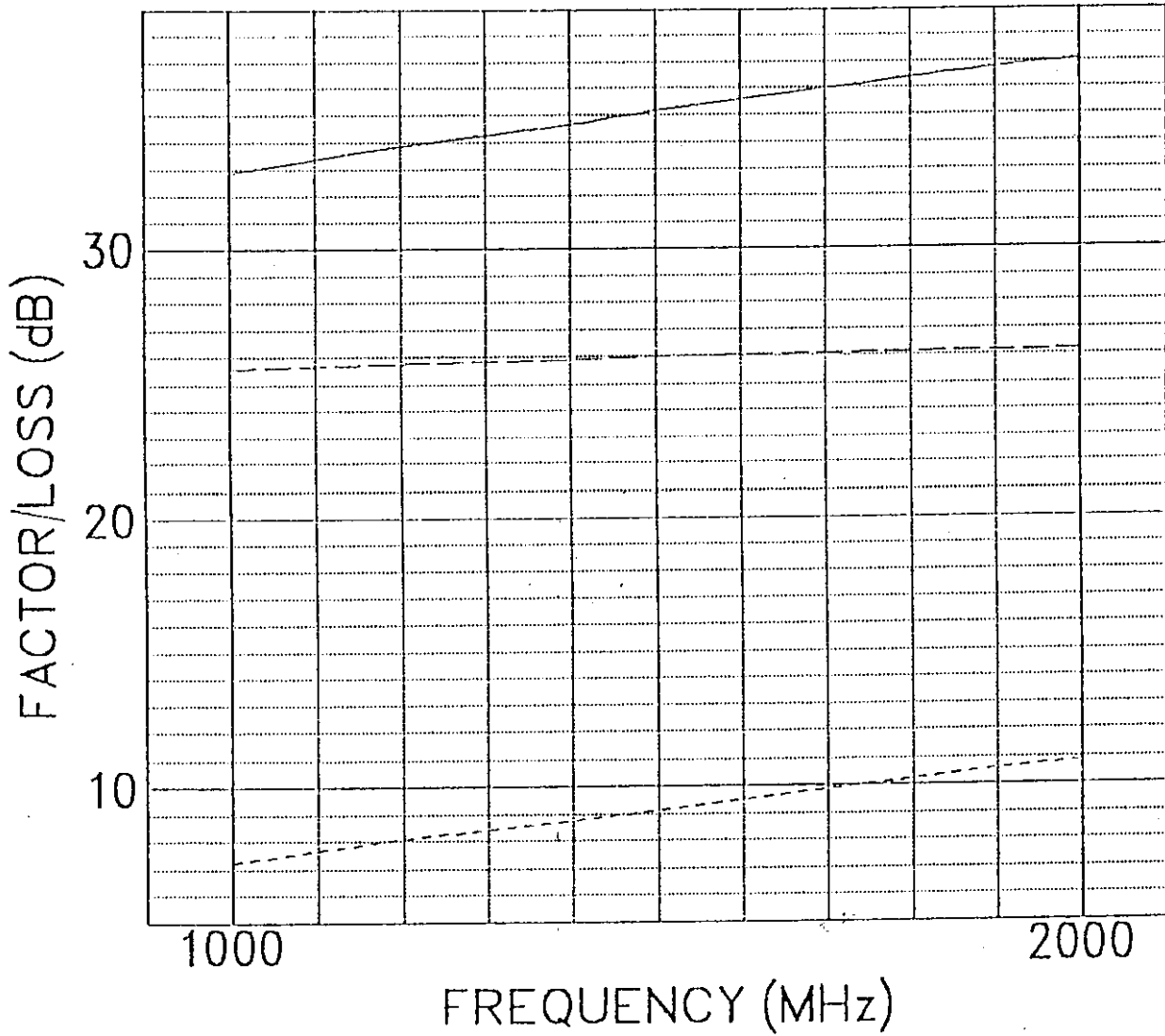
