In regards to your recent TCB application referenced above, we kindly request that you provide the following additional information.

1. The cover letter specifies 2x2 MIMO operation for the EUT, however, this is not addressed in the test reports. I note that the operational description references 3X3 and 1x2 options, but not 2x2. Please clarify. If multi-transmit-path modes are available, were they investigated?
2. Please correct the following typos in the cover letter:
 - a. Paragraph under Alps Bluetooth: should be "... equipment class code DSS..." (and not "DDS"); and, should be "...specification Ver 2.0 +

EDR..." (and not "ERD").

- b. In the paragraph under Intel WLAN: should be "... complies with FCC Parts **15C and 15E** under equipment class codes **DTS and NII**."

The items indicated above must be submitted before processing can continue on the above referenced application.
