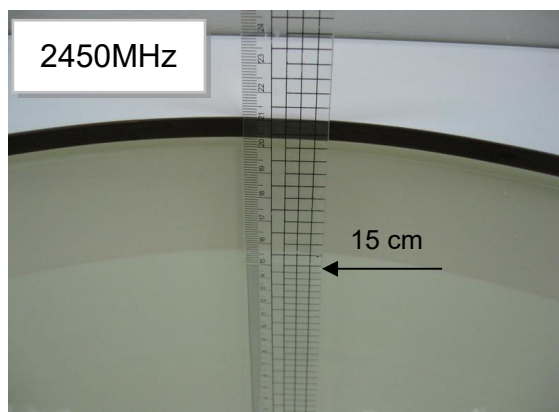

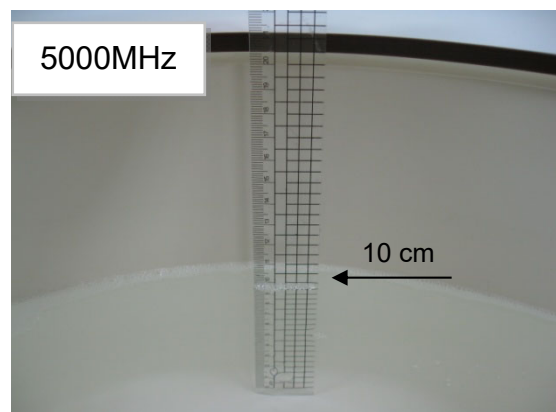

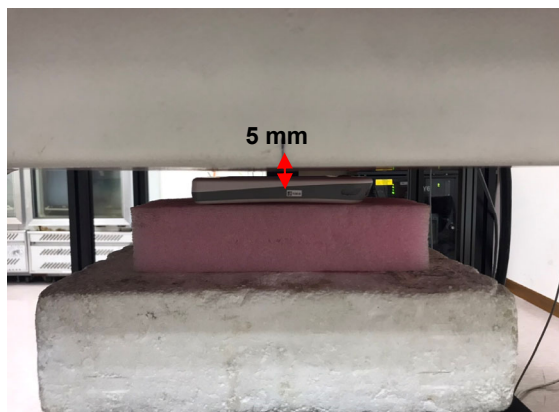

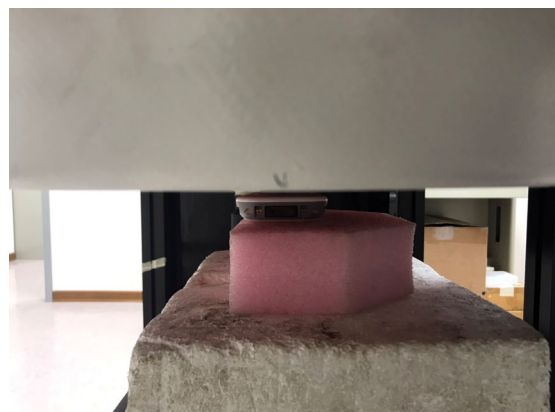

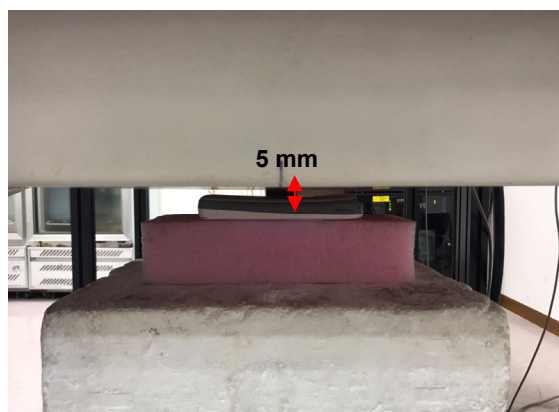
Body - distance between flat phantom and EUT is 5 mm

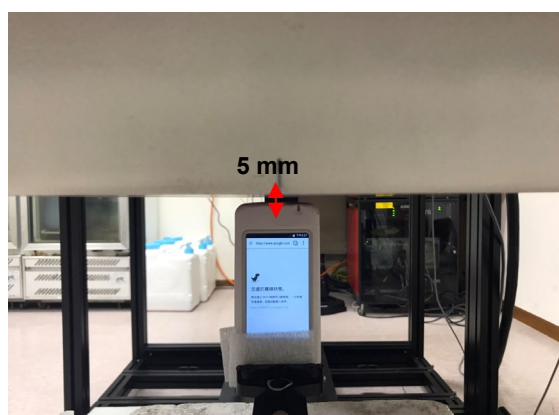
Photograph 2. Body, Front Surface, 5mm

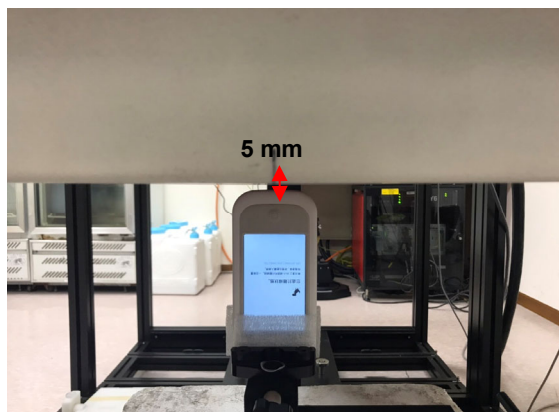


Photograph 6. Body, Top Edge, 5mm

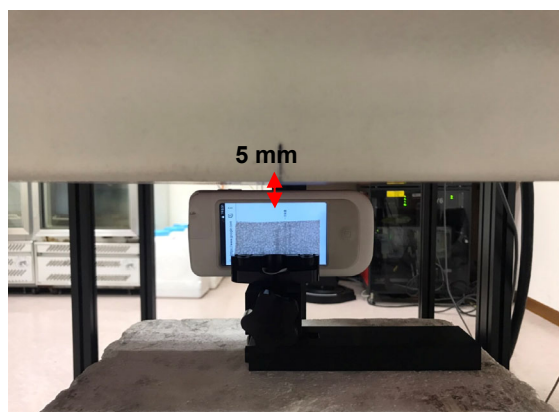

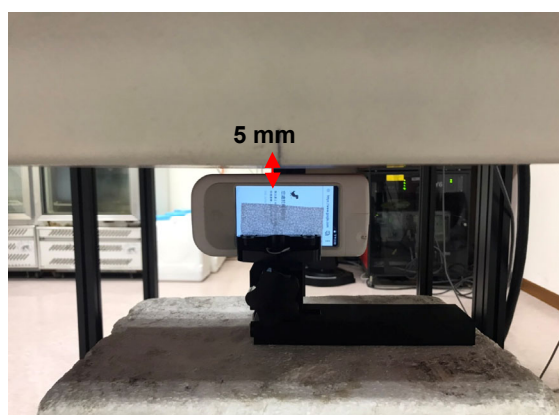

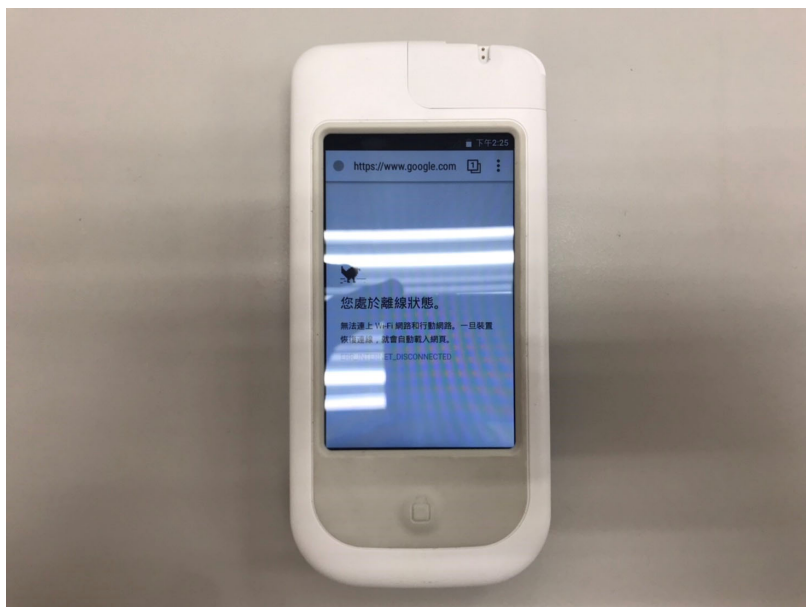


Photograph 12. Body, Left Edge, 5mm

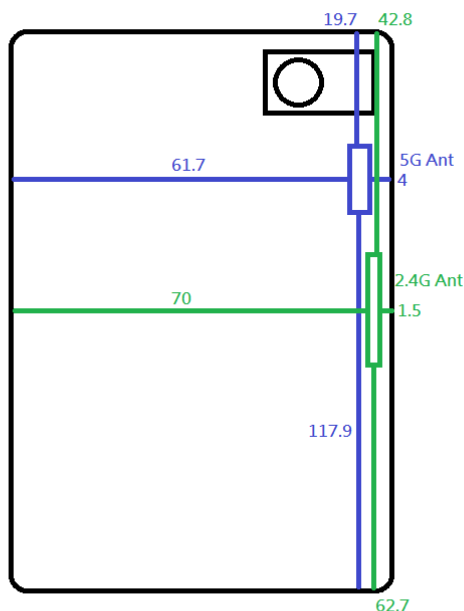
