### LIMIT

<b>Remark:</b>

DTS device is not subject to routine RF evaluation; MPE estimate is used to justify the compliance. 3. For mobile or fixed location transmitters, no SAR consideration applied. The maximum power density is 1.0 mW/cm <sup>2</sup> even if the calculation indicates that the power density would be larger. 4. All two antennas are completely uncorrelated with each other.	



## TEST RESULTS

No non-compliance noted.

### Calculation

Given  $E = \frac{\sqrt{30 \times P \times G}}{d}$  &  $S = \frac{E^2}{3770}$

Where  $E$  = Field strength in Volts / meter

$P$  = Power in Watts

$G$  = Numeric antenna gain

$d$  = Distance in meters

$S$  = Power density in milliwatts / square centimeter

Combining equations and re-arranging the terms to express the distance as a function of the remaining variables yields:

$$S = \frac{30 \times P \times G}{3770d^2}$$

Changing to units of mW and cm, using:

$P$  (mW) =  $P$  (W) / 1000 and

$d$  (cm) =  $d$ (m) / 100

Yields

$$S = \frac{30 \times (P/1000) \times G}{3770 \times (d/100)^2} = 0.0796 \times \frac{P \times G}{d^2} \quad \text{Equation 1}$$

Where  $d$  = Distance in cm

$P$  = Power in mW

$G$  = Numeric antenna gain

$S$  = Power density in mW / cm<sup>2</sup>

### Maximum Permissible Exposure

Substituting the MPE safe distance using  $d = 20$  cm into Equation 1:

Yields

$$S = 0.000199 \times P \times G$$

Where  $P$  = Power in mW

$G$  = Numeric antenna gain

$S$  = Power density in mW / cm<sup>2</sup>

Note:

Both of the WLAN 2.4G&5.0G can transmit simultaneously, the formula of calculated the MPE is:

CPD1 / LPD1 + CPD2 / LPD2 + .....etc. < 1

CPD = Calculation power density

LPD = Limit of power density

WLAN 2.4G=0.0684

(For mobile or fixed location transmitters, the maximum power density is 1.0 mW/cm<sup>2</sup> even if the calculation indicates that the power density would be larger.)
