



Electric field tests shall be performed in the frequency range of 30 MHz to 1000 MHz using a calibrated bi-log antenna and the frequency range of 1 GHz to 40 GHz using a calibrated horn antenna.

All amplitude of spurious emissions that are attenuated by more than 20 dB below the permissible value has no need to be reported.

1.1.6 Results of Radiated Emissions (30MHz~1GHz)




